#### Monday, April 15, 1996

Senator Liu rose on a point of order as follows:

"Point of order, Mr. President.

"Thank you Mr. President. I rise on a point of order because it does appear to me to be appropriate to request the presiding officer of this body to provide a ruling on a matter regarding a bill which is in possession of this body and which, according to Masons, in a more general fashion, is appropriate for such request when constitutional or statutory issues arise. The example given in Masons being a question as to say whether a bill, by law, requires three readings before passage. Similarly then, Mr. President, my question pertains to the effect of rule 51 and Article III, Section 12, of the State Constitution that provides for recall of a bill. That rule, very simply stated, is: 'Twenty days after a bill has been referred to a committee, the same may be recalled from such committee by the affirmative vote of one third of the members of the Senate.'

"But I read in the papers, Mr. President, what appears that you have taken the position, and the leadership, that the 20 days tolls upon a re-referral, an exception to what I believe is contrary to a clear and simple reading of Rule 51 and the State Constitution, that is that such recall can be made after referral to a committee, a committee, which in the case of H.B. 2366, H.D. 1, did occur back in March. Those 20 days having elapsed, Mr. President, my question, then, is whether or not Rule 51 and the State Constitution on that bill does not apply in the sense that the 20 day clock has expired or not expired. And if your ruling is that the 20 day clock begins anew on a rereferral, I would say that this essentially eviscerates the Constitutional right of recall to nothingness and should not be accepted. So I ask for a ruling from the Chair."

The Chair responded:

"Your latter assumption is correct. I have ruled that because of new findings, the Committee on Health has jurisdiction over this bill, so the matter has been rereferred to the Committee on Judiciary, jointly with the Committee on Health."

Senator Liu stated:

"Then, Mr. President, I appeal the ruling of the Chair."

Senator Anderson seconded the motion.

The Chair then said:

"It has been moved and seconded. There has been an appeal of the ruling of the Chair. At this juncture, an 'aye' vote will sustain the ruling of the Chair, a 'no' vote will not. Mr. Clerk, call the roll."

Senator Matsuura then requested a recess.

At 11:29 o'clock a.m., the Senate stood in recess subject to the call of the Chair.

The Senate reconvened at 12:04 o'clock p.m.

Senator Liu then stated:

"Mr. President, I speak in support of overturning the ruling of the Chair because I think the language in our rule, in our State Constitution and in subsequent Attorney General's Opinions are clear on what the language means. The Constitution talks about 20 days after a bill has been referred to a committee. Our rule talks about 20 days after a bill has been referred to a committee. In 1976, an Attorney General's Opinion to the then Honorables Blair and Cobb, indicated that, 'Because a recall of a bill is specifically provided for by the Constitution and is not merely a rule of the Legislature, we do not believe that the right to recall a bill from a committee can be nullified by other rules of procedure of the Legislature.'

"Mr. President, to support an interpretation such as has been made in this body today, would be to nullify, by rule and interpretation thereof, the right to recall the bill as put out by our State Constitution. It would provide to one individual, the presiding officer of this body who has the right of referral, the only individual who has the right of referral, the only officer of this house who has the right of referral of a bill, it places in that person, the power to negate this Constitutional provision as it relates to bills. This is an issue that goes beyond a single bill; this is an issue that goes to the very heart of openness and of integrity of the legislative process.

"I ask you, Mr. President, and my colleagues, to reconsider, to reconsider the ruling which has been taken here, and to please, to please think about what we want to stand for in terms of openness and democracy. I hope that we will move forward and not support the ruling on Rule 51. Thank you, Mr. President."

Senator Baker then rose to state:

"Mr. President, I rise to speak on this matter.

"Mr. President and colleagues, the issue before us is one of procedure. It is whether the President has the right, under our rules, to refer and re-refer bills and who then has a right to object to a re-referral. I refer my colleagues to Rule 45, Referral to Committee. It is the President, by our rules, who makes referrals and rereferrals. It is the committee chairs involved who have the right to make a complaint or ask for a reconsideration if they feel that they were aggrieved. I would note for all of my colleagues that neither chair in question has indicated any aggrievement.

"I would also note that an ancillary issue the minority leader attempts to raise for this floor is simply hypothetical. There is no such move on the floor. There is no proper motion. There is no proper action on which to base any other interpretation of the question before us than one of procedure. And since it is procedural and it is in keeping with Rule 45 of our Rules, I ask all of my colleagues to vote to sustain the ruling of the President.

"Thank you."

Senator Liu responded:

"Mr. President, I rise in rebuttal.

"This is more than just a procedural issue in the hypothetical. It is a proper question. We did receive a ruling from the Chair from which an appeal has been taken. We are looking at an issue of substantive importance to not only this subject matter and this Legislature, but this body. We did look and there was a lot spoken about rules and what they meant just about a week and a half ago. I'm concerned about how certain rules were being used or not used. In here, on this issue regarding a re-referral, nary a word about how that power, I believe, has been misused by this body. It was never the intent of Rule 45. It was never the intent that that rule be used to negate the right of recall of a bill.

"Again, the ruling as has been made today by the Chair, I believe, is improper and should be overturned."

Senator Anderson rose to state:

"Mr. President, I'd like to speak against the Rule of the Senate.

"I'd just like to remind my colleagues that it may be Rule 45 that you can refer a bill, but it most certainly does not mean that you can icebox a bill on Rule 51. That's what I spoke on last week, if you will remember. I said that jokingly. What the newspapers had said was that the President and the others were iceboxing a particular bill, and that's what the measure is and that's And I jokingly said, 'I know that the what it was. chairman from the Judiciary had stated numerous times that since we had heard the Senate bill on the constitutional amendment, there was no sense in hearing the House version.' I also said that I had worked with others and we had come up with an amendment to that amendment of the Constitution, and that was not heard. So that when this body received another referral to the Committee on Health, that then meant that that committee had not heard the bill and we would most certainly hear it. Some responded, if I were you I would not hold my breath.

"Now I don't think that something as serious as we are doing right now was meant to be funny. I think that the people and the community have spoken out. I think we have given everybody ample time to read the Constitution and to read the rules, because it's nothing that's just willy nilly. It wasn't done without thought and without research. And you should have been prepared because there are a lot of Senators here who I'm sure feel the same way that we do ... that they don't like to have a bill boxed into a committee and they have no way to get around that. That's not what the Constitution was for, nor do I believe that's what our Senate Rules were for.

"So, I ask my colleagues to reconsider, because once we set a precedent like this, then any president can go ahead and icebox a bill and make sure that we have no way to call it out of committee.

"Thank you very much."

The Chair then said:

"There has been an appeal on the ruling of the Chair. A 'yes' vote or an 'aye' vote will sustain the ruling ...."

Senator Anderson interjected:

"Mr. President, may I ask for a roll call vote?"

Senator Holt then inquired:

"Mr. President, it is my understanding, from the Majority Leader, that this issue before us, the vote before us is on Rule 45. Is that correct?"

The President replied:

"That is correct."

Senator Liu stated:

"Mr. President, my specific request in my asking for a ruling of the Chair was on Rule 51 and you ruled on my request regarding rule 51. I believe you can check the Journal. So I would disagree and object, and if I have to, make another appeal if the ruling is that this vote is on Rule 45."

The Chair asserted:

"It is on Rule 45."

Senator Baker then said:

"Mr. President, with regard to the items before this body, the only ruling that the President could have made is on Rule 45 because there is no motion or any other substantive or procedural item, only hypotheticals, before this body at this time. Thank you, Mr. President."

Senator Liu rose and stated:

"Mr. President, I would bring your attention to ... point of order.

"I would point you to Mason, Section 61, and I would further point to Section  $\overline{241}$ , When Point of Order May Be Raised. Section 1 of Section 241 clearly indicates from its discussion there that items that are within the control of this body are subject to points of order and questions while not only to procedure of rules, but they also relate to violation of Constitutional statutes.

"So again, Mr. President, not wanting to prolong this unnecessarily, but I will if I have to, I would ask that the question be restated so that it incorporates Rule 51."

The Chair responded:

"Your motion is out of order. We are voting on Rule 45. Mr. Clerk, call the Roll."

Senator Liu interjected:

"Mr. President .... Point of order."

The President stated:

"You are out of order, Senator Liu."

The motion was then put by the Chair and, Roll Call Vote having been requested, denied on the following showing of Ayes and Noes:

Ayes, 21. Noes, none. Excused, 4 (Aki, Anderson, Iwase, Liu).

The President then stated:

"The ruling of the Chair has been sustained."

Senator Liu rose again on a point of order and said:

"Mr. President, point of order.

"If we could not have a fair fight on the question that I did pose, then at this point, Mr. President, I do move to recall H.B. 2366, H.D. 1, from committee, based on Rule 51."

Senator Anderson seconded the motion.

The Chair denied the motion as follows:

"Your motion is out of order. There are not enough votes to sustain that motion. You are out of order."

Senator Anderson interjected:

"I ask for a roll call on that."

The Chair stated:

"You are out of order."

Senator Anderson then rose on a point of personal privilege as follows:

"I'd like to stand on a point of personal privilege.

"The other day, Mr. President, we were speaking on the OHA budget and Senator Matsuura stood up and pointed out some problems that he was having. I've been going over the OHA budget and the management audit on the Office of Hawaiian Affairs and the auditor said that we should have these not in a special fund, and I think that is fair. It also says in here that we do not derive any funds from Duty Free and others from the airport. And yet on Saturday evening, I believe it was, it said that we are going to have Mr. Owen Miyamoto retire, but we're going to hire him for another year as a consultant. Now, I don't know if that's in the budget. I don't know why after 30-something years we do not have somebody to take over that.

"But I think that OHA deserves to have us look at their budget; where we're getting their funds. We also don't have any funds coming from Sand Island and other areas. So if I were my colleagues, I would question this very, very diligently to find out why Hawaiians have to pay for the problems that we're having today when they offered, offered to sit down with the administration and work out any problems that we're having with the economy. They were willing to do their share.

"So for that reason, I'd like to bring it to your attention to not only read the audit of Hawaiian Affairs but also read the Office of Hawaiian Affairs' questions and answers responsive to legislative briefing because I think it's very informative and it's one that would answer some of the questions on why we should not take away 80 percent of their funding. And I sure as hell don't expect someone to sit down and say look at this; now we're only going to take 30 percent away from them; because I think that too is irresponsible.

"Thank you very much for listening."

At 12:20 o'clock p.m., the Senate stood in recess subject to the call of the Chair.

The Senate reconvened at 12:21 o'clock p.m.

Senator Matsuura also rose on a point of personal privilege and stated:

"Mr. President, I would like to speak on a point of personal privilege.

"Mr. President, I have been here for 16 years now, and what has just transpired this morning gives me great concern. I can understand why the minority leader walked out. He had no reason to walk out but we gave him the reason to walk out. As a Democrat, as the controlling body here, I think that what he was requesting was very fair. And I, for one, had a very hard time voting on these issues, Mr. President. He was asking for a ruling on Rule 51. They know it, you know it and I know it. He wanted to know whether or not that 20 days started all over again after the second referral. That was the question. We gave him the ammunition to attack all of us. We look like hell to the public out there. The public is not going to understand what's happening over here.

"If Senate Rule 51 was the issue, we vote on Rule 51. What's wrong with that? Up or down. We all have our reasons why we vote one way or the other. There's nothing wrong in voting for a constitutional amendment or voting against the constitutional amendment -- believe me. Everybody has a vote and they vote on their conscience. However, what we just did .... I wish the newspapers and the television don't come to interview me because I don't want to answer any questions about what just happened. I'm just going to tell the truth ... I cannot lie. What the Minority Leader is asking for is very proper. Let him make the request again. Let him make the proper motion. We vote up or down -- it doesn't matter.

"Mr. President, I don't expect you to be Mr. Perfect. You are going to make mistakes in making decisions like that because you have to think on your feet at the podium. If the decision was wrong, whether you counted the 20 days after the second referral, that's all right. The public will understand that. Nobody's perfect. However, I think that the Republicans are now upset. They are going to come back tomorrow and the public will be on their side because the public understands what they're trying to do. We're digging our grave deeper and deeper, it's time that we stopped, and it's time to be fair. I think it is time that we vote our conscience -- one way or the other. That's why we were elected and put over here.

"Thank you, Mr. President."
