Senator Tam rose on a point of personal privilege as follows:

"Mr. President, good morning. I stand for the purpose of personal privilege.

"In reference to the April 4, 1996 Star-Bulletin article questioning your committee's environmental protection legislation on air quality control at Campbell Industrial Park through H.B. No. 388, I have a letter from Dr. Bruce Anderson, Deputy Director for Environmental Health, clarifying his views.

'Dear Senator Tam:

I want to take this opportunity to clear up any ambiguity which may exist as a result of my comments in a recent newspaper article regarding the imposition of Best Available Control Technology requirements to all facilities at the Campbell Industrial Park.

Let me state at the outset that as advocates for the environment, the Department of Health certainly supports and applauds the efforts you have undertaken to address the issues of air quality and public health in the region surrounding Campbell Industrial Park. We have been increasingly concerned that residential development in this area will lead to further conflicts in land use between the existing industrial facilities and the influx of new residents. Additionally, in light of some recent episodes which occurred at the Park, the Department is undertaking an effort to identify services of pollutants which are causing nearby residents to experience discomfort or illness.

The Department feels that its ongoing studies and monitoring of the air quality in the area are very much in line with the intent expressed in your legislation and that was the thrust of my remarks in the newspaper. I think we all agree that it is essential that we comprehensively study and analyze the air quality data for this region so that we may ensure that appropriate steps are taken to protect the health of the adjacent residents.

Please be assured that the Department of Health appreciates your leadership and commitment in this area to taking effective, appropriate action and look forward to working with you so that we may finalize a bill this session which will insure that the health and welfare of the community are well protected.'

"I wish to also inform everyone that I met with Chevron U.S.A.'s new regional manager for the State of Hawaii. Chevron declares that it wants to be a part of Hawaii and they plan to remain in Hawaii, and Chevron has agreed to pay all emergency hospital bills due to its release of excessive air emission without any of conditions it imposed upon claimants previously. Thank you."
