RE-REFERRAL OF HOUSE CONCURRENT RESOLUTION

Senator Kanno, chairman of the Committee on Agriculture, Labor, and Employment, requested a waiver of the required hours of Notice of a Public Hearing on H.C.R. No. 42, and the Chair granted the waiver.

Senator Anderson rose on a point of personal privilege as follows:

"Mr. President, I rise on a point of personal privilege.

"Mr. President, yesterday we had a bill that everybody is saying, 'I wish this thing would go away and never come back. We have to move on.' But it was a bill pertaining to licensing or statutory rules, and in this morning's paper it said that that particular same-sex is still alive.

"What bothers me is that I had once said on this floor that because of the news media, I could probably call somebody an SOB and it would never be written up. And that's factual because I had a fax like everybody else and I called this person but they had a recorder on so I left a message and she called me back. She said, 'I'd like to

know exactly where you stand, Senator Anderson, because I understand that you're for this particular bill.' And I said, 'No, I'm not.' And she said, 'We were just down at the ball park for Senator Norman Mizuguchi and Senator Graulty and said the constitutional amendment bill is dead and that's where you want it to be.' And I said, 'That's not factual. It's not true. This is where the bill lies and this is what's happening.'

"And I think what happens is the news media plays up whatever they want to, so everybody thinks that the constitutional amendment is dead. Everybody thinks that same-sex marriage is going through. And we're losing sight of economic benefits. We're losing sight of how the administration and others are raising ... raising, every dollar that they can through administration rules and other means. This is one of the worst, I would say, times that the news media is playing games and we're all being blamed. And I sure as hell don't like it.

"People out there are saying in a four-letter word, but they could use worse, that we're full of it. That's why we have brown eyes and I said I want you to know that some of us have blue. And they said you guys are about a quart shy. And I think that's the worst thing that could ever happen to us -- that the community, in general, has lost faith in their Legislators. And they've lost faith in government. They have lost faith in the judicial system. And for that reason, I wanted to stand on this floor today to let everybody know that everything that we have is still alive -- alive, kicking, and it can move, let me tell you. So anybody up in the gallery, any one of you from the news media, do your job; make sure that if you're going to quote, quote us properly. If you're going to draw cartoons, I would hope that you draw them for the right reason, not for anybody being out there for themselves because they are doing it for a reason, but for the good of the people.

"And I want everybody to also know that my chairman from Judiciary ... I have never once said that that gentleman has not been open and has not given us, any of us, a chance to say what we want in committee. I think he has been one of the most open chairmen.

"I have fought in conference committees for what I believe is there. It doesn't mean it's going to pass. As a minority, as I once told the majority leader, I understand we have two votes, but there's other votes out there—important votes. And we're going to have to execute those votes because the process and this institution have been circumvented, the worst that I have ever seen. I've been here a few years. I'm not that old, but I've been here a few years.

"Thank you very much for listening."

Senator Graulty also rose on a point of personal privilege and said:

"Mr. President, may I rise on a point of personal privilege?

"Mr. President, I just wanted to thank the previous speaker for his kind words. I've tried to be as open as I could possibly be to all the members of the committee whether they be majority or minority members. And I think our deliberations have been fair and open, and I just wanted to thank the Senator for his kind words."

Senator Matsuura rose on a point of personal privilege as follows:

"Mr. President, I just want to stand on a point of personal privilege.

"We have a tendency to focus primarily on this samesex marriage issue, but today, there was an amendment that we tried to put in a bill which was killed. We, as legislators, will have to use our common sense. I'm going to give the background of this specific amendment that we tried to insert in conference.

"All of you know the drug commonly known as ice is totally out of control. And in one of the Judiciary hearings a few weeks ago, the subject of controlling ice and the effect that it has on the public was brought out. And one of the questions that I asked was, why is it that ... who's bringing them in? And the comment that the person made was that ice is made in Hawaii. They bring in the ingredients to Hawaii. He mentioned that there were three basic ingredients: ephedrine, acetone, and iodine. Iodine and acetone -- one can pick them up over the counter -- you can't control it, but the ephedrine you The way to do it is to put it into the category of controlled substance. Today, they're bringing ephedrine in through mail order. With these ingredients, one can make ice in a kitchen.

"It is common sense, logical, that we stop the importation of ephedrine. We would all be in favor of that. However, that was not so. The House argument was that the House didn't have a hearing on it.

"We can't wait till next year as the House says we should. How many people are going to get hurt within that one year that we're going to wait. I say let's stop the importation now! I also mentioned about DUI in terms of people on drugs driving. There is a simple urine test that should be incorporate in our laws now. There's a lot of people who are on drugs driving. We should have passed the implied consent law for drug testing this session. It has been held up in the Senate Transportation Committee for two years now. It is wrong!

"These are what I consider as common sense bills. It makes common sense to pass these kinds of legislation. I'm venting my frustration because some day I'm going to write this common sense law. Until then we have to try to pass some of these bills that really make common sense.

"Thank you."

Senator Liu rose on a point of inquiry as follows:

"Will the chairman of the Judiciary Committee be willing to yield to three questions?"

The Chair posed the question and Senator Graulty having answered in the affirmative, Senator Liu continued:

"I would like to ask the chairman whether or not in submitting the Senate's position on H.B. No. 3347 yesterday, whether or not he included the exact language which was contained in H.B. No. 2524, S.D. 1."

Senator Graulty answered: "The answer is no, Mr. President."

Senator Liu continued to inquire:

"Thank you. I'd also like to ask whether or not he believes the House proposed C.D. 1 to H.B. 3347 is worth meeting over again in his jurisdiction."

Senator Graulty then said:

"Would you repeat the question, I didn't get it."

Senator Liu continued:

"Whether or not in reviewing now the House proposed C.D. 1 to H.B. 3347, whether or not you can inform us as to your sense as to your desire to meet again on that bill."

Senator Graulty answered:

"The House has taken the position as reported in this morning's paper that they will not return to the table unless the Senate is willing to seriously discuss the proposed constitutional amendment. As also indicated in the papers, I am seeking the assistance of the Senate Majority Attorney on the constitutionality of the proposal that the House has given us. And after I get the reading from the Majority Attorney, I hope to share it with the members of my Conference Committee and formulate a position to go back into conference with, if that be the desire of the Conference Committee members."

Senator Liu further inquired:

"Thank you. And my last question, Mr. Chairman, is whether or not you intend, at this point in time, to hold any kind of decision-making on H.B. 2366, H.D. 1, in time for final reading?"

Senator Graulty responded:

"The position of the Judiciary Committee has been, H.B. 2366 does not have the necessary support from the committee to pass on to the floor of the Senate. That is the position that we took on decking deadline and our position remains the same."

Senator Liu then rose on a point of personal privilege as follows:

"Mr. President, I rise to speak on a point of personal privilege.

"Mr. President, I would like to relay to you that I'm now being contacted by various news media across the country, radio stations mainly, on this issue regarding same-sex marriage and what is happening here in the Hawaii State Senate. I've declined most of those invitations. The last one I did accept was in the State of Alaska, mainly because the invitation came by way of a personal friend who really urged me to take part.

"I'd rather not be on the airwaves in other states or even this state on this issue because I would wish that we have the chance this summer, this fall, to have whatever stories that are written on Hawaii talk about how we are improving as a place to invest money in, how we are a wonderful place to take a vacation to, how a change in our business climate is occurring. But I can guarantee you, Mr. President, that with the information provided here today on this floor regarding this issue, and with the uncertainty and the time clock running as to what will happen, that we are guaranteeing ourselves that the result will be that Hawaii will, yes, be in the headlines this summer across the country but we will be associated with the issue of same-sex marriage. I can guarantee you that if we proceed along the course upon which it appears that we are, on this issue, and that there could be no action, then this will be a cutting edge issue for the campaigns, not only in Hawaii, but for Congress and the Presidency.

"So I would ask you, Mr. President, that as we wind down, that as you have on other issues this session, for instance workers' comp, that you exercise leadership that will provide us with a chance to come with a clean decision on this issue.

"Thank you, Mr. President."
