#### RECONSIDERATION OF ACTION TAKEN

S.B. No. 2144, H.D. 2:

Senator Iwase moved that the Senate reconsider its action taken on April 12, 1996, in disagreeing to the amendments proposed by the House to S.B. No. 2144, seconded by Senator Tanaka and carried.

Senator Iwase then moved that the Senate agree to the amendments proposed by the House to S.B. No. 2144, seconded by Senator Tanaka.

Senator Iwase then explained:

"Mr. President, this bill relates to conservation easements. Amendments were made by the House at the request of the Department. They appear to be appropriate."

The motion was put by the Chair and carried, the Senate agreed to the amendments proposed by the House to S.B. No. 2144 and S.B. No. 2144, H.D. 2, entitled: "A BILL FOR AN ACT RELATING TO CONSERVATION EASEMENTS," was placed on the calendar for Final Reading on Wednesday, April 24, 1996.

Senator Solomon rose on a point of personal privilege and stated:

"Mr. President, I rise on a point of personal privilege.

"Mr. President, as you know, your Committee on Executive and Judicial Appointments will be taking up the matter of Mr. Joseph Blanco this coming Thursday. I was very much surprised ... well I'll just say I was kind of shocked when I turned on the news and there was Regent Lily Yao making remarks such as, 'The Regents will not stand for any kind of interference. The Regents will not stand for the Judicial and Executive Appointments Committee telling them what to do.'

"Mr. President, I would like to set for the record that your committee never asked the Regents to get involved. Your committee never made that proposal. As a matter of fact, that proposal came from Mr. Blanco who is the chairman of the Board of Regents and was backed by Mr. Dan Ishii who serves as its secretary. As a matter of fact, Mr. President, I have letters that I would like to quote and read. This is dated April 19th from the University of Hawaii Board of Regents, signed by Mr. Ishii and he says:

'While the Board did not indicate one way or another whether the Board would reconsider the reelection of Mr. Blanco as the chair, the Board did reaffirm its authority to elect its officers without external interference.'

"I take great offense to this last remark. Furthermore, Mr. President, I would like to read to my colleagues the opening remarks of Mr. Blanco. He says here: further public confidence in government, it became clear that the University needs to better inform the public about its standards of integrity that the Regents and the U.H. administration subscribe to. At this meeting today I am asking the board to determine how best to demonstrate that we can and have dealt with conflicts or potential conflicts of interest. After all, a competent board can scarcely be recruited from persons entirely free from potential conflicts of interest.' The chairman goes on to say, Mr. President, 'Should the regents as a body choose to provide guidance by developing a conflicts of interest which clearly articulates the university policy. community's views and which prescribes the process by which the board deals with potential conflicts of its members on both financial and personal matters, I would welcome it and adhere to it to the fullest. In doing so, we further public confidence in the university government, and we would set a new standard on the subject that other boards would likely benefit from.' And at that juncture, Mr. President, he goes on to recuse himself as the chairman, since they're dealing with his situation, and appoints Regent Yao to represent him.

"Mr. President and fellow colleagues, I demand a retraction from the chairman as well as Regent Yao and also from Mr. Ishii. And if I don't get that retraction, Mr. President, I hereby put you and my colleagues on notice that Mr. Blanco will remain deferred.

"Thank you very much, Mr. President."

Senator Liu then said:

"Mr. President, I rise for the purpose of wishing to make a couple of inquiries to the Senator from the Sixteenth District, the chairman of the Judiciary Committee, if he would yield."

The President posed the question to Senator Graulty, and Senator Graulty having answered in the affirmative, Senator Liu then continued with his first question:

"Thank you, Mr. President; thank you, Senator. I've had some time now to contemplate your response to one of my inquiries yesterday regarding the status of H.B. 2366, H.D. 1, and I can only come to the conclusion that from your comments yesterday, the current status of that bill is really a reflection of the wishes of a majority of the members of your committee, and that if a majority of the members of your committee desire to have, shall we say for example, a decision-making hearing on that bill, that it will be the chairman's position, based on his answer yesterday, that he would in fact hold such a meeting, regardless perhaps of his own position on the issue. Is that a fair statement?"

Senator Graulty answered:

"That is correct."

Senator Liu continued:

"Thank you, and one more question, if I may. Thank you, Mr. President. I notice (I received a copy from my colleague here who is a member of your committee) that you have scheduled two meetings with those who are purported and I guess some who have the titles of being

constitutional lawyers, and I was wondering whether or not the chair of Judiciary attempted to reach other scholars in the community -- for instance, former Associate Justice of the State Supreme Court, Frank Padgett -- for the purposes of these meetings to perhaps give a different point of view on the issue."

Senator Graulty responded:

"Senator, we contacted as many as we could last night and if Justice Padgett is willing to address the issue, we would be more than happy to accommodate him.

"We had solicited, as you know from the memo, the advice from Justice Nakamura, but he was unwilling to participate. I have asked the Professor of Constitutional Law at the University of Hawaii, John Van Dyke, to brief the committee this evening. And by the way, I wanted to make sure that all the Senators would know that they are welcome to participate at this evening's informational briefing, as well as the one that I have scheduled for tomorrow morning at 9:00 a.m. with Evan Shirley, whom I'm sure you know, Senator, is one of our foremost practitioners in constitutional law. They both indicated that they are willing to look at H.B. 2366 and give the committee their views. But if Justice Padgett is amenable, I'd be more than happy to contact him, or even better still, maybe you can contact him for me and invite him to brief the committee as well."

#### Senator Liu then stated:

"I appreciate the answer, Mr. President, and I believe the Senator understands my concern would be that both of the gentlemen who will be appearing, I think their views on the issue from the legal standpoint are fairly well known, and I'm happy to hear that the chairman of the Judiciary Committee is open to entertain views from others who may be as well-grounded in constitutional law to have a fair hearing of their views at these meetings. I appreciate that, Mr. Chairman, and perhaps we can communicate afterwards."

Senator Graulty then responded:

"May I just rebut? I do not know what Mr. Shirley's views are. My invitation to him last night was only to look at H.B. 2366 and give us his reading. I don't know what you mean when you say his views are well known. He has never been involved in the issue of same-sex marriage from the time that Baehr vs Miike was rendered by the Supreme Court. I do not know what his views are. I did not ask him what his views were. I have not met with him ahead of time and I wanted to make sure that you were aware of that.

"With regard to Professor Van Dyke, Professor Van Dyke is the the constitutional law professor at the University, the same law school that you and I attended. You know the level of his knowledge in constitutional law. He represents the Legislature in the matter pending before the courts on the constitutional amendments that we had passed out two years ago. I understand the hearing is tomorrow, but I don't think it's fair to say that in some way Professor Van Dyke has a bias with regard to H.B. 2366. I have not heard his views on the matter. I am soliciting his views as the Professor of Constitutional Law at the University of Hawaii Law School.

"With that, Mr. President, I hope I responded to the Senator's questions."

Senator Liu added:

"I appreciate the answer, Mr. President. In response, I will not question the integrity of the Senator regarding his

views or regarding his intent in requesting the attendance of Mr. Shirley. However, I will say that with all due respect to the position that Mr. Van Dyke holds, I would personally say that I disagree with his views on this issue as a matter for the record.

"Thank you very much."

Senator Holt then inquired:

"Mr. President, will the chairman of Judiciary yield to a question."

The Chair posed the question and Senator Graulty responded:

"Yes I will, Mr. President."

Senator Holt continued:

"Mr. Chairman, is it true that H.B. 3347 ... is that the correct number? The interpretation of statutes bill."

Senator Graulty interjected:

"I believe that is the correct number. That is the bill presently in conference."

Senator Holt then inquired:

"Presently in conference? What's the status of that bill, Mr. Chairman?"

Senator Graulty responded:

"I'm waiting for a memo from the Senate majority attorney, Mr. Wada, and once I get that memo which I hope to receive sometime this afternoon, I'll be sharing it with the members of the conference committee."

Senator Holt further inquired:

"What is the relationship between H.B. 3347 not being the subject of your meetings with the constitutional attorneys, yet H.B. 2366 will be the subject?"

Senator Graulty replied:

"Only because I had asked Mr. Wada yesterday afternoon, as I explained to Senator Liu when he asked me the question, to give us an opinion. I don't have any problem asking any of these two gentlemen to also give an opinion as to the language that the House is proposing in H.B. 3347. Again, it's a matter that I had asked Mr. Wada yesterday and he came first in time. But if that be the pleasure of the members of the Judiciary Committee, I would be very happy to add the additional assignment that they look at H.B. 3347.

"The other part of my response, Senator, is that Professor Van Dyke has already been quoted in the newspaper -- I believe in yesterday's Star-Bulletin -- as giving an opinion on that particular proposal from the House, and I did not really want to mix the two. I believe that the important inquiry for the committee at this point is whether H.B. 2366 is going to be able to do what the proponents of that bill think it's going to do."

Senator Holt questioned:

"And if in the eyes of your members, or the majority of the members of your committee, they feel that H.B. 2366 will address the issues, is it your intent to move the bill out of committee?"

Senator Graulty answered:

"I can't say that right now. I would want to meet with the members of the committee before I make any kind of public announcement with regard to that."

Senator Holt continued:

"But that is the purpose of the meeting -- to make that determination?"

Senator Graulty answered:

"Right. And if we make that determination first ...."

Senator Holt interjected:

"And if the determination is made in the affirmative that it does address the issue legally, then it will be the position of the committee to move the bill out of committee?"

Senator Graulty replied:

"I can't say that until I ask the members."

Senator Holt asked:

"Then what is the purpose of the meeting?"

Senator Graulty answered:

"To find out whether it is an appropriate vehicle. It may not do what people think it's going to do. And I think that's what I want to inquire into."

Senator Holt then said:

"Thank you, Mr. Chairman."

Senator Solomon then inquired:

"Would you yield to a question, Mr. President?"

The Chair having answered in the affirmative, Senator Solomon continued:

"Thank you. I have the understanding, Mr. President, that the Governor has requested that you appoint someone from the Senate to represent the Senate in some kind of a negotiation that the Governor is putting together regarding the OHA revenue issues. Is that true, Mr. President?"

The Chair responded:

"I believe that the Governor is having a meeting with one trustee from the Office of Hawaiian Affairs, Frenchy DeSoto, and he has asked both the Speaker and myself to send a representative from each body to a meeting in his office."

Senator Solomon continued to inquire:

"And Mr. President, do you know what the agenda of the meeting is? What is the purpose of the meeting?"

The Chair answered:

"I have no details about the agenda for that particular meeting. I was just called by the Governor informing me of a meeting."

Senator Solomon then asked:

"Mr. President, I'd like to ask if you would yield to another question? (Chair: "Certainly.") Thank you.

"It's my understanding, Mr. President, that on the Senate side, the bill on OHA and revenues was killed. Is that true, Mr. President?"

The Chair answered: "That is correct."

Senator Solomon continued:

"So, is there some other kind of agenda, Mr. President, that perhaps we on this floor do not know about? I mean is there going to be a re-awakening of that bill insofar as the Senate is concerned in terms of our position?"

The Chair responded:

"The Senate is not in support of the House position to reduce funds for OHA and until I am otherwise alerted by the members of the Senate, that is the Senate position. We are against the reduction of funds for OHA."

Senator Solomon then stated:

"Thank you very much, Mr. President, for reconfirming that position. Mr. President, may I continue on a point of personal privilege?

"Just to remind my colleagues here on the floor, I don't know if you realize this but when Governor Cayetano, then Senator Cayetano, was chairman of the Ways and Means Committee, it was his very actions, Mr. President, that defined the definition of revenues as it referred to the Office of Hawaiian Affairs. And I think it is quite ironic at this point in time, now that he is governor, he's questioning his own piece of legislation.

"The rally that is going on today is for that very purpose of the revenues of OHA. I am hoping that each and every one of you will stand firm on the position of the Senate as stated by the President. We negotiated this; it took us over a period of ten years and it really was through a lot of blood, sweat and tears.

"And I think the biggest 'give' that was given by the Hawaiians, was that the Hawaiians gave up their rights to appraise these properties and settled instead on an estimate in terms of revenue. And I have discussed this with our President, being that I was very much a part of these negotiations since I first became part of this honorable body. And I communicated to the President that if the House wants to consider all negotiations null and void, and if they want the Hawaiians to go back to the bargaining table, then I think everything should be put back on the table for consideration. Senator Yamasaki, who at that time guided us through this process emphasized to my colleagues at that time that this was a very serious, serious matter.

"So I don't know what the House is thinking. I don't know what their agenda may be, but I'm hoping -- I'm hoping -- that they will see their way clear to leave alone what has been done in good faith, and carry on with the commitments that we have made.

"Thank you, Mr. President."

Senator Anderson rose on a point of information as follows:

"Mr. President, on a point of information, if I may, for the previous speaker.

"I was going over the audit of the airport and under that audit it said for management cancelled bids, etc., there was \$102 million wasted on airports. So I just wanted to bring it to your attention that that alone, if we were getting any revenues, that's ten years that they could have been paying OHA from those funds. So if you would read the audit, I think it would enlighten you to find out that that's wasted money -- \$102 million.

"If you need the page number or whatever, please call my office and I'll gladly share it. Thank you."

Senator McCartney rose on a point of personal privilege and said:

"Mr. President, I'd like to rise on a point of personal privilege just to comment on the same-sex marriage issue and what is going on right now.

"I know it's a sensitive issue and the body is divided There's a lot of dialogue and debate. committee has a division on this. But the point that I wanted to let everybody know about is that our chairman, despite his personal position and the committee members' personal positions, has been open and fair. committee is openly and actively dialoguing those two bills, H.B. 3347 and H.B. 2366. And we are doing our We are doing our debate and dialogue soul-searching. internally, and I just want to assure the members of the Senate that we are doing the best we can to represent this entire body and the people of Hawaii. And in a few days we will have a decision as a committee on what direction we take. I think that can guide the course of action of what other people choose or choose not to do.

"I just wanted to assure the members of the Senate that the chairman is being very fair and very open, and we have complete communication and dialogue with him despite what our positions are on this issue.

"Thank you."

Senator Holt then rose and stated:

"Mr. President, just to follow up on the previous speaker's comment, I'm glad to see that the chair is being open and fair with the members of his committee. I would just hope that the chair would be open and fair with the rest of the members of the Senate.

"Thank you."
