Senator English rose to speak in support of the measure and said:

"Madam President, members, I rise to support the nominee.

"Your Committee on Transportation and International Affairs has had a very good working relationship with Brennon, and we consider him to be academically qualified as well as well-prepared for this job. We think that the initiatives with the airports, the initiatives with harbors, and in the future initiatives with highways will be excelled and will help us to improve the transportation in Hawai'i. And we feel that because of his attitude and outlook on how to make these projects happen, that they will happen in a timely manner. I ask my colleagues to be an effective leader in this role. Thank you."

Senator Trimble rose to speak in support of the nominee:

"Madam President, I also rise to offer brief remarks in support of Brennon Morioka.

"I will note for the record that he has a bachelor's and master's from Cal-Berkeley, whose colors are somewhat similar to that of Punahou, but please do not confuse them. He has a Ph.D. from the University of Hawai'i. He has taught some rather esoteric courses up there. The only problem I have with the gentleman is that he's a highway man. But looking beyond that, I have known him for seven years. The things that I have always known him to be are very determined, very peopleoriented, very concerned. What really shocked me was when I found out that he was an engineer.

"I urge my colleagues to vote for a very capable, hardworking, dedicated, solution-oriented people-person because he'll be a great, great Director of the Department of Transportation. Thank you."

Senator Hemmings rose to speak in favor of the nominee as follows:

"Madam President, I rise to speak in favor of the nominee.

"I'd like to just add a particular point of view I think is salient especially for 25 Senators. There are 16 active cabinet level heads in the executive branch of government who work for the Lingle administration. And as a State Senator, I don't ever recall one of my constituents calling me up and asking that I give Kurt Kawafuchi a call and ask him to do a better job collecting our taxes. The point is that I believe that besides working for the Lingle administration, in this particular department, because of the harbors, airports, but most especially because of the highways, Brennon gets calls from all 76 Legislators on a regular basis. Traffic is a huge and vexing problem for all of us, and this man is the right man at the right time for the right job.

"I'm looking forward to working with him as I think all the Senators would be, and I do urge us all to give him unanimous support with our vote today. Thank you, Madam President."

Senator Baker rose to speak in support of the nominee and said:

"Madam President, I, too, rise in support of this nominee.

"Perhaps all of us have traffic issues in our districts, but some of the more challenging ones happen to be in the fifth senatorial district on the island of Maui between Maalaea and Lahaina. And I must say that Mr. Morioka has helped our community with good humor, good advice, and patience to assist us through some of those thorny issues. So it is on behalf on my constituents that I rise in support of this nominee and express their appreciation for his continuing to shepherd some of these highway projects, even though now he has to look after harbors and airports as well. Thank you." The motion was put by the Chair and carried on the following showing of Ayes and Noes:

An article written late last year in the Honolulu Star Bulletin by Waipahu resident Daniel de Gracia summed it up best: 'All across the world, the Tomcat was America's premier representative of our will to defend our freedom, giving us a symbol to rally to in a time of uncertainty and low national self-esteem.'

"The F-14 Tomcat holds a special place in the heart of thousands of former U.S. Navy aviators, and an entire generation of individuals who read of its heroic exploits. Now that the aircraft is retired, all remaining aircraft not reserved for museums are being chopped up and destroyed for scrap use in soda cans, aluminum foil, automobiles, and other generic uses. For the men and women of that aircraft, all they have left is memories, and they would very much like to see those historic memories preserved in the form of a Tomcat stamp. The F-14 Tomcat pilots have a saying: 'Tomcats Forever.' I think it would be very fitting for the USPS to produce a first class Forever Stamp.
