"Madam President, I rise in opposition to Stand. Com. Rep. No. 3622, H.C.R. No. 346, S.D. 1.

"This is a resolution. It was a gut and replace resolution. It now calls on the Administration and the Legislature to complete the purchase of Turtle Bay Resort as well as the surrounding undeveloped lands and urges the commitment of the Legislature to assist with the purchase.

"First of all, this Legislature and this Administration has no business purchasing the Turtle Bay Resort. Turtle Bay Resort did not ask for any help from the Legislature. It is a private development. We don't have the money for this. It's one thing to talk about purchasing undeveloped lands. It's another thing to talk about zoning or changes. But to purchase and talk about the condemnation of private property at a time when we see more and more businesses folding in this community, and we continue to send negative messages about the business climate and the investment climate, I urge my colleagues to think about this and not commit this Legislature to this ill-fated plan. Thank you."

Senator Trimble rose to speak in opposition as follows:

"Madam President, the Senator from Hawai'i Kai urged me to reconsider my vote. So I will stand in opposition to S.C.R. [sic] H.C.R. No. 346. Thank you, Senator Slom."

At 11:48 a.m., the Senate stood in recess subject to the call of the Chair.

The Senate reconvened at 12:48 p.m.

Senator Hooser then moved that Stand. Com. Rep. No. 3622 and H.C.R. No. 346, S.D. 1, be recommitted to the Committee on Water and Land, seconded by Senator Ige.

Senator Hooser rose to speak in support of the recommittal and said:

"Madam President, because there's a conflict on the title and the contents of the resolutions, and we have a bill which is a much better vehicle moving—it's currently in conference to address these issues—that would be the most appropriate place to deal with the subject matter. Thank you."

Senator Slom rose to speak and said:

"Madam President, I'm just a little curious why all of a sudden that became an issue with the title when everyone knew that the original resolution had been gutted. You know, I just wish for once we would stand up and discuss these things in public and not go behind closed doors for an hour. We could discuss the issue and find out why people support something or why they oppose it. That's the honest thing to do. That's the transparent thing to do. And since we're always talking about that, yeah, I'm very distressed. We waste people's time. We waste our own time.

"Thank you, Madam President."

Senator Hee rose on a point of personal privilege.

"Thank you, Madam President. I rise in a point of personal privilege."

The President inquired:

"A point of personal privilege in our discussion on a recommittal motion? Please proceed."

Senator Hee replied:

"Sorry. That's okay. We'll do it your way."

At 12:49 p.m., the Senate stood in recess subject to the call of the Chair.

The Senate reconvened at 12:51 p.m.

Senator Hee rose to speak in support of the recommittal as follows:

"Madam President, I rise in support of the motion to recommit.

"Notwithstanding the previous speaker, the fact of the matter is the Majority had a long discussion on the incongruity of the title to the body. I would like to point out that but for the title I would be voting against the recommittal because I believe that, you know, I have staked out a public position as part of the working group. This has been a long process. It's been an open process which reporters have been invited and other members of the public every Wednesday. And we will have another meeting; I believe it's this Thursday. The public's invited. The reporters have been present.

"But more than that I would like to articulate that part of the reason for my support of the body—and not the title—was that it clearly lays out issues that we have discussed as part of the working group, and part of it as the Governor has said—and the working group has stood behind her position that she recognizes that the State does not intend to own, operate the resort, that she intends to not lose a single job. And that she has said privately and now has laid out publicly through this reso that the intent through these negotiations is to result with a net zero outlay in state moneys. And I am remiss that I did not check clearly the title and take into account the concerns of the members of the Majority. So I will support recommittal at this time. Thank you."

Senator Hemmings rose to speak in support of the recommittal as follows:

"Madam President, I rise to speak in favor of the motion to recommit

"Though it's been explained to us that the legislation can replace the resolution, I cannot sit here and take in the excuse. And I don't know how you do it with a straight face. If nothing else, your party—the Majority party—is very, very keen on the machinations of this process. You've actually pulled some rabbits out of some amazing hats. But to stand up at this time, after all this resolution's been through, and the subject's been through, and to use as an excuse that the title's not correct, I think is insulting to most reasonable people's intelligence. Thank you, Madam President."

Senator Baker rose to speak in support of the recommittal and stated:

"Madam President, I rise in support of the motion to recommit.

"The consideration of the current subject matter in this resolution came only recently. The measure probably should have had a Ways and Means referral, but because of the timing it would have made it problematic. I think on further reflection, members concluded as did this Chair that the more appropriate vehicle for substantive consideration of whether we are able to assist in the preservation of the Turtle Bay area is in the bill that is in conference that does have all the appropriate referrals. I think this is where we can make an appropriate referrals. It hill reflection of members of this Body and the members of the House to try to move something forward that may address all of the concerns that have been outlined before as well as give us an opportunity to see what is possible on a going forward basis. And that's why I support this recommittal. Thank you."

# APPOINTMENT OF CONFEREES

In accordance with the disagreement of the Senate to the amendments proposed by the House to S.B. No. 1035, and the request for a conference on the subject matter thereof, the President appointed Senators Tokuda, chair; Fukunaga, cochair; English and Whalen as managers on the part of the Senate at such conference.

Senator Trimble rose to speak on a point of personal privilege.

"Madam President, I rise on a point of personal privilege.

"Colleagues, can you imagine my surprise last Friday when I heard Ben Villaflor, Sergeant-at-Arms, calling for a Republican Senator to show up at a Joint Committee for vote taking?

"It reminded me of standing up on Wednesday and questioning then the head of the state's Ethic Commission, saying that accepting free air transportation, ground transportation, and hotel accommodation from two to four days was not in a conflict of interest. I've thought about the remarks I made on Wednesday. I thought I'd repeat them so that no one would stand and say that I had possibly said something behind their back. I find what the Ethics Commission said was confusing. I wonder if Dan Mollway had complete information when he rendered his opinion. I will be requesting further information from him.

"And I'm also curious, Madam President, of the length of time of absences that you approved. Because I notice when I look around the room that not all members that went on that trip are in Chambers today. And I was just curious when we will have a full contingency to worry about what we're doing this week, which is truly crunch time. This is when we're supposed to be worrying about differences in wordings between House versions and Senate versions. And in my five years in, or six years in the Hawai'i State Senate, I've never seen that so many people were approved to go on a trip at one time—particularly during conference committee time. And I find it puzzling. Thank you."
