TWENTY-FIFTH DAY

Friday, March 4, 2011

The Senate of the Twenty-Sixth Legislature of the State of Hawai'i, Regular Session of 2011, convened at 11:39 a.m. with the President in the Chair.

The Roll was called showing all Senators present with the exception of Senators Dela Cruz, English, and Kim who were excused.

The President announced that he had read and approved the Journal of the Twenty-Fourth Day.

At this time, Senator Baker introduced a number of individuals who were at the Capitol as part of Associa Hawaii's Day at the Legislature to learn what the Legislature does and to interact with members and committees who may have an effect on their industry. Two of the participants recognized included account executives Linda Ames and Douglas Lefler from Certified Management Incorporated in Kīhei, an Associa company.

Senator Galuteria introduced other employees of Associa who were participating in the company's first legislative day, and noted that Associa is a national leader in community association management which serves 1.4 million households in associations across the mainland, and manages over 70,000 homes in Hawai'i through its local organizations—Certified Management Company and Hawaii First.

Senator Slom introduced two constitutents from the Eighth Senatorial District: Kanani Kealoha Faleafine and Kristi Hirota-Schmidt, both of whom work for Associa.

Her father, Bobby Maesaka, was a prison guard from 1959 to 1984. Her brother is a sergeant at OCCC. Her father shared with her that working in the prison system is not an easy job, but someone has to do it. When she started as a social worker, her father told her, 'Jodie, I know you will make a good social worker. Just remember the inmates are people who made mistakes and that their sentences are their punishment.' 'Most of the inmates will be returning to the community,' he said, 'and it is up to the staff to make their lives better so that they will become productive citizens who participate positively when they are released.'

"Five days after Jodie started as a social worker at Halawa, her father passed away. Miss Maesaka-Hirata earned her Bachelor of Science in Social Work at the University of Hawai'i at Mānoa and her Master of Science in Criminal Justice Administration from Chaminade University. She was a social worker with our state's prison system in 1989 to 1994, became a supervisor from 1994 to 2007, and was promoted to be the warden of Waiawa Correctional Facility in 2008. She shared with the committee her many goals for improving the corrections system, and your committee was satisfied with her credentials and her experience for this position. In the new administration and the new day, she will be tasked with many important jobs, including overseeing the return of at least 1,000 to 2,000 inmates from the mainland, improving the sheriff's division, and, of course, building and developing a corrections system for the next 50 years for our state.

"Your committee recommends that the Senate advise and consent to the nomination of Jodie Maesaka-Hirata for the position of the Director of Public Safety."

Senator Baker rose in support of the nominee as follows:

"I think that our nominee has been breaking the glass ceiling all of her life in her work in corrections, and this is another instance; and I commend the Governor for making this fine appointment because another glass ceiling will be shattered. Thank you."

"He was a senior military officer in two separate China engagement programs and played a significant role in initiating exchanges for Chinese disaster management to improve international relationships through sharing ideas and enhanced emergency response and reduce trauma impact. He created the Eagle Vision Unit, one of only six in the nation, to provide commercial satellite imagery in war fighting and use in natural disaster response. The 109th Air Operation Group he created assists with Air Force fighting capability for contingencies in the Pacific and natural disaster response in the state. Your committee has reviewed and approved his qualifications for the position, and we feel that he will be the leader we need to help expand our Youth Challenge Academy, to work with the countries and the members associated with APEC, and most importantly, to train and make certain that our troops are prepared for any encounter before them.

"Your PGM members recommend that the Senate advise and consent to the nomination of Major General Darryll D. M. Wong as the Adjutant General for the State Department of Defense."

Senator Kahele rose in support of the nominee as follows:

"Having served in the United States Marine Corps, I, too, understand the rigors required of military service to our country. I respect the lifelong leadership skills that the nominee, Major General Darryll Wong, demonstrated in his nearly four decades of service that has culminated in his position as Commander of the Hawai'i Air National Guard. His impressive military resume illustrates his high qualifications to lead the Department of Defense. Born, raised, and educated in Hawai'i, he is truly a keiki o ka 'āina and exemplifies all that we hope for our keiki. His perseverance, dedication, and commitment to our community confirm his capacity to ensure the department's continued progress for 'A New Day in Hawai'i' and the State Department of Defense. Thank you, Mr. President."
