The Roll was called showing all Senators present with the exception of Senator Tsutsui who was excused.

The Vice President announced that she had read and approved the Journal of the Sixth Day.

By unanimous consent, action on Conf. Com. Rep. No. 1-12 and H.B. No. 608, H.D. 3, S.D. 1, C.D. 1, entitled: "A BILL FOR AN ACT RELATING TO HEALTH," was deferred until Tuesday, January 31, 2012.

FINAL READING

Conf. Com. Rep. No. 2-12 (S.B. No. 239, S.D. 2, H.D. 2, C.D. 1):

Senator Tokuda moved that Conf. Com. Rep. No. 2-12 be adopted and S.B. No. 239, S.D. 2, H.D. 2, C.D. 1, having been read throughout, pass Final Reading, seconded by Senator Green

Senator Tokuda rose to speak in support of the measure as follows:

"I would like to encourage the passage of both measures that are a part of our fast tracked priorities: SB 239 and SB 809. The first will extend the use of tobacco funds to allow the John A. Burns School of Medicine to cover operating expenses; and the latter bill is in alignment with the Senate's focus this session to create a win-win situation by creating jobs through badly needed construction and repair and maintenance projects, while addressing our aging infrastructure and capacity needs. I appreciate the body's support on these measures and I hope we can get this rolling. Thank you."

Senator Slom rose to speak in opposition to the measure as follows:

"As I've said in the past, I cannot support the bill because what it does is divert money from the legitimate purposes that the Legislature authorized for the use of this tobacco settlement money to the School of Medicine to operating expenses, to their debt service, and then in the future it's going to go into the general fund. Again, it makes a mockery of the special fund and specifically, purposes to which the people think the money is going. Thank you."

The motion was put by the Chair and carried, Conf. Com. Rep. No. 2-12 was adopted S.B. No. 239, S.D. 2, H.D. 2, C.D. 1, entitled: "A BILL FOR AN ACT RELATING TO THE HAWAII TOBACCO SETTLEMENT SPECIAL FUND," having been read throughout, passed Final Reading on the following showing of Ayes and Noes:

Senator Ryan rose to speak on a point of personal privilege as follows:

I think it's an affront to the Hawaiian people, but also to the State of Hawai'i and it involves departments. I ask the support of my colleagues to demand that it be removed immediately."
