Thursday, March 15, 2012

The Senate of the Twenty-Sixth Legislature of the State of Hawai'i, Regular Session of 2012, convened at 11:35 a.m. with the President in the Chair.

The Roll was called showing all Senators present.

The President announced that he had read and approved the Journal of the Thirty-First Day.

At this time, Senator Shimabukuro introduced a group of tenth-grade students from Waianae High School's "Sharin' D' Lemon" Lemonade Alley team who were participating in the nationwide business literacy competition, including Charlemaine Blue, Maryann Manouthan, Marina Neito-Lopes, Taase Taofi, and their advisor Diana Sepplefrick.

"Colleagues, today, just very briefly, I'd like to say three names: Irving, Virgil, and Jonathan. These three men, Hawai'i residents, are alive today. Not six weeks ago, we came together as a body in a bipartisan fashion—thank you, Sam—and we approved \$1.5 million for the Queen's transplant program.

"I just had the honor of going over to Queen's, on your behalf and the behalf of many families in Hawai'i, and was able to sit with them. Two of those gentlemen had their liver transplants in the last two weeks. They are thriving. The third gentleman was the last individual to get a transplant at HMC West; he is doing terrific. I was able to sit with their wives, who are grateful that they have their husbands, who are all grandfathers.

"It is really very rare, I think, that we get to reflect on something that we do here at the Capitol, and in very short order see a result like that. So honest to goodness, Irving, Virgil, and Jonathan are alive today because of your generosity and the very hard work of Dr. Wong and Art Ushijima at Queen's and the many advocates—the Lucys of the world—who advocate for transplant services. But I wanted to thank you. You looked out for those gentlemen; there are going to be a lot more people to come that are going to get transplants here in Hawai'i. You should be very proud of yourselves and so should the State of Hawai'i. Thank you."

Senator Gabbard rose to remind the members about the upcoming Hawai'i Foodbank fundraiser, Capitol Idol 2012, and exhorted the members to use their talents to raise funds for a worthy cause.

Senator Shimabukuro rose on a point of personal privilege to suggest that Senator Espero do a poetry reading for the event.

Senator Kim rose on a point of personal privilege to extend belated happy birthday wishes to Senator Hee, and humorously encouraged him to share his various talents in rodeo and horseback riding at the event.

Senator Hee responded by noting that Senator Gabbard was proficient in jumping rope, and suggested that he share that unique talent at the event.
