

## TWENTY-THIRD DAY

## Thursday, February 28, 2013

The Senate of the Twenty-Seventh Legislature of the State of Hawai'i, Regular Session of 2013, convened at 11:33 a.m. with the President in the Chair.

The Roll was called showing all Senators present.

The President announced that she had read and approved the Journal of the Twenty-Second Day.

At this time, Senator Wakai introduced 100 fourth-grade students from Salt Lake Elementary School who were accompanied by their teachers and chaperones.

By allowing the Public Utilities Commission to evaluate, select and tailor the best set of incentive mechanisms to transform Hawaii’s electric industry, the Committee on Commerce and Consumer Protection hoped to create a regulatory tool that could help the State transition to an affordable clean energy-focused system that is mutually beneficial to electric utilities and ratepayers.

“Hawaii electricity rates are at record levels, due in large to the high cost of petroleum used to fuel electric plants on all the islands. Electric ratepayers are in need of relief and with this regulatory tool, the State can better guide the electric utilities to accelerate their efforts to acquire and implement lower cost, clean energy resources.

“With the introduction of economic incentive mechanisms, the electric utilities can retire old, inefficient utility plants without passing the costs onto the consumer and without losing financial rewards. SB 120, SD1 will help encourage the much needed electric utility infrastructure improvements which will directly help the consumer and help Hawaii reach its clean energy goals.”
