The Senate of the Twenty-Seventh Legislature of the State of Hawai'i, Regular Session of 2014, convened at 11:36 a.m. with the President in the Chair.

The Roll was called showing all Senators present.

The President announced that she had read and approved the Journal of the Twenty-Sixth Day.

At this time, Senator Taniguchi congratulated and recognized the Honolulu Festival in Hawai'i on its twentieth anniversary, and presented the following remarks:

"Thank you, Madam President. It gives me great honor to recognize the Honolulu Festival, which is celebrating its twentieth anniversary in Hawai'i this year. The festival begins today and runs through Sunday, March 9.

"Since 1995, thousands of artisans, performers, and visitors from Japan and the Pacific region travel to Hawai'i each year to participate in the Honolulu Festival. Recognized as one of Hawai'i's premier cultural events, the many activities of the Honolulu Festival are held at locations easily accessible to residents and visitors alike. And since admission is free, festival events, performances, demonstrations, and exhibits can be enjoyed by all.

"This international event is generously sponsored by the Honolulu Festival Foundation, whose largest supporter is JTB, formerly known as the Japan Travel Bureau. At the same time as the Honolulu Festival, JTB is also celebrating its 102nd anniversary of its founding in Tokyo, Japan. JTB first opened an office in Honolulu in 1964, and this year marks its fiftieth anniversary.

"Representing JTB, we are fortunate today to have President and CEO of JTB Corporation from Japan, Mr. Hiromi Tagawa. With him is the President and CEO of JTB Hawaii, Inc., Mr. Keiichi Tsujino.

"Also, in the gallery we have Mr. Tsukasa Harufuku, executive vice president of JTB and board member of the Festival Foundation; and Mr. Masayuki Endo, also with JTB."
