Wednesday, February 4, 2015

The Senate of the Twenty-Eighth Legislature of the State of Hawai'i, Regular Session of 2015, convened at 11:37 a.m. with the President in the Chair.

The Roll was called showing all Senators present with the exception of Senator Galuteria who was excused.

The President announced that she had read and approved the Journal of the Eighth Day.

MESSAGES FROM THE GOVERNOR

The following messages from the Governor (Gov. Msg. Nos. 169 to 173) were read by the Clerk and were placed on file:

Gov. Msg. No. 169, letter dated January 30, 2015, as provided in Section 9, Article VII, of the Constitution of the State of Hawai'i, requesting the immediate consideration and passage of S.B. No. 1072, which makes an emergency appropriation for the Department of the Attorney General.

No. 1118, which makes an emergency appropriation to the Department of Health for hazard evaluation and emergency response preparedness.

Second Reading and be referred to the Committee on Ways and Means.

On motion by Senator Green, seconded by Senator Slom and carried, the report of the Committee was adopted and S.B. No. 158, S.D. 1, entitled: "A BILL FOR AN ACT RELATING TO THE BUDGET DOCUMENTS," passed Second Reading and was referred to the Committee on Ways and Means.

Senator Keith-Agaran, for the Committee on Judiciary and Labor, presented a report (Stand. Com. Rep. No. 8) recommending that S.B. No. 139, as amended in S.D. 1, pass Second Reading and be referred to the Committee on Ways and Means.

On motion by Senator Green, seconded by Senator Slom and carried, the report of the Committee was adopted and S.B. No. 139, S.D. 1, entitled: "A BILL FOR AN ACT RELATING TO CIVIL SERVICE EXEMPTIONS," passed Second Reading and was referred to the Committee on Ways and Means.
