Senator Ruderman then moved that the Senate advise and consent to the nomination of SCOTT ENRIGHT as Chairperson of the Department of Agriculture, term to expire December 31, 2018, seconded by Senator Riviere.

Senator Ruderman rose to speak in support of the nominee as follows:

"Thank you, Madam President. Over the past 38 years, Scott Enright has lived and worked on each of the five major islands in Hawai'i, and for 23 years has resided on the Hamakua Coast of the island of Hawai'i. He brings with him a comprehensive understanding of agricultural business and economics in Hawai'i, including extensive firsthand knowledge of bioenergy fuel stock and an in-depth understanding on land use planning and policy as it pertains to agriculture in Hawai'i.

"Scott has a strong working knowledge of sustainable, multiuse agricultural models that encompass crop diversity, livestock management, forestry, waste-to-energy, and affordable worker housing, coupled with a strong background in community building.

"Scott has been director of the Department of Agriculture since January 2014, and deputy director for the previous two years. Director Enright serves as the national chair of NASDA, the National Association of State Departments of Agriculture. This prestigious position may be useful to Hawai'i in many ways, and Hawai'i is honored to be hosting the national convention of this organization this summer on the Big Island.

"In your committee, we heard enthusiastic support from a broad spectrum of the community. We were particularly impressed with the fact that the nominee enjoys support from every sector of ag, from large-scale industries, including biotech, to small farmers and the organic farming community. This ability to relate to and support all kinds of farmers is exactly what we need in Hawai'i today.

"I'm grateful such a strong candidate chooses continued service to our state. I urge my colleagues to confirm Scott Enright as director of the Department of Agriculture, and I'm confident your support will be rewarded with an excellent, competent stewardship of the Department of Agriculture. Thank you, Madam President."

Senator Slom rose to speak in support of the nominee as follows:

"On behalf of the Senate Minority, we fully support the nominee. And in addition to the things that were just said about him from the Agriculture chairman, I think it's important to note that a number of people who were in opposition to his nomination have come forward and said how he reached out to them, how he listened, and how he provided results. So, I concur with the remarks by the good senator from the island of Hawai'i. He is the right man for this position. Thank you."

Senator Kouchi rose to speak in support of the nominee as follows:

"I just would briefly touch on what my colleague from Hawai'i Kai said. He has a unique gift to go into a room for a contentious hearing and take the temperature down. And in the last several years, there's been an alarming trend of people coming out to public meetings and acting in a disruptive way, taking over meetings, and having people cancel the meetings. I cannot underscore how valuable the skill that Chair Enright has to walk into the room, to make everyone feel that they will be fairly heard, and he has the knowledge in which to exchange with the participants so that they know that there is someone who will be able to make a good decision because he has the knowledge and the background to address the problems that they are there to discuss. Thank you."

Senator Thielen rose to speak in support of the nominee as follows:

"I have had the great pleasure of working with Chairman Enright; although I don't know that he would call it a pleasure working with me in return. I represent a district which includes a lot of nurseries and small farms, and there's a tremendous demand for his time and attention, and he has been very, very generous with his time and attention for people. We are fortunate to have somebody who is willing to put that effort in, especially somebody who lives on a neighbor island and is commuting. So mahalo to the nominee."

Senator Nishihara rose to speak in support of the nominee as follows:

"I'd like to also echo the sentiments of the previous speakers. I've had to work with Mr. Enright; I've found him to be someone who's well-capable to handle the various controversies that come up before Agriculture. I know that he's well-regarded – you can trust his word. He's a person of deep character, and, certainly, he can handle whatever controversial issues that have come up, and there have been a number of them. I've only found him to be open and willing to listen to the other side and to do all he can to further the agricultural industry in Hawai'i. So, I rise in strong support for him and ask other members as well to support him. Thank you."

Senator Dela Cruz rose to speak in support of the nominee as follows:

"I just want to acknowledge the hard work of the incoming chair with the Whitmore Project. It's probably the largest undertaking for agriculture the state's seen in recent years, and because of his leadership and his participation in the ADC board, it's going to be real as part of all of our terms — within the time we're elected, we'll see the fruits of our labor. It's not something we're going to see 20, 30 years down the line. So, I really appreciate his help and ask all of you to support his confirmation. Thank you."

Senator Kahele rose to speak in support of the nominee as follows:

"I've known Scott for many, many years and always knew that he had the qualities to serve in this position, as well as the experience and all of that will be brought to the Department of Agriculture. So, I welcome Scott; ask my colleague for your support; and hope that we'll work closely together, Scott. Thank you very much."

The motion was put by the Chair and carried on the following showing of Ayes and Noes:

Ayes, 25. Noes, none.

At this time, Senator Ruderman introduced Scott Enright, newly confirmed director of the Department of Agriculture, who was present in the gallery.

Stand. Com. Rep. No. 1563 (Gov. Msg. No. 502):

Senator Ruderman moved that Stand. Com. Rep. No. 1563 be received and placed on file, seconded by Senator Riviere and carried.

Senator Ruderman then moved that the Senate advise and consent to the nomination of PHYLLIS SHIMABUKURO-GEISER as Deputy Chairperson of the Department of Agriculture, term to expire December 3, 2018, seconded by Senator Riviere.

Senator Ruderman rose to speak in support of the nominee as follows:

"Phyllis Shimabukuro-Geiser is a third-generation descendant from a farming family which produced pineapple on Maui and then diversified into tomatoes and fresh eggs on O'ahu. Phyllis earned both bachelor and master of science degrees in agriculture and wants to dedicate the rest of her career using her 30 years of experience in farming to help the farmers, ranchers, and the State of Hawai'i toward sustainability, food resiliency, and quality of life. She states: 'Helping to feed our people with more locally produced foods is the noblest gift I can offer through public service.'

"I'm grateful to see an actual food farmer appointed to this position, as I know she understands the challenges facing Hawai'i's farmers from a firsthand, real-life perspective. Her knowledge and experience will be a great asset to the director and to the department. Your committee was extremely impressed with the outpouring of support for Ms. Shimabukuro-Geiser and with her remarkable ability to truly listen and communicate clearly. Also, her deep-rooted sense of community and genuine respect for all were apparent.

"I'm pleased that Ms. Shimabukuro-Geiser wants to serve our state in this capacity, and I urge my colleagues to support her as deputy director of the Department of Agriculture. Thank you."

Senator Slom rose to speak in support of the nominee as follows:

"I've known Ms. Shimabukuro-Geiser for many years. She's smart; she's articulate; and she brings a wealth of knowledge to this position. She'll be a very good help to the department head and to the people of Hawai'i. We talk about the importance of agriculture all the time – here's someone who's brought us our daily eggs for many years. Thank you."

The motion was put by the Chair and carried on the following showing of Ayes and Noes:

Ayes, 25. Noes, none.

At this time, Senator Ruderman introduced newly confirmed Deputy Director Phyllis Shimabukuro-Geiser, who was present in the gallery with Governor David Y. Ige and his Chief of Staff Mike McCartney, and supporters from the Department of Agriculture.
