Tuesday, April 28, 2015

The Senate of the Twenty-Eighth Legislature of the State of Hawai'i, Regular Session of 2015, convened at 11:41 a.m. with the President in the Chair.

The Roll was called showing all Senators present with the exception of Senators Galuteria and Ruderman who were excused.

Senator Keith-Agaran rose to speak in support of the nominee as follows:

"Linda Chu Takayama brings experience and training from her private law practice and her years of public service at the federal and state level to this position. During her prior tenure as the Hawai'i insurance commissioner, Ms. Chu Takayama developed programs to stabilize and expand the property insurance market during the highly volatile period following Hurricane Iniki, including establishing the Hawaii Hurricane Relief Fund. She was a member of the governor's subcabinet task force on health care reform and chaired the governor's task force on workers' compensation reform. She also brings her previous experience from Washington, D.C., where she served as chief of staff to United States Senate Sergeant-at-Arms. From her prior service, we can expect that she will be able to balance the needs of workers with the needs of employees and industry.

"The nominee has been described as a person strongly guided by a strong foundation of values, including the right of all of us to an honest day's work, to be fairly compensated for that work, and to be cared for in terms of injury or illness. She's committed to supporting the training of a vibrant workforce to meet the challenges of an evolving community. She's been described as fair, intelligent, and tough – not bad descriptions for the next director of Labor.

"In short, I'm confident that Ms. Chu Takayama's values are consistent with the goals of the Labor department and its attached agencies, and I am confident she'll provide strong leadership and appropriate administrative support to successfully meet their objectives. I urge my colleagues to advise and consent to Linda Chu Takayama as the next Hawai'i director of Labor."

Senator Baker rose to speak in strong support of the nominee as follows:

"Ms. Chu Takayama is an additional outstanding female member of the cabinet, along with other women that our governor has sought fit to appoint and bring into state service. They are strong, talented, able, capable, and actually are the epitome of, I think, the kind of role models we want our daughters, sisters, mothers, aunties to have. So it's my pleasure to stand in strong support of this nominee. We know that she'll do very well, and I invite my colleagues to join me in voting up on her nomination."

H.C.R. No. 205, S.D. 1:

The Chair stated:

"Members, due to a clerical oversight, this resolution was not acted on in time to meet yesterday's crossover deadline for amended concurrent resolutions. After consulting with the subject matter committee chairs, the recommendation is for the Senate to reconsider its previous action in adopting Standing Committee Report No. 1691, then adopt the unamended House concurrent resolution and return it to the House. At this time, if there are no objections from the members, the Chair will entertain a motion for reconsideration at this time."

Senator Gabbard moved that the Senate reconsider its action taken on April 24, 2015, in adopting Stand. Com. Rep. No. 1691, seconded by Senator Green.

Senator Gabbard noted:

"Colleagues, this resolution requests the Department of Health to promptly investigate all alleged violations in the solid waste recycling industry and fairly and equally enforce applicable laws and regulations for all companies. In order to move this resolution forward, I am recommending that the Senate adopt this resolution in its original form. The only amendment contained in the S.D. 1 is new language regarding the importance and value of the management of waste through solid waste recycling and alternative means of waste disposal. The original H.C.R. No. 205 accomplishes the same goal as the S.D. 1, so I ask for your favorable support of this motion."

The motion was then put by the Chair and carried.

On motion by Senator Gabbard, seconded by Senator Green and carried, H.C.R. No. 205, entitled: "HOUSE CONCURRENT RESOLUTION REQUESTING THE DEPARTMENT OF HEALTH TO EXAMINE EXISTING AND ALLEGED VIOLATIONS IN THE SOLID WASTE RECYCLING INDUSTRY AND FAIRLY AND EQUALLY ENFORCE APPLICABLE LAWS AND REGULATIONS FOR ALL COMPANIES," was adopted.

FINAL READING

S.B. No. 550, S.D. 1, H.D. 2:

Senator Green moved that S.B. No. 550, S.D. 1, H.D. 2, having been read throughout, pass Final Reading, seconded by Senator Espero.

Senator Slom rose to speak in opposition to the measure as follows:

"This is an interesting bill. It started out about tobacco and ecigarettes – it was a bill that I actually signed onto, the original Senate Bill 550. Somewhere between the H.D. 1 and H.D. 2, it became about a new product called 'powdered alcohol.' Now, Madam President, I am the last person you want to talk to about alcohol and alcohol products, but I do have concerns, as I always do, about our state bragging about being the first to ban something.

"It's interesting that the Alcohol and Tobacco Tax and Trade Bureau (TTB), which is a division of the Department of the Treasury, approved the sale of powdered alcohol products, or Palcohol, on March 10th of this year. Now, being a diligent member of the Senate, I sent my staff out to bring some packets of powdered alcohol so I could both show them and share them with my colleagues here. Unfortunately, they couldn't bring me any of the powdered alcohol because there is none; it's not available yet. And yet, we are going to ban the product before it's even here, and we're going to call it a public safety issue or public health issue. It is powdered alcohol. If we're talking about a public health issue, then we would ban liquid alcohol, but we're not going to do that. Why? Because it brings in a great deal of revenue, and that brings up another point here.

"If this bill passes and becomes law, then we will have to find funds to enforce the law and, at the same time, we will lose revenues that would ordinarily go to the state. In addition to that, this Senate has debated bills that had to do with the problem of glass recycling and the cost of glass. This helps solve that problem.

"But I'm most concerned about the fact that whenever there is a new product, whether it's e-cigarettes or now powdered alcohol, we want to jump on top of it; we want to ban it; we want to regulate it out of business. And that's the reputation that we're getting in the State of Hawai'i. To ban a product before it's even here, not to regulate or tax it as an alternative, to me, seems to be short-sighted. Thank you, Madam President."

The motion was put by the Chair and carried, the Senate agreed to the amendments proposed by the House to S.B. No. 550, S.D. 1, and S.B. No. 550, S.D. 1, H.D. 2, entitled: "A BILL FOR AN ACT RELATING TO HEALTH," having been read throughout, passed Final Reading on the following showing of Ayes and Noes:

Ayes, 21; Ayes with Reservations (Espero, Ihara, Riviere). Noes, 2 (Slom, Thielen). Excused, 2 (Galuteria, Ruderman).

S.B. No. 982, S.D. 1, H.D. 2:

On motion by Senator Green, seconded by Senator Espero and carried, the Senate agreed to the amendments proposed by the House to S.B. No. 982, S.D. 1, and S.B. No. 982, S.D. 1, H.D. 2, entitled: "A BILL FOR AN ACT RELATING TO MEDICAL AMNESTY," having been read throughout, passed Final Reading on the following showing of Ayes and Noes:

Ayes, 23. Noes, none. Excused, 2 (Galuteria, Ruderman).

RECONSIDERATION OF ACTIONS TAKEN

S.B. No. 961, S.D. 2 (H.D. 3):

Senator Green moved that the Senate reconsider its action taken on April 16, 2015, in disagreeing to the amendments proposed by the House to S.B. No. 961, S.D. 2, seconded by Senator Chun Oakland and carried.

In accordance with the Conference Committee Procedures agreed upon by the Senate and the House of Representatives, the managers on the part of the Senate recommended that the Senate agree to the amendments proposed by the House to S.B. No. 961, S.D. 2, on the following showing of Ayes and Noes:

Ayes, 3 (Green, Keith-Agaran, Harimoto). Noes, none. Excused, 2 (Chun Oakland, Slom).

Senator Green then moved that the Senate agree to the amendments proposed by the House to S.B. No. 961, S.D. 2, seconded by Senator Chun Oakland.

Senator Green noted:

"Madam President, I think they made some good additions to this bill. They put in some additional protections that patients who are committed to assistant community treatment for mental illness, these protections be afforded to them by licensed psychiatrists having enough information about their petition to actually give them proper diagnosis and help. So, we agreed with the subject material of their changes. There were additional safety provisions, like I said, for the individual patients, and that was the means for us to agree. Plus, we did have to agree with their effective date."

The motion was put by the Chair and carried, the Senate agreed to the amendments proposed by the House to S.B. No. 961, S.D. 2, and S.B. No. 961, S.D. 2, H.D. 3, entitled: "A BILL FOR AN ACT RELATING TO MENTAL HEALTH TREATMENT," was placed on the calendar for Final Reading on Wednesday, April 29, 2015.

At this time, Senator Riviere thanked the members for their support of the food bank drive, and announced that the Senate's efforts had raised approximately \$5,000 and collected nearly 500 pounds of food.

On behalf of the members of the Senate, the Chair thanked Senator Riviere and his staff for coordinating the food bank drive.
