FIRST DAY

Wednesday, January 20, 2016

In accordance with the provisions of Section 10 of Article III of the Constitution of the State of Hawai'i, the Senate of the Twenty-Eighth Legislature of the State of Hawai'i, Regular Session of 2016, was called to order at 10:03 a.m., by the Honorable Ronald D. Kouchi, President of the Senate.

The members of the Senate and guests rose for the invocation, delivered by Pastor Matt Higa of New Hope, Kaua'i. The members and guests remained standing to sing the National Anthem and "Hawai'i Pono'ī," led by Nalani Brun.

The Roll was called showing all Senators present with the exception of Senator Kahele who was excused.

At this time, Senator Espero introduced the following members of the Fukuoka Prefectural Assembly who were present in the gallery: Kensei Haraguchi, Chairman, and his wife, Kazuko Haraguchi; Katsutoshi Otsuka, Assemblyman; Kaname Tsutsumi, Assemblywoman; Katsuji Kohara, Assemblyman; Hiroyuki Inoue, Assemblyman; Hisatoshi Hoshii, Assembly Office Staff; Koichi Isayama, Fukuoka Kenjin Kai; Toshiyuki Kaku, Assembly Office Staff; and Motoaki Yoshimatsu, Assemblyman.

Senator Shimabukuro welcomed DeMont and Rachel Conner from Ahupua'a 'O Nānākuli Homestead; Uncle Joe Tassill and his wife, Aunty June; and Tori McCann, University of Hawai'i – West O'ahu intern who would be assisting the Committee on Hawaiian Affairs this session.

Senator Keith-Agaran noted the presence of Chief Justice Mark E. Recktenwald, Supreme Court, State of Hawai'i, in the gallery.

Senator Taniguchi welcomed Edgar Ruiz, executive director of The Council of State Governments West, who was present in the gallery.

Senator Galuteria recognized the presence of Office of Hawaiian Affairs Trustee Hulu Lindsey in the gallery.

Senator Kidani acknowledged Department of Education Superintendent Kathryn Matayoshi, who was present in the gallery.

At this time, the President addressed the members of the Senate as follows:

"At this time, I'd like to offer a few remarks on this first day of the 2016 session. To all of our distinguished, honored guests: Welcome to your house. One of the nice things about being the President is, well, each and every one of our members are extremely grateful for the support and sacrifice that is made by each and every one of our families to allow us to participate in this role and be involved in public service. As the one who is making the remarks, I get to point out to my wife, Joy, and to thank her – Joy, if you'd please stand. I met her in 1984, two years into my Kaua'i County Council career, and last November, we celebrated our twenty-eighth anniversary. I appreciate the sacrifice that she has made, the job that she has done in helping raise our two sons, and the support she has given me to continue to do this job. And she is like each and every one of the family members who stand behind the other 24 senators who are here.

"If you look, as you came into the gallery, you've been handed a small sheet, if you wanted to take it, and on that sheet is the statement from the Majority of the Senate. If you were up early like I was and saw the Majority Leader on Hawaii News Now, he explained clearly that we were asked to give overarching goals and themes, and so this is a general statement of where we'd like to go. We are still in the process of having bills introduced, and the specifics as to how we are going to achieve these goals will be forthcoming in the next few days.

"And I guess what I need to say so that we can get the focus back on the work at hand: When you heard Pastor Higa ask for some prayers for Senator Kahele - if you're wondering why he's excused today, he checked in on Monday to Queen's Hospital, where he's been undergoing some tests. He was optimistic that he'd be here with us this morning, but they have asked him to stay there so they can continue to conduct some tests. We just issued, before the opening gavel, a statement from his family, where they thank you for your kind thoughts and prayers, but also at this time, that you respect the family's privacy. So until we have any further information from the family, that's the comment we have. I can tell you that I spoke to him yesterday and I spoke to him this morning; he is in good spirits, and he, as an ex-Marine, is a fighter and ready to go, and I feel sorry for the doctor who's trying to keep him in the hospital.

"We celebrate on Kaua'i, and I believe statewide, during the month of December, Rizal Day. One of the famous quotes from Dr. Rizal is, 'If we do not know where we came from, how can we know where we're going?' And with that, I'd like to acknowledge the work of the Senate President Emeritus, Senator Kim, and her leadership for the past three sessions as President and where she has gotten the Senate and has set us on a great course. And now it is our job to continue to make progress and better the work that has been done, so I'd like to extend my thanks to Senate President Emeritus Donna Kim.

"I know that the local media has done some polling about what the people of Hawai'i believe are the top issues that are facing us, and before I get to that, I wanted to say, along the lines of Pastor Matt Higa, seeing heart to heart. It has been troubling to me that, in the public meetings that have been occurring from Kaua'i to the Big Island, the public discourse has not been civil and we've not been communicating heart to heart. And people seem to think that we need to yell and scream louder than the other person, that by name-calling and putting someone down, we can be successful.

"As I thought about what to say this morning, I looked at Senator Harimoto, and, quite frankly, when I first met him, he impressed me as the kind of guy I would've taken lunch money from when we were in high school. Then, he told us in the

summer he was diagnosed with cancer and what he was going to have to undergo; and when you see the quiet dignity, the strength, and the courage that he has exhibited given the conditions that he has been faced with, I found out just how strong he is, and realized I never would've gotten his lunch money from him. But it also tells me - and I hope it tells the rest of us – that if we can conduct ourselves with the dignity, the humility, and the strength that has been exhibited by Senator Harimoto as he has been fighting his battle with cancer, then we can achieve the kind of heart-to-heart and civil discourse that we all aspire to in how we run the people's business here in Hawai'i.

"The function of the democracy is to embrace dissent and minority opinion, to ensure that someone who has a differing opinion is not afraid to come forward and express those points of view. But at the end of the day, the primary function of the democracy is that the majority must carry the day and move forward, and so let us hope, as we go forward in the 2016 session, we will be able to achieve those goals.

"I didn't see on the top three priorities in the polling about healthcare, and I would be remiss representing the neighbor islands if I didn't say one of the most important issues facing us is how we will continue to deliver quality healthcare to the rural communities that we serve in an affordable way, and so I would add that.

"And I would now simply go through the list that I saw in the press. The third priority, rail: The Senate is not anticipating taking up any other rail bill other than to make sure that the opportunities that present itself through the transit-oriented development ensure that we have affordable housing for residents and all ranges of our residents, that the opportunities are there – not only for economic development and high-end housing and opportunities, but for each and every one of our citizens.

"They talk about economy and the cost of living and jobs. We have committed funds to diversify the economy, to support high technology and reinvestment there, but with the news of Maui closing HC&S - and to deal with the loss of over 600, almost 700 jobs on Maui - what will really be our measure is how do we see the opportunities that are presented to us. We've been working for several years with Jimmy Nakatani and the Agribusiness Development Corporation in trying to get a biodigestor sited; it would have biofuels and, with the correct additives, he had hoped to produce hog feed at 50 percent of the cost that we are now paying for hog feed and support our local farmers. We've got a great opportunity to look at those kinds of crops to go into the fields in Maui. The biodigestors create energy; they create natural gas that can fuel vehicles, and it can go a long way toward helping us realize the 100 percent sustainable goal that we have. And so these are the kinds of things that are important for us as far as looking for the opportunities that we have, not being stymied by what we think are disasters, and being able to push forward with positive results.

"Clearly, in the last six months, the homelessness issue has dominated the media. But more importantly, I know Chair Tokuda is going to be coming out soon with a comprehensive package, because homelessness is also about the delivery of social services and those who are impacted and getting the correct help so that you're not in a homeless situation. It also entails having the shelters, but more importantly, once we have the shelters and transitional programs, there has to be somewhere for them to go; and so we need to develop the affordable rental units and the affordable sale units and we're going to work to make sure we identify projects on each and every island. The problem isn't just here on O'ahu; the problem is statewide, and we need to look at it in that particular fashion if we're going to wind up addressing it.

"The biggest problem that I have with homelessness is that they say, 'But we don't want those kinds of people here with us.' My family never owned a home as I was growing up; we were renters. My parents divorced, and the summer before my junior year in high school, my mother, as a single mother with three children, bought our first house. Nine hundred sixty square feet, nothing fancy, but it was ours. And I still remember to this day the feeling that I had when we walked in that home. And it was a federal program, so the mortgage was based on the salary that my mother made, so that we could afford to have a home. And then she put, eventually, a chain-link fence around it, extended a patio, put way too many plants - in my opinion in her vard, and certainly created a home. And with her love and support and the support of my father, myself, my brother, and my sister were able to go to college to achieve the things that we have today. When I've looked at President Emeritus' story that she has been telling us, the same humble beginnings from Kalihi, I realize that the majority of the body here were those kinds of people. And those kinds of people are really good, really smart. Those people are people who care tremendously about this great state, and if given the opportunity, given the support, they will make Hawai'i the greatest place on earth.

"And so it's with that commitment that I say: Let's get started. I look forward to working with each and every one of you to achieve success for the Senate and for the State of Hawai'i. Thank you."

At this time, the Chair called on Majority Leader J. Kalani English.

Senator English rose to deliver the following remarks:

"Thank you, Mr. President. Good morning, members of the Senate.

"Mr. President, I'm pleased to present the 2016 Senate Majority Legislative Program, and I'd like to ask that this get inserted into the Journal. I'll also very quickly go over the four overarching themes. As you know, the Majority members met; I'd asked everyone to give us their overarching themes. We discussed this and came up with this consensus document.

"But in general, Mr. President, we're talking about Mālama 'Ohana as providing for our families, including the housing issues that you're talking about and a number of other issues.

"We're looking at Mālama Honua, which is nurturing the earth: again, food security, energy security, and these types of issues and concerns.

"Mālama Kaiāulu, sustaining our communities: taking care of our kūpuna, our children, looking at long-term care, looking at healthcare – these issues that we all will face at some point in our lives.

"And finally, Mālama Aupuni, good governance: Quite simply put, transparency and openness. I'd like to point out, members, that we will be broadcasting all of our Senate proceedings and House proceedings live in real time from every conference room, so people will watch as the hearings are being conducted, and this should go out statewide, so this is a huge step forward for transparency. I believe that starts on the 26th of this month.

"So I wanted to go over this very briefly; for members of the public, you can find this document at hawaiisenatemajority.com. Many of our senators have taken this and used this as a template to introduce bills, so you'll see many bills reflecting these values, and we think that this approach is one that will allow for the most collaboration and flexibility for the public and the senators to be creative and innovative in how we tackle the problems facing us today. Thank you, Mr. President."

The Chair having so ordered, the Senate Majority Program is identified as "<u>ATTACHMENT A</u>" to the Journal of this day.

At this time, the Chair called on Minority Leader Sam Slom.

Senator Slom rose to deliver the following remarks:

"Thank you, Mr. President, and aloha, everyone. Mr. President, thank you for your poignant and candid remarks. We'd also like to acknowledge and thank our many men and women of the armed forces – and particularly, our hearts go out for our 12 missing Marines and for our colleague, Senator Kahele: always a Marine, never an ex-Marine. Our distinguished guests, the overburdened taxpayers of Hawai'i, on behalf of the entire Senate Minority, I wish you aloha.

"And now, for the rest of the story.

"Looking around, Mr. President, I am saddened that we didn't allow more people to join us in our opening every year; no amount of public celebration should reduce our resolve to work on this day. But this recent biennium tradition of curtailing festivities in the even year limits the number of taxpayers from being with us in the people's capitol. And I hope we eliminate this tradition in the near future.

"So what should be the goal for the election-year 2016 legislative session? The Senate Minority's point of view can be summed up in a single word: **accountability**. The Legislature must be more accountable for unfulfilled promises, wasted tax money, poorly written contracts, and unenforceable legislation. The Legislature is accountable for failing to penalize poor performance by government and/or excusing individual bad or corrupt behavior.

"We are honored to represent the people of Hawai'i and to be part of the state Senate and to earn your trust and respect, but we must do a better job of oversight, especially fiscal oversight. Billions of taxpayer dollars have been wasted on our watch because we haven't held government agencies accountable for delays, waste, and mismanagement.

"Our \$28 billion biennial operating budget is bloated and in deficit. So, too, is our \$15 billion share of the \$28 billion unfunded liability. The Senate Minority sponsors the Hawaii Open Budget so you can see the budgets for yourself. We also sponsor an annual Alternative Operating Budget: our suggestions on how to trim the fat, pay down the debt, and restore the fiscal health of our government.

"While we *talk* of change, we don't seem to change. Problems of a decade ago – or even longer – still are problems today: back-breaking taxes, homelessness, the high cost of living, diminishing economic diversity, replacing our aging infrastructure, and cooling our classrooms, among others.

"We seem to be out of touch with reality, making it increasingly difficult to speak out against the cause of problems in Hawai'i and to call for change. Yet this must be done. How? Simply stated, we must do a much better job not of making new promises, but of making good on old ones.

"Our job is to restore and encourage the public's confidence in our process, and to be more transparent and accountable ourselves while empowering our citizens. We have to do more than simply make speeches; we need appropriate action. We *can* do this; we *must* do this.

"The public feels disconnected because we haven't done the best that we can do.

"Your Senate Minority continues to believe that Hawai'i's economy has *not* turned around despite selected employment and tax data, and that too many of our citizens and small businesses continue to struggle needlessly. "Hawai'i is perceived as being hostile to business. We do have a state agency, the Department of Business and Economic Development, but now it's operating as the Department of Business, Economic Development, Tourism, Housing, Energy, Aerospace, Film, Art, Loans, and Climate Change. There is no focused business advocate in our state government.

"How many promises have already been broken, and are yet to be broken, on the off-schedule, off-budget, originally \$2.7 billion (and now nearly \$7 billion) O'ahu rail transit boondoggle? The Legislature made this never-ending drain on taxes possible and is an enabler to the biggest and worst public project in Hawai'i's history. There is no accountability, while roads, sewers, and water delivery continue to break down.

"The Public Utilities Commission will shortly rule on the \$4.3 billion takeover of Hawaiian Electric by Florida-based NextEra. As hard as we try, Mr. President, we cannot find significant benefits for Hawai'i ratepayers from this action, just more non-competitive monopoly.

"As we have said in the past, the Hawai'i Health Connector wasted more than \$150 million without improving healthcare. We can do better. Millions more are now being spent on the ended Health Connector in transition, but it should receive no more state taxpayer funds.

"And we must continue to be compassionate, but not foolish, in helping the truly needy while dealing firmly with those who prey on others and game the system. Stopping fraud is the key to this.

"We must increase our local residents' standard of living by reducing their burdensome costs. We begin by eliminating the GET on food and medicine.

"And we must promise no new taxes! We need to call for federal affordable cargo reform of the Jones Act, joining with like-minded legislators in Alaska, Guam, and Puerto Rico.

"Your Senate Minority offers a thoughtful, effective fivepoint Action Agenda for 2016, including accountability for millions of dollars the state intends to spend on technology upgrades and modernization.

"So, Mr. President, on behalf of the Senate Minority, I pledge continued efforts to support good legislation, regardless of who introduces it; to examine and report honestly on the financial and policy impacts of all bills; and to work toward ending legislative exemptions for ourselves on laws that we pass on to others.

"We celebrate our God-given liberty and our ability to change. We seek a '**Better Day**.' And working for a brighter, better future for Hawai'i is not a partisan issue. Together, we must navigate a smarter course with a vision of how much greater Hawai'i can be.

"God bless Hawai'i, our armed forces, and the United States of America. Aloha!"

We will support efforts that prioritize the empowerment of homeless individuals through social services that specialize in mental health, employment, housing, and other critical needs. Education - We will support ways to make education accessible for our keiki from pre-school through higher education. We will explore alternatives that facilitate and enthuse our public high school students to enroll in college.

Mālama Honua (Nurturing the Earth)

The Democratic Majority of the Senate will aim to set specific benchmarks for satisfactory levels of local food production and consumption. We will also ensure that Hawai'i is well-prepared for any disaster, economic disruption, or other external factor by encouraging the production and consumption of locally grown and locally raised food through good agricultural practices and support of local farmers.

Ensuring a sustainable future for Hawai'i will continue to be a priority. Improving energy resiliency and continuing progress in food self-sufficiency will have positive effects on our local job market and economy.

We will continue to focus on renewable energy alternatives that are practical and economical and take into account Hawai'i's unique geographical and topographical characteristics and environment. As Hawai'i makes progress in this area and with our overall clean energy goals in mind, we will further encourage the availability of renewable energy, facilitate processes for the development of renewable energy, and advance projects to improve energy efficiencies.

Mālama Kaiāulu (Sustaining our Communities)

We will strengthen our social safety net to ensure that our keiki, kūpuna, and family care givers are healthy, safe, and supported, while continuing to use the community development process to address housing, agricultural, environmental, and health concerns that arise during proposed development. We believe that relying on smart growth principles will lead to development that balances competing interests for land and maximizes the use or preservation of various types of land.

We will further explore opportunities to protect Hawai'i's natural resources through preservation and protective measures, such as improving agricultural practices, mitigating climate change impacts, and alleviating zoning concerns. Hawai'i's unique geographical features, including coastline, volcanoes, and watersheds, open doors to innovative processes and procedures, as well as new technologies and applications to existing systems, to accommodate Hawai'i residents.

We will focus on efforts to create a holistic overview and understanding for community development in the State, such as transit-oriented development. We will support efforts to enhance the provision of safe, fair, and effective government services. We will work toward greater efficiency, security, and accountability for government leaders and also for those serving to protect Hawai'i residents.



We will encourage effectiveness, transparency, and accountability across all branches of government by insisting on high standards of conduct, proper training, and fair and reliable systems and procedures.

The Democratic Majority of the Senate will strive to infuse the Hawaiian culture throughout government by fostering the use of the Hawaiian language on certain government documents and records.

We will strengthen and protect government infrastructure by upgrading technology and services to meet the demand of Hawai'i's residents and visitors. We will continue to promote the enhancement of the State's information technology services and incentivize the use of technology to potentially create revenue streams. We will continue to focus on the establishment and expansion of the State's critical technology infrastructure, including broadband.
