At this time, Senator Baker rose to speak on a point of personal privilege as follows:

"I was remiss in not calling to the attention of this body on Friday, the day the President of the United States signed the Child Nicotine Poisoning Prevention Act of 2015. This measure requires the Consumer Product Safety Commission to set standards for packaging so that no one under five years of age is able to open or obtain harmful contents from e-liquid, e-cigarette liquid. So this is certainly a step in the right direction for the Congress to take and the President to sign it into law. It does not - as I understand it, and we're doing some more research - actually require warning labels, which we have measures introduced in both the House and the Senate to do. But I wanted to bring this to your attention because the feds are finally moving in this arena and to thank you for all of your support for these measures in the past. Mahalo."

Senator Espero rose to speak on a point of personal privilege as follows:

"Thank you. I just sent you an email from the Honolulu Police Department and their annual misconduct report, and I just wanted to briefly, so you can see what this looks like: In 2010, according to the reports I have, zero officers were fired; 2011, five were fired; 2012, one was fired; 2013, six were fired; and in 2014, eight were fired. That's 20 officers in the last 5 years. In 2015, 23 police officers were fired.

"So, I think this is an area that we need to continue looking at. I know our Women's Caucus has introduced some bills in the past; there's a slew of other law enforcement and police reforms, but this is certainly quite alarming when you look at the numbers and when you look at what's happening nationally as well as locally. This is certainly something that we need to be on top of; we've had some legislation in the past and, hopefully, we'll be able to look at some others this year. Thank you."

Senator English rose to speak on a point of personal privilege as follows:

"Members, tomorrow we'll be paying our final farewell to Senator Kahele as his motorcade passes the Capitol. Please assemble in front of the Father Damien statue at 9:00 a.m. The motorcade will come by and stop in the front for about five minutes and then continue to Hickam Air Force Base. Thank you."
