The Senate of the Twenty-Eighth Legislature of the State of Hawai'i, Regular Session of 2016, convened at 11:36 a.m. with the President in the Chair.

The Roll was called showing all Senators present with the exception of Senator Ruderman who was excused.

The President announced that he had read and approved the Journal of the Twelfth Day.

STANDING COMMITTEE REPORTS

Senator Keith-Agaran, for the Committee on Judiciary and Labor, presented a report (Stand. Com. Rep. No. 2077) recommending that S.B. No. 2314, as amended in S.D. 1, pass Second Reading and be placed on the calendar for Third Reading.

On motion by Senator Green, seconded by Senator Slom and carried, the report of the Committee was adopted and S.B. No. 2314, S.D. 1, entitled: "A BILL FOR AN ACT RELATING TO THE OFFENSE OF ABUSE OF FAMILY OR HOUSEHOLD MEMBERS," passed Second Reading and was placed on the calendar for Third Reading on Thursday, February 11, 2016.

I want to take this opportunity to thank each and every one of the members of the Senate, and the staff members in your offices, that helped with all of the arrangements – the ceremony and the events that we had to put together over the last two weeks; all of our support staff, for their support and efforts; the governor and lieutenant governor and the administration, for their assistance; and all of the private sector people who came forward to assist us in our expression of mourning for the loss of Senator Kahele. No matter how big or small your contribution was, we could not have honored him in such a tasteful way without the contributions of each and every one of you. So, I want to express my thanks for that."
