At this time, Senator Galuteria rose to speak on a point of personal privilege as follows:

"Mahalo, Mr. President. I'd like to acknowledge the loss last Friday of Dr. Richard Kekuni Akana Blaisdell, a pioneering advocate for Native Hawaiians and a champion for access to health care for all. He was 90 years old. Kekuni graduated from the Kamehameha Schools and got a medical degree from the University of Chicago School of Medicine in 1948. He did his residencies at Tulane, Duke, and the University of Chicago hospitals.

"Dr. Blaisdell was instrumental in starting the University of Hawai'i School of Medicine and was the inaugural chairman of the then-Department of Medicine at the University of Hawai'i at Mānoa in 1966. He was the first Native Hawaiian in the nation elevated to the chairman of a medical school.

"Kekuni authored a critical health report for the Congressional Native Hawaiians Studies Commission in 1983. He testified for the Native Hawaiian Health Bill before Congress in '86, '87, and '88, and it was in October of '88 that the bill was passed, establishing five Native Hawaiian Health Care Systems on five islands.

"Kekuni also served as interim director of the Center for Hawaiian Studies at UH Mānoa in '87 and '88. And in 1990, Dr. Blaisdell was named a Living Treasure of Hawai'i by the Honpa Hongwanji Mission of Hawaii.

"So, colleagues, let us bid aloha to another great Hawaiian, knowing that perhaps the doctor serving you today may have been impacted by Dr. Blaisdell. Thank you."

The Chair then remarked:

"As I made no reference to the score of that game more than four decades ago, I'm sure you figured out who won the contest."
