S.B. No. 2418:

Senator Keith-Agaran moved that S.B. No. 2418, having been read throughout, pass Third Reading, seconded by Senator Shimabukuro.

Senator Thielen rose to speak in support of the measure with reservations as follows:

"Thank you, Mr. President. I'm going to follow a couple of my peers from the other day and say I rise with conflict on this bill. I had voted 'no' in the Judiciary committee. As many of you may know, I'm a co-sponsor of a bill that would allow initiative – for citizens to be able to put questions on the ballot – not to change the constitution, but to change the law. And so it seems odd that I had voted 'no' on putting this question on the ballot, but the bill that we had put forward required a certain minimum number of signatures in order to get something onto the ballot, and I think that that still is a good requirement.

"When I voted 'no' in Judiciary committee, it was because we did not see any support for the measure – I think we got one testimony in support, but a lot of testimony in opposition, and so I felt that it hadn't made that threshold. I do note, though, that the amount of testimony we got in opposition was very small in comparison to the other proposed constitutional amendments in front of us that day; and so in going back and looking at that and seeing the late testimony in support, the question I'm wrestling with is whether it's appropriate to put this on the ballot for voters to vote on.

"So, at this point, I'm going to move my vote to 'with reservations' as opposed to a 'no.' I think there are still very many good reasons not to put an elected attorney general

forward, but at this point, I support moving the question forward for more discussion in the Legislature. Thank you."

Senator Slom rose to speak in opposition to the measure as follows:

"Yes, Mr. President. Of course, I rise with a position of 'no.' I've been introducing initiative bills for 20 years now. I believe in initiative; I believe in the people having the right to vote and to initiate legislation. I also had been a strong supporter of electing the attorney general over the years and also had introduced legislation, but in looking over some of the events of the past several years and some of the issues that we have, I just wanted to register my personal opposition to the premise of electing the attorney general.

"Just like when we had the discussion with the school board, and we went from elected school board to appointed school board, people thought that there was going to be a panacea, that there was going to be great changes. And in fact, there have not been; there've been very few changes, and some people are just as upset or more so with the appointed school board. There's no panacea, I believe, in this particular issue of elected versus appointed.

"I think the real problem is that too many of the public believe that the attorney general – whether he or she be elected or appointed – is the attorney for the people, that the attorney represents the people, rather than the attorney representing the state government and elected officials. And I think, more so than the question of election or appointment, I think that's what we really need to look at and concentrate on.

"There have been instances in the past where the issue of independence – could an appointed attorney general really be independent of the governor who appointed that person stand? And I think there are arguments on both sides. But I don't think that the simple act of electing will erase that; as I say, I think it's more of the real cause of the problems. But I certainly believe that the public should have the right; we should have more questions. I believe in not only initiative, but, as you know, referendum, recall, and term limits. So, I'm just registering this as my opinion on this particular issue. Thank you."
