Thursday, March 3, 2016

The Senate of the Twenty-Eighth Legislature of the State of Hawai'i, Regular Session of 2016, convened at 11:36 a.m. with the President in the Chair.

The Roll was called showing all Senators present with the exception of Senators English and Nishihara who were excused.

The President announced that he had read and approved the Journal of the Twenty-Second Day.

At this time, Senator Gabbard welcomed a group of 23 cadets of the Bravo Class from the Hawaii Youth Challenge Academy in Kalaeloa, who were seated in the gallery with their lead instructor, Sina Atanoa, and their teacher of government and law, Damien Miller. Senator Gabbard noted that the five-and-a-half month program instills discipline and a sense of self-worth by using military training to improve the life skills and employment potential of at-risk students ages 16 to 19, and remarked that he wished the program had existed in the 1960s when he was a rebellious young man.

We had a Prepaid Health Care Act; it did not add costs or bureaucracy – it worked fine since 1974. We were derelict in not getting this innovation, the exemption, from the beginning. And I'm only hoping now that everything will line up and we'll be allowed to go back to our previous Act. Thank you."

Senator Baker rose to speak in strong support of the measure as follows:

"Thank you. Unfortunately, the previous speaker is in error. This is the first time we were able to go in to get such an innovation waiver; the Act called for them not to be granted until '17, and so this is very timely. It will continue the current

practice of allowing small businesses to enroll their employees in a health insurance plan directly with the plan without creating a SHOP exchange. When we had a functioning health connector, we were able to get an exemption for creating a SHOP exchange. Thus we have been able to allow health insurance enrollment for small business employees directly with qualified plans. Authorizing this waiver is the first step to securing this innovation waiver to ensure that we'll be able to continue with our current practice which protects the Prepaid Healthcare Act. Although I had hoped for a larger waiver, based on the information we received from CMS at the federal level, Hawaii's waiver will be looked on very favorably. Something larger might have created additional problems. Passing legislation supporting submission of the Innovation Waiver is critical going forward. Thank you, Mr. President."
