TWENTY-SIXTH DAY

Thursday, March 10, 2016

The Senate of the Twenty-Eighth Legislature of the State of Hawai'i, Regular Session of 2016, convened at 11:57 a.m. with the President in the Chair.

The Roll was called showing all Senators present with the exception of Senators Riviere and Thielen who were excused.

The President announced that he had read and approved the Journal of the Twenty-Fifth Day.

At this time, Senator Baker introduced Aileen Wada, gubernatorial nominee to the Real Estate Commission, who was present in the gallery.

Senator Kahele welcomed the following visitors from the Lyman House Memorial Museum in Hilo, who were seated in the gallery: former State Senator Richard Henderson, chairman of the board; Director Barbara Moir; and Trustee Gerald DeMello

Senator Espero acknowledged the presence of Chief Justice Mark E. Recktenwald of the Supreme Court, State of Hawai'i, and Rod Maile, administrative director of the courts, in the gallery.

Senator Kahele honored Barry K. Taniguchi for his outstanding and dedicated service to the people of Hawai'i, and presented the following remarks:

"Mahalo Mr. President. Colleagues, why does this chamber pause every so often to acknowledge and honor special efforts by special people? Why do we take the time to present awards or recognize significant milestones in people's lives? After all, if we didn't, life would go on without special occasions. This chamber would go on. We'd still get up in the morning; we'd go to work; we'd care for our kids; they'd go to school, grow up, get their own jobs (hopefully!), maybe have a family of their own. Life has a strange way of doing its own thing.

"We honor special individuals because it's our way – the Senate's way – to say thank you, mahalo nui loa, to someone whose contributions to our island state have made a difference in the lives of so many.

"The late Senator Gilbert Kahele, my father, would often say: 'It's not what we receive that enriches our lives; it's what we give.' The gentleman from Hawai'i island I am about to introduce to this chamber embodies just that. Throughout his life, he has given his heart and soul to his family, his community, his island, and this state.

"Born in Hilo, Hawai'i, Barry Taniguchi is a product of our public education system. He attended Hilo Union, Hilo Intermediate, and graduated from Hilo High School. He attended the University of Hawai'i at Hilo and graduated with a Bachelor of Business Administration degree and a major in accounting from the University of Hawai'i at Mānoa.

"After graduating from UH Mānoa, Barry was employed by Haskins & Sells, CPAs – predecessor of the current Deloitte & Touche – and, in 1971, became a certified public accountant. He worked for the Realty Investment Company as controller and returned to the family business, KTA Super Stores, in 1983. In 1989, due to an illness by his uncle – the current CEO at the time – and at just 42 years old, he assumed the office of president and chief executive officer. Under his leadership and through the economic recession of the 1990s, the family business grew from four stores to six stores throughout the island of Hawai'i.

"Dedicated to carrying on the traditions of his grandparents, Koichi and Taniyo Taniguchi, who started the family business in 1916, Barry Taniguchi believes that a strong community is important to families and business. Thus his involvement with many community and nonprofit organizations, including but not limited to, the Hawai'i Community Foundation, the Aloha Council, the Boy Scouts of America, Hawai'i Island Economic Development Board, Hilo Boarding School, Hilo High School Foundation, Waiākea High School Foundation, Lyman House Memorial Museum, Pacific Tsunami Museum, Public Schools of Hawai'i Foundation, Chamber of Commerce of Hawai'i, Better Business Bureau, Boys and Girls Club of Hilo, The Food Basket, Hawai'i Community Health Services, Hospice of Hilo, Aloha United Way Statewide and Hawai'i Island Association, University of Hawai'i at Hilo Chancellor's Advisory Committee, University of Hawai'i Foundation, University of Hawai'i Alumni Association, Crown Prince Akihito Scholarship Association and Foundation, Mauna Kea Management Board, the Queen's Health System Board, Queen Emma Foundation Board, and, finally, the Honpa Hongwanji Mission of Hawai'i.

"Mr. Taniguchi presently sits on the following boards of Hawaiian Electric Industries, American Savings Bank, Hawaiian Electric Company, Hawai'i Employers Mutual Insurance Company, and Valley Isle Produce.

"Mr. Taniguchi's dedication and commitment to the community is honored in the various awards and recognitions. He was inducted into the Junior Achievement of Hawai'i's 2010 Business Hall of Fame; the Hawai'i Society of CPAs' 2005 Business and Industry Hall of Fame; the University of Hawai'i, College of Business Administration's 2004 Hall of Honor; the Hawaii Island Chamber of Commerce Humanitarian of the Year; the University of Hawai'i Alumni Association's Outstanding Alumnus; and the Hilo High School Foundation Alumnus of the Year.

"Colleagues, it's obvious that Barry Taniguchi is an outstanding civic leader, but behind all of that is also a devoted family man, married to his lovely wife, Sandra Taniguchi, and together they have five children, four grandsons, and two granddaughters. Mr. President, with your permission, I yield my time to my fellow colleague from the Moku O Keawe, Senator Inouye."

Senator Inouye rose to present the following remarks:

"Thank you, Mr. President, and good morning. With Barry this morning in the chamber is his eldest son, Toby Taniguchi. Toby is currently the president and chief operating officer of KTA Super Stores. He has worked in the family business for over 20 years in his current position and has worked in every position in the store to learn the family business. He graduated from the University of Portland and lives in my district of Waimea on Hawaiian Homelands.

"He actively is involved in the community, working with The Food Basket, Boys and Girls Club of the Big Island, Pacific Century Fellows, Hawai'i Employers Council, Hawai'i Island Chamber of Commerce, and the Japanese Chamber of Commerce and Industry of Hawai'i. The apple does not fall far from the tree.

"In my lifetime, I have known Toby's grandfather; his uncle Tony; and, of course, his dad, Barry, and so proud to be able to see – I think it's the fifth generation, but fourth generation for my meeting the family and the current president of KTA Stores. And let me say, Mr. President and colleagues, KTA Stores is celebrating its 100th anniversary this year.

"Mr. President, with your permission, I yield my time to my fellow colleague, the senator from District 15, for the introduction of our final guest – Senator Glenn Wakai."

Senator Wakai rose to present the following remarks:

"Thank you, Mr. President. A special lady rounds out this legendary family. On the floor sitting next to her brother and father, we have Amanda Taniguchi. Amanda graduated from the University of Puget Sound and is currently living on O'ahu. She works at David Yurman, a newly opened jewelry store in the new section of Ala Moana Center. Mr. President, I yield my time back to my fellow colleague from the Big Island of Hawai'i."

Senator Kahele continued:

"This year KTA Super Stores is celebrating a century, colleagues - 100 years - of serving the Hawai'i island community.

"With \$49 in his pocket and the pursuit of the American Dream, a young Koichi Taniguchi left Japan on his way to California in 1907. The ship he was on would stop here in Honolulu and, as chance would have it, Koichi decided to stay. Starting a new life in the young Territory of Hawai'i, Koichi would send for his future wife, Taniyo, to join him in the islands, and together they moved to Hilo and in 1916 founded K. Taniguchi Shoten, or 'store.' His shipments of goods at the time, most of which came from Japan, were marked with the initials 'KT,' but there was another KT store in Hilo. And as a result, all the shipments would get mixed up on the Hilo dock. So, to remedy this problem, Koichi added an 'A' to the 'KT' initials. Contrary to what most people think, the 'A' in KTA does not stand for 'Associates,' but as a way to differentiate it from the other KT store during that time. From those humble mom-and-pop beginnings, the modern six-location supermarket business now employs 800 associates at six stores on Hawai'i

"KTA has established many firsts in Hawai'i's grocery industry over the years. In 1977, at its flagship Puainako store, it expanded the first 'superstore' in the state to include the first in-store bakery; the first to install UPC bar code scanners at all checkouts; the first to install and operate energy-saving photovoltaic systems at its Waimea and Kailua-Kona stores. KTA debuted its private-label Mountain Apple brand in 1994 as a way to promote products grown or made in Hawai'i, and it also launched its own TV show, *Living in Paradise*, in 2000.

"Hawai'i doesn't have many businesses that have hit the 100-year, century mark. So far, prioritizing its core market on Hawai'i Island has been working for the Taniguchi family business. It is a reflection of the founders' century-old philosophy, reflecting a commitment to humbly serve the people of their community. An example of this was a conversation I had just yesterday with Barry's son, Toby, when he mentioned that they were very proud to have recently opened a pharmacy at the remote Waikoloa Village Market location. After hearing that, my first response was, 'That's fantastic; it must be very profitable!' Toby would then say, 'Actually, Senator, it's not profitable, and we barely break even on the pharmacy, but that's not why we opened it. We opened the pharmacy because the Waikoloa community needed it, and it was the right thing to do.'

"In the Japanese culture and language, there is a phrase, 'Okage sama de,' which means, 'I am what I am because of you.' It is a humble phrase that is meant to convey that gratitude goes outward. The Senate of the Twenty-Eighth Legislature of the State of Hawai'i, Regular Session of 2016, hereby expresses its heartfelt mahalo to Barry Taniguchi and his family for his faithful service, dedication, and commitment to Hawai'i. The Hawai'i State Senate expresses its warmest aloha, best wishes

for their continued success, and, Barry, on behalf of the State of Hawai'i, Okage sama de. My most honorable colleagues, please join me to honor and welcome Mr. Barry Taniguchi, his daughter, Amanda Taniguchi, and his son, Toby Taniguchi.

"Mr. President, I humbly request a recess at the appropriate time to honor and congratulate our distinguished guests. Mahalo."

At 12:11 p.m., the Senate stood in recess subject to the call of the Chair.
