TWENTY-SEVENTH DAY

Friday, March 11, 2016

The Senate of the Twenty-Eighth Legislature of the State of Hawai'i, Regular Session of 2016, convened at 11:38 a.m. with the President in the Chair.

The Roll was called showing all Senators present with the exception of Senators Galuteria, Ihara, Riviere, and Thielen who were excused.

The President announced that he had read and approved the Journal of the Twenty-Sixth Day.

At this time, Senator Slom welcomed a group of fifth-grade students from Mayor John H. Wilson Elementary School, who were seated in the gallery with teachers Roxanne Yi and Max Kaneshiro and chaperones Marissa Faleolo and Susan Amine.

Senator Kidani introduced the following visitors from the HCAP Head Start program who were present in the gallery: Hawai'i Head Start Director Lynn Cabato; Head Start Hawai'i Policy Council Chair Trisha Hornback, from the Kahalu'u Head Start program; Policy Council Secretary Rayna Duenas, from Puohala Head Start; and other program leaders, parents, and family advocates. Senator Kidani noted that the federallyfunded program, which celebrated its fiftieth anniversary last year, is the largest early childhood program in the state, serving more than 1,600 children and their families each year. The HCAP Head Start supporters were visiting the State Capitol to distribute materials that substantiate the case for state support for early learning programs, emphasizing that their work supports the work of the Executive Office on Early Learning to provide more families with access to quality pre-K opportunities. Senator Kidani remarked that she had a soft spot in her heart for HCAP, having served as a member of the Board of Directors for several years beginning in 2000, and reiterated her continuing support for early childhood education.

Senator Slom honored Ka Iwi Coalition for its outstanding commitment to preserving Hawai'i's natural resources, and presented the following remarks:

"Thank you, Mr. President. Today, we have the distinct pleasure of honoring a unique group of individuals within our community. We're always talking about public-private partnerships; we're always talking about people getting together to do things. Well, this group of people has done just that. On behalf of my colleague, Senator Thielen, who could not be here today, we would like to honor the Ka Iwi Coast Coalition. This is a group of individuals who have been working tirelessly – actually, some of them for decades – to save and preserve one of the most pristine parts of our coastline, not just for the people of East Honolulu, not just for the people of the State of Hawai'i, but for all of our visitors and guests who come to Hawai'i and want to see the true Hawai'i.

"The efforts to save Ka Iwi go back to 1983, when, at that time, there was a plan to develop hotels and resort development. And in 1983, citizens got together to protect that Ka Iwi coastline. In 1988, the State Legislature passed a resolution asking the Department of Land and Natural Resources to develop a park plan for the Ka Iwi coast; and 10 years later, the state purchased 305 acres to develop the park. But in 2010, a developer purchased two parcels of 182 acres to ostensibly develop a golf academy and some other resort development. So, the Ka Iwi Coalition was formed to save Ka Iwi coast. It was part of Livable Hawai'i Kai Hui, and they've done something that nobody else has done: Not only have they saved the area, but they've helped raise private money to purchase the area, and then they went a step further. They're going to own and operate that parcel to make sure that it's done right.

"So, today, Mr. President, we honor these selfless individuals who have done so much, and I'm very proud to introduce them and ask if they would please stand and be recognized, starting with members of the Ka Iwi Coalition: Phil Esterman; Bob Retherford; Lea Retherford, who's representing her mom Ursula, who we all know and love; Levani Lipton; and Elizabeth Reilly, of not only the Ka Iwi Coalition but Livable Hawai'i Kai Hui; and representing the Trust for Public Land, Laura Kaakua. Thank you for everything you've done."

At 11:46 a.m., the Senate stood in recess subject to the call of the Chair.
