### TWENTY-EIGHTH DAY

### Monday, March 14, 2016

The Senate of the Twenty-Eighth Legislature of the State of Hawai'i, Regular Session of 2016, convened at 11:39 a.m. with the Vice President in the Chair.

The Roll was called showing all Senators present with the exception of Senators Chun Oakland, English, Harimoto, and Kouchi who were excused.

The Vice President announced that he had read and approved the Journal of the Twenty-Seventh Day.

At this time, Senator Baker introduced several gubernatorial nominees to boards and commissions who were present in the gallery: Tina Takashy, nominee to the Language Access Advisory Council; and Edna Kaahaaina and Michelle Pestel-Maga, nominees to the State Council on Developmental Disabilities.

Senator Slom honored Richard Lowe for his visionary contributions to the people of Hawai'i and the Hawai'i State Capitol, and presented the following remarks:

"Thank you, Mr. President and colleagues. Seated on the Senate floor today, we have someone really interesting and really special, and there are so many people that you know them for one career but you don't know them for many of the other things that they have done. We are today celebrating the life of a visionary in Hawai'i, someone who was born in California on a farm. His mother was an organist for a major church, and he started playing the piano at the age of five. He moved to Hawai'i in 1964, and he became a part of the design team for the Hawai'i Civic Center, of which we are a part.

"I neglected to mention that he had gotten his master's degree at MIT, and he was well-involved with a number of primary architectural projects and development here in Hawai'i. For example, he was involved with the Victoria Ward master plan, which is 63 acres. He also was with the real estate brokerage firm of Earl Thacker for 25 years. In 2010, he founded his own brokerage, but along the way, he got involved in master planning, and he was a no-nonsense guy in terms of if the project really merited inclusion and if it was important and if it was done right. He also was in the loan appraisal department of Coldwell Banker, and I'm told that he actually knew Mr. Coldwell. He got involved in a lot of other development things; important for us to know is that he is a U.S. Marine – once a Marine, always a Marine.

"But the interesting thing in how I met him and how many people know him is because of his piano expertise; and our honoree today is one of the most popular pianists in our community. He appears at special events, including venues of Nico's Pier 38, Nordstrom, Duc's Bistro. He's played at Washington Place, events, weddings, birthdays. And last year, he made his debut here in our office, in room 214, during the Art at the Capitol, and we're very pleased to announce that on Friday, April 1st, he's going to be entertaining you again. And I've got to tell you, there was some singing and dancing and slapping of feet last year, so we're going to have that again on April 1st.

"He is an amazing man who has accomplished a great deal, but his love for Hawai'i is the prominent thing that we're recognizing him for today, so I'd like to introduce and have him stand: Mr. Rich Lowe. And up in the gallery, one of his friends and colleagues, an architect and also a member of the MIT Alumni Association here in Hawai'i, Mr. Bundit Kanisthakhon, who has his own architectural firm, Tadpole Studio; Bundit,

please stand to be recognized. Thank you, Mr. President; thank you, colleagues, and aloha, Rich Lowe."

Senator Baker recognized Daintry Bartoldus of the State Council on Developmental Disabilities, who was present in the gallery.

Ms. Coverlissa's positive attitude and passion for serving individuals with developmental disabilities will enhance the effectiveness of the State Council on Developmental Disabilities.
