## Monday, March 21, 2016

The Senate of the Twenty-Eighth Legislature of the State of Hawai'i, Regular Session of 2016, convened at 11:35 a.m. with the President in the Chair.

The Roll was called showing all Senators present with the exception of Senators Harimoto and Kim who were excused.

The President announced that he had read and approved the Journal of the Thirty-Second Day.

Senator Kidani rose and stated:

"Aloha. Thank you, Mr. President. We continue with our Education Week program this morning. Many of today's honorees are being recognized for their achievements outside the classroom. Let me call on my colleague, Senator Taniguchi, to introduce our first guest."

Senator Taniguchi recognized Wrayna Fairchild, recipient of the 2015 Voya Unsung Heroes award, and presented the following remarks:

"Thank you, Mr. President. The Voya award recognizes educators who are inspiring innovation, creativity, problemsolving, and critical thinking among their students. In 2015, Wrayna Fairchild was the recipient of the Teacher Innovator Award. Wrayna's innovative teaching idea, 'Let's Make a MakerSpace,' is focused on building a MakerSpace to the Waikīkī School library. A MakerSpace is a specifically designed space where students have the freedom to use their creativity to design original creations of each student's choice. Supplies are at the disposal of the makers to apply their vision as a reality, encouraging students to explore, tinker, and even fail, teaching them the importance of trying.

"As a winner, she received a week-long Innovation Immersion Experience and participated in a variety of activities, including time in the Henry Ford Museum. She returned with increased vision and enthusiasm to continue to create outstanding learning experiences for her students. Wrayna won the award in 2015 while she was at Waikīkī Elementary School, but she has since moved to Mānoa Elementary, and that's why I'm doing the introduction today. Members, would you please welcome Wrayna Fairchild? Thank you."

#### Senator Kidani rose and stated:

"Thank you, Mr. President. There is a very prolific awardwinning author and blogger named Neil Gaiman who has made widely quoted statements about many things, among them: librarians. Gaiman says, 'Google can bring you back a thousand answers. A librarian can bring you back the right one.' My colleague, Senator Taniguchi, has also been designated to introduce the first of two librarians who we will honor today."

Senator Taniguchi congratulated Jan Kamiya, recipient of the Friends of the Library of Hawai'i 2015 Librarian of the Year Award, and presented the following remarks:

"Thank you, Senator Kidani and Senate President. On behalf of Senator Brickwood Galuteria, who represents the Twelfth District, which I used to represent, I have the honor to introduce Jan Kamiya, the 2015 Librarian of the Year. An avid reader and researcher, Jan grew up at the McCully-Mō'ili'ili Public Library. She later began her career in the Hawai'i State Public Library System at the Hawai'i State Library, next to the State Capitol, then moved to the Mānoa branch library.

"In 2012, Jan became the young-adult librarian at McCully-Mō'ili'ili Public Library, where she performs her duties with noticeable enthusiasm. She also teaches at the University of Hawai'i in the master of library and information science program. She's an avid genealogist and a member of the Hawaii Opera Theatre Chorus. We would like to congratulate Jan on her selection as the 2015 Public Librarian of the Year. Jan, would you please rise to be recognized? Mr. President, I yield the floor to Senator Riviere."

Senator Riviere honored Anna McCormick, recipient of the Friends of the Library of Hawai'i Excellence in Service Award, and presented the following remarks:

"Thank you, Mr. President. Members, guests in the gallery, and guests on the floor here, it's my privilege today to introduce to you Anna McCormick. Anna is a resident of the North Shore; she lives in Waialua. And this is on behalf of the senator from Wahiawā as well: She works in Wahiawā, so on behalf of Senator Dela Cruz and myself, I'd like to share a few remarks.

"Anna was born in 'Ewa Beach, moved to the North Shore with a large family. She graduated from Waialua High School, began working as a janitor in the Mililani community library back in 1984. Under the guidance of her boss at the time, he encouraged her to apply for another position, and in 1993, she became a library assistant III over in the Wahiawā library, where she has served admirably since. She became a library assistant IV in the late nineties, and she has a family – her children have grown up and served in the military.

"She continues to provide very personal, caring care and service for everybody who comes into the room. She firmly believes in the importance of treating people the way you want to be treated and to offer others service with a smile. No matter what the situation may be, or how difficult, she's there for people with a good, positive response and personality. So, ladies and gentlemen, I'd like to introduce to you Anna McCormick, this year's Excellence in Service award winner. Thank you, and I now yield the floor to Senator Kidani."

### Senator Kidani rose and stated:

"Thank you, Senator Riviere. Mr. President, for the past few years during Education Week, we have recognized students in Hawai'i schools who have received awards from Prudential Insurance Company. The Prudential Spirit of Community Awards is the largest youth recognition program in the United States, honoring middle and high school students for outstanding service to others. Our Hawai'i honorees come from four schools on three islands. Let's begin by calling on Senator Dela Cruz."

Senator Dela Cruz recognized Orren Smith, 2016 Hawai'i State Honoree for the Prudential Spirit of Community Awards, and presented the following remarks:

"Thank you, Mr. President. The Prudential Spirit of Community Awards was created in 1995 to honor middle and high school students who have demonstrated an extraordinary commitment to serving their communities and for outstanding service to others. Orren Smith, named as one of the top two youth volunteers in the State of Hawai'i for 2016, is a sixth grader at Hanalani Schools and represents the best of America's youth who demonstrate exemplary volunteer service.

"Realizing that residents of Hawai'i are at risk from many natural disasters – because the state is isolated, emergency help may not be available to reach the state – Orren arranged for a presentation on disaster preparedness at his school to educate his fellow students and their families on how to increase their chances of surviving a natural catastrophe. Orren researched disaster preparedness programs, contacted agencies involved in emergency planning, and obtained permission from school officials to hold a student assembly. He had a Coast Guard officer speak to students and prepared materials for the speaker to use and handouts for the students to take home. More than 155 families in Orren's community were reached through students who attended the presentation and learned how to plan and stay safe in the event of a natural disaster. Orren would like his project to continue and is thinking of arranging for volunteer speakers to speak at other schools in the community.

"We congratulate Orren Smith on being named a recipient of the Prudential Spirit of Community Awards for 2016 for the State of Hawai'i. Orren, if you could please stand? We definitely extend our best wishes for his continued success in all of his endeavors. We also have with us today, in the gallery, Orren's mother, Lydia Smith; Bonnie Lee, the Hanalani Lower School principal. We also have George Evensen, principal; Cynthia Chung, teacher at Our Savior Lutheran School; and Lieutenant Junior Grade Christa Funk, U.S. Coast Guard. Please rise and be recognized. Thank you, Mr. President. I yield to Senator Wakai."

Senator Wakai congratulated Anna Kimata, 2016 Hawai'i State Honoree for the Prudential Spirit of Community Awards, and presented the following remarks:

"Thank you, Mr. President. Anna Kimata is a bright and compassionate sophomore at Punahou School. She is a resident of Nu'uanu, so on behalf of Senator Chun Oakland, I and Senator Chun Oakland honor her today.

"I met Anna when she was an incoming freshman at Punahou School; after speaking to her summer school class in 2014, she expressed a desire to be an intern here at the State Capitol. I usually don't take underclassmen into my office, but there was something very special about this young lady, and, boy, was I right.

"Anna witnessed the complex issues we grapple with every day here at the Capitol. She was particularly interested in the plight of Micronesians in Hawai'i, recognizing this immigrant group as our civil rights issue of today. Anna understood how their meager resources in their home islands forced many of them to immigrate here to Hawai'i. She asked numerous questions and saw very few solutions, so, instead of complaining, Anna focused on contributing to improvements. I introduced her to the President of Palau, who was touring the Punahou School campus a year ago. The President was able to see how resources are an important factor in successful educational outcomes. He talked about his lack of basic educational resources on his home island. As Punahou tears down and rebuilds their elementary school, Anna and I are working on taking those extra surplus materials down to Palau in the near future. But in the meantime, she identified the pressing need to get more resources down to Palau, and she gathered 40 of her classmates to help gather extra library books - they boxed them up, and we took them to Palau for Palau's public school system for the improvement of their education system there.

"But Anna didn't stop there; that experience went so well that she volunteered to gather even more items. This time, she helped the people of Saipan. Last August, the folks in Saipan were devastated by Super Typhoon Soudelor, with gusts up to 120 miles per hour; 350 homes were flattened in Saipan. Anna gathered toys and bought some of her own to brighten the holidays for those without much to cheer about, and sent those items via container to the island of Saipan.

"So, everyone, you see the seeds of goodness have been planted into Anna. She has the ability to recruit those who will be her advocates, and today, we congratulate her on being this year's Prudential Spirit award winner. Congratulations, Anna. Joining Anna here today are her parents, Jason and Monica Yu-Kimata; would you please both stand to be recognized? Also with them is Mamie Kimata, Dr. George Kimata, and Mauhia Kimata – all relatives of Anna; please all stand to be recognized. Thank you, Mr. President. I would now like to turn it back over to Senator Kidani."

Senator Kidani acknowledged Britnee Akau, 2016 Hawai'i State Distinguished Finalist for the Prudential Spirit of Community Awards, and presented the following remarks:

"Thank you, Senator Wakai. Mr. President, on your behalf, I would like to acknowledge our third Prudential awardee: Britnee Akau from your island of Kaua'i. Unfortunately, Britnee and her family were unable to be with us this morning, but I would like to still acknowledge her work.

"Britnee is a 15-year-old sophomore student who organized a Gift of Aloha Book Drive. She collected more than a hundred books about Hawai'i and arranged for them to be donated to a national book drive in Washington, D.C. The success of the Gift of Aloha Book Drive project encouraged Britnee to continue her public service efforts locally by visiting Kaua'i's Wilcox Elementary School, promoting the anti-bullying platform BRAVE – 'Building Respect and Values for Everyone' – and distributing anti-bullying-related books to elementary students in the community.

"She is currently working to collect books for other organizations, including Wilcox Memorial Hospital on Kaua'i and the Next Step homeless shelter here on O'ahu. Britnee's volunteer community work is an inspiration to her fellow students, and we acknowledge her compassion and initiative this morning. Mahalo, Britnee; let's give her a hand."

The Chair remarked:

"Senator Kidani, before you proceed, I would also note that last year we honored her sister, who received the award as an eighth-grader, so their parents and extended family are certainly doing a great job."

Senator Ruderman commended Phillip Palmore, 2016 Hawai'i State Distinguished Finalist for the Prudential Spirit of Community Awards, and presented the following remarks:

"Thank you, Mr. President. The Senate of the State of Hawai'i is proud to honor and recognize Phillip Palmore, an esteemed resident of Mountain View and student at Kea'au High School, who has received national recognition for exemplary volunteer service by receiving a 2016 Prudential Spirit of Community Award. This prestigious award, presented by Prudential Financial, in partnership with the National Association of Secondary School Principals, honors young volunteers across America who have demonstrated an extraordinary commitment to serving their communities.

"Phillip Palmore earned this award by giving generously of his time and energy to designing and leading a project to build an ADA-compliant outdoor walkway and garden for the residents of the Hilo Medical Center Extended Care Facility. Upon discovering that residents were not permitted to go outdoors due to environmental safety concerns, he designed a figure-eight walkway with two seating areas – one nestled in a raised flowerbed and another at the end of the walkway, shaded by a pergola. Throughout the project, Phillip Palmore embodied leadership skills, including communication, organization, and relationship-building. By creating a welcoming outdoor area, this project improves residents' quality of life by fostering family and community interaction.

"The success of the State of Hawai'i, the strength of our communities, and the overall vitality of American society depend in great measure upon the dedication of young people like Phillip Palmore, who use their considerable talents and resources to serve others. The Senate of the State of Hawai'i hereby congratulates and honors Phillip Palmore as a recipient of the Prudential Spirit of Community Award, recognizing his outstanding record of volunteer service, peer leadership, and community spirit, and extends best wishes for his continued success in all future endeavors. Please welcome, once again, Phillip Palmore from Kea'au High School. And let's also acknowledge in the gallery, we have Phillip's father, Stephen Palmore. Thank you."

Senator Kidani rose and stated:

"Thank you, Senator Ruderman. Mr. President, before we move on from the Prudential awards, I would like to acknowledge one more individual who has long been associated with this program. With this morning's student honorees on the floor is Prudential's vice president for government affairs, Todd Thakar. Also in the gallery is his assistant from Prudential, Dayna Culbertson. Thank you both for your work to identify these outstanding young men and women for us each year.

"Mr. President, I certainly do not mean to diminish the accomplishments of any of our previous honorees over the past few days, but I kind of feel like we have saved the best for last. I now call on Senator Nishihara to introduce Hawai'i's Milken Educator for 2016."

Senator Nishihara commended and congratulated Michael Sana, recipient of the prestigious 2015-2016 Milken Educator Award, and presented the following remarks:

"Thank you, Senate President, and thank you, Senator Kidani. You know, I did teach at Waipahu High School for one year, so as a former school administrator, I'm keenly aware of the critical importance of visionary leadership among the corps of teachers on our campuses. There is none finer than the gentleman who joins us on the floor today, Michael Sana. Thank you.

"Michael is the chairman of the Waipahu High School science department and has given students opportunities to conduct and publish authentic scientific research. His students have worked at Lawrence Livermore National Laboratory, which is a federal research facility in California, and at the Rutgers University. He endeavors to create a learning environment that is creative and fun, a place where students will become excited about learning and come to understand the rewards of perseverance and hard work. Michael's passion for teaching and mentoring has helped dozens of students begin their college careers with a desire for rigorous scientific research. His hard work has helped to make Waipahu High's science curriculum a bright spot in the department. He's wholly dedicated to the success of his students, to nurturing their selfconfidence as well as pushing his students to strive for excellence.

"So, the Senate commends and congratulates Michael for his dedication and devotion to the children of Hawai'i and being selected as the recipient of the prestigious 2015-2016 Milken Educator award. Thank you. So, thank you, Mr. President, and before I return it back to the floor, I'd like to also recognize, up in the gallery, Stephen Schatz, the deputy of DOE. Now I'll return the floor to Senator Kidani. Thank you."

Senator Kidani rose and stated:

"Thank you, Senator Nishihara. Mr. President, I believe there are fans of Michael Sana in the gallery; I think his parents are here and his family. Thank you. I believe Principal Keith Hayashi was also here, but I think he had to leave. Thank you very much.

"Mr. President, colleagues, the Hawaii Public Charter Schools Network will be making the rounds at the Capitol today. Earlier this morning, the Network had displays and an informational program set up upstairs. In the gallery this morning, I'd like to introduce some of our charter school guests, charter school directors, and their schools: Heather Nakakura from West Hawai'i Explorations Academy; Kaleimakamae Ka'auwai, Kawaikini Charter School; Kamaka Gunderson, Ke Ana La'ahana Charter School; Daniel Caluya, Nā Wai Ola Charter School; Usha Kotner, Kona Pacific Charter School; and Pat Brandt, board member, Hālau Kū Māna Charter School. Thank you to the Charter School Network for helping us this morning with their Education Week.

"Mr. President, that concludes our Education Week recognition for today. On the day after tomorrow, we will meet teachers and administrators from the Teach For America program that this year has 280 teachers in Hawai'i classrooms. We'll hear more about that on Wednesday. Thank you, Mr. President and colleagues."

Senator Galuteria introduced Ron Lockwood, chair of the McCully-Mō'ili'ili Neighborhood Board, who was seated in the gallery.

At 12:00 p.m., the Senate stood in recess subject to the call of the Chair.
