### THIRTY-FIFTH DAY

### Wednesday, March 23, 2016

The Senate of the Twenty-Eighth Legislature of the State of Hawai'i, Regular Session of 2016, convened at 11:38 a.m. with the President in the Chair.

The Roll was called showing all Senators present with the exception of Senators Galuteria and Kahele who were excused.

The President announced that he had read and approved the Journal of the Thirty-Fourth Day.

At this time, Senator Dela Cruz welcomed employees, friends, and supporters of Wahiawā General Hospital, who were visiting the State Capitol to support the passage of H.C.R. No. 118. Senator Dela Cruz also acknowledged State Representative Marcus Oshiro.

Senator English introduced Naomi Kuailani, his cousin from Hāna, who was seated in the gallery.

Senator Kidani honored Teach for America on its tenth anniversary, and presented the following remarks:

"Thank you, Mr. President. We have two institutions represented by guests with us on the floor today to conclude our 2016 Education Week presentations, and I truly believe we have saved the best for last. First, we recognize a program that has brought dozens and dozens of teachers into Hawai'i's classrooms, where they fill a very critical void. Their cause is doing right by youngsters in our schools who need help the most in the name of enhanced educational equity. I call on Senator Kim to tell us more about Teach for America and to introduce our guests."

Senator Kim rose to present the following remarks:

"Thank you, Senator. Mr. President, it's a pleasure to welcome Teach for America Hawai'i, which is celebrating its tenth anniversary in our islands and 25 years in the United States promoting educational equity. Since 2006, the children of Hawai'i have been enriched by 300 corps members working as teachers in difficult-to-fill positions, such as special education, mathematics, and science, and in difficult-to-place jobs on O'ahu's Leeward Coast or rural areas of Hawai'i island. They have touched the lives of more than 15,000 students with their willingness to invest tremendous amounts of time, effort, and resources, and the result has been improved academic achievement levels. These Teach for America corps members also take on leadership positions at extracurricular activities that build strong bonds between faculty, students, and the community.

"I'd like to first introduce Jill Baldemor. Jill is Teach for America Hawai'i's executive director, a 1995 corps member who taught in Washington Heights, New York. She practiced law at Goodsill Anderson Quinn & Stifel for seven years before joining Teach for America.

"Anais Gude is the Hawai'i external affairs manager and a 2010 corps member who taught kindergarten and second grade at Kahakai Elementary School. She's a Fulbright Fellow. She taught English in the Slovak Republic. She has a bachelor's degree in sociology and Asian studies from Colorado College and a master's degree in teaching from Chaminade University. Welcome and thank you.

"Colleen McEnearney, corps member since 2013, is a teacher at Wheeler Middle School, where she is also the math and science department chair. She previously worked one-on-one with students receiving special education services at Campbell High School in 'Ewa Beach. Thank you.

"Cameron Kubota, corps member since 2013, is a mathematics teacher at Wai'anae High School and a cohort leader for the Hoku Scholars program. He attended Kailua High School, Pepperdine University, and Chaminade University. Thank you, Cameron.

"And finally, we have David Miyashiro. He is the external manager and 2008 corps member at Wahiawā Middle School, teaching special education. He previously worked for U.S. Senator Mazie Hirono in Washington, D.C. He's a graduate of Punahou School and Brandeis University and holds a master's degree from UH Mānoa and Harvard University.

"So, we congratulate all of you, Teach for America, on your anniversary, and we thank you for your leadership, service, and for inspiring us by your good example. And also with us, in the gallery, Mr. President, we have some Teach for America supporters and friends. Thank you."

Senator Kidani rose and stated:

"Thank you, Senator Kim. Mr. President, 2016 marks the fortieth anniversary of the establishment of the University of Hawai'i – West O'ahu. Those of us who have been around a while can remember the 'little campus that could,' nipping at our heels, reminding us that they were still around and very much worthy of our support.

"Following Board of Regents approval, West O'ahu College held its first classes in high school facilities in 1976. A few years later, seeing the value of highly flexible class schedules, a commitment to serve non-traditional students, and a cando/must-do approach to its mission to serve the underserved, regents approved programs and degree expansion and renamed the school University of Hawai'i – West O'ahu.

"About 30 years from its humble beginnings, and with new temporary facilities in portables at Leeward Community College, West O'ahu became a four-year campus in 2007. Ground was broken for the permanent Kapolei campus in 2009, and just over 2,000 students were enrolled as the doors opened in brand-new facilities for fall semester classes in 2012.

"On the horizon for UH West O'ahu are construction of a new administration building and facilities for instruction in the allied health services. With the Legislature's support, an expanded UH Academy for Creative Services digital media production center is on the drawing boards and in this year's budget.

"Those of us who represent the several communities around the new campus marvel at the partnership UH West Oʻahu developed with Waipahu High School that now enrolls 600 high schoolers in early college classes. The new campus is a spectacular focus for our communities, and we are very proud to celebrate the successes of our UH West Oʻahu campus.

"Mr. President, the UH West O'ahu campus is officially located in Senator Gabbard's district. I would like to call on him now to continue our presentation."

Senator Gabbard rose to present the following remarks:

"Mahalo, Mr. Pres. As the senator from District 20, known affectionately as 'God's country,' I can't tell you how much it means to have UH West Oʻahu in our district. It has become the flagship of the whole west side, and while we are celebrating the fortieth anniversary, I would just remind my colleagues of a little history: It was actually in 1966 when the Legislature made its first appropriation of \$300,000 for planning for UH West Oʻahu. Forty-six years later – forty-six years later – we opened the doors in 2012, much to the happiness of all the people who

live out there. So I just want to say, you've heard the saying how the wheels of government turn painfully slow - I cannot think of another example better than this one here. So, I would like to say mahalo to all of you, the colleagues who have helped to get this campus open, and for your continuing support over the years.

"Mr. President, UH West Oʻahu has a new presence at the State Capitol this session. This is the very first internship of its kind for students at UH West Oʻahu. These students are leading the way for future students to get involved with the political process here in Hawaiʻi. Nine students from various programs at the Kapolei campus have been assigned to senators and reps for internships for which they can earn college credit. These members of the capitol class of 2016 are in the gallery with us this morning, and I would like to ask them to stand and be recognized. But first, I would also like to recognize their mentors for the internship; their role in this also must be acknowledged. We have Ken Inouye and Dwight Takamine. Rufino Dan Magliba and Russell Kokubun could not be with us today, but these gentlemen are adding wisdom to this great program. Good to see you, Dwight; aloha.

"And now, for the House interns: They are Ronie Agustin, Isaiah Baclaan, Ana Lillis, and Marousha Moore. Please give them a hand; aloha. And in the Senate, we have the services of Patrick Alvior, Tori McCann, Angelo McDuffie, Joyleanne Santos, and the very capable young man who's been a tremendous help in my office this session, Mr. George Kalantzis. And on a personal note, George, thank you for all your help; we hope you've learned some things to do during your time with us besides how to make coffee. At this time, I'd like to turn the floor back over to Senator Kidani. Mahalo."

Senator Kidani commended and congratulated Rockne Freitas on his accomplishments and contributions to the University of Hawai'i and the State of Hawai'i, and presented the following remarks:

"Thank you, Mr. President. Colleagues, with us on the floor today are senior executives and guests from the University of Hawai'i. I would like to start by introducing our Board of Regents chair, Mr. Randy Moore; also, president of the University of Hawai'i's ten-campus system, David Lassner; our interim chancellor of UH West O'ahu, Dr. Doris Ching; and the immediate past chancellor at UH West O'ahu, Dr. Rockne Freitas

"Rockne, if you would remain standing for just a little while. Colleagues, it is hard to imagine that someone with such imposing stature considers himself shy and wanting to stay out of the limelight. We have tried repeatedly to invite this gentleman to our chamber to recognize his commitment to the state and to the university and to wish him well in retirement, but we have been unsuccessful until now.

"It would take way too long for us to run through Rockne's résumé, so let me do the short version – with some acronyms: OSU (Oregon State University); the NFL; OHA; Kamehameha Schools; and finally, UH.

"Beyond the professional credentials, we know Dr. Freitas to be a true gentleman, with a wonderful capacity for bringing people with divergent views together, and, as we say in our congratulatory certificate, a 'community statesman.' Rockne, mahalo for your service to the State of Hawai'i, to the University of Hawai'i, and to the people of Hawai'i.

"Mr. President, with Rockne today on the floor is his son, Makoa; and Makoa's son, Rockne's grandson, Rockne. Thank you for joining us today. I believe, in the gallery, we have some fans and supporters of UH West O'ahu: Wendy Tatsuno – thank you; Cindy Vinluan – thank you; and Christine Nevis – thank you for being here today.

"Mr. President and colleagues, mahalo for your participation in our 2016 Education Week presentations. I appreciate your help and will look forward to next year, when we can once again recognize excellent school leadership, excellent teachers, and outstanding students who inspire us all. Thank you, Mr. President."

Senator Taniguchi rose to extend an additional welcome and best wishes to Rockne Freitas, noting that he is an active constituent of the Eleventh Senatorial District community.

At 11:54 a.m., the Senate stood in recess subject to the call of the Chair.

"Your Committee further finds that Mr. Wescoatt has been nominated to the Hawaiian Homes Commission based on his knowledge, experience, and commitment to improving housing in the state, and I hope that my colleagues will also support his nomination. Thank you."

At this time, Senator Inouye rose to speak on a point of personal privilege as follows:

"I ask you and our colleagues to thank Senator Kidani and her hardworking staff for the outstanding Education Week presentations that we have seen these past days. Kudos to all of them. Thank you, Mr. President."

Senator Baker announced that Easter baskets for the Institute for Human Services could be dropped off at her office or brought to the Capitol Rotunda the following morning at 10:00 a.m. for photos with the Easter bunny.

Senator Kim rose to speak on a point of personal privilege as follows:

"Mr. President, I received this thing from the news, KHON, and also saw it on TV, but I think most of you recall that this is where Ledward Kaapana was playing music at our airport and he was told that he couldn't play – they stopped him. Apparently, that's our airport rules, but it's very sad that we have that. I remember going to Nashville, Tennessee, coming off the plane at the airport and being greeted by a country-western trio – and I thought that was wonderful – came back here and talked with HTA, asking them how we can bring our Hawaiian music to our airports.

"And so, having seen this, that someone of Mr. Kaapana's stature – and he says that he's been doing this at airports around the world for decades, so he was surprised when he was told to stop playing music there. And so, I think that we need to really take a look at our rules at the airport and see how we can infuse our Hawaiian music and if we do have our local musicians who are willing to play, we certainly want to welcome that. He was asked, 'Will you play music again at the airport?' and he said, 'Yes, that's not going to stop me, because I just did it again in Maui.' And so, we thank Mr. Kaapana for his music and hopefully, we can remedy this. Thank you very much."

Senator Inouye rose to speak on a point of personal privilege as follows:

"I just want to add – thank you, Senator Kim, for bringing that up. Just to let you know that we have been in discussions with DOT as well, and they are reviewing their administrative rules as well and will be devising new rules and will be also making sure that it goes out to public hearings as well.

"And we all remember when it first started, back in the days before TSA and before 9/11, when there were disruptions at the airport such as the Hare Krishna programs that they did at the airports, and that was the start of the administrative rules implemented then. However, after TSA, then we found out that they're not allowed in the airports anyway, so I think it's about time that we look and see, that we go back to the rule system and see if we can make some changes as well.

"I've also made a request to – because, with the upcoming Merrie Monarch Festival, we know that we're going to have entertainment at the airports as well, and so they've been instructing the personnel at the airports not to disrupt the entertainment for that period of time. Hopefully, we can participate in the administrative rule process forthcoming. Thank you, Mr. President. Thank you, colleagues."

The Chair then made the following announcement:
