THIRTY-SIXTH DAY

Thursday, March 24, 2016

The Senate of the Twenty-Eighth Legislature of the State of Hawai'i, Regular Session of 2016, convened at 11:34 a.m. with the President in the Chair.

The Roll was called showing all Senators present with the exception of Senators Galuteria and Kahele who were excused.

The President announced that he had read and approved the Journal of the Thirty-Fifth Day.

At this time, Senator Baker recognized the Youth Council of the Coalition for a Tobacco-Free Hawai'i for their outsanding work to lead initiatives that help make the next generation tobacco-free, and introduced the following council members who were seated in the gallery: Chase Kessler from La Pietra -Hawaii School for Girls; Kristian Leming from James B. Castle High School; Brianne-Lyn Nagamine, Carin Ham, and Kelsie Calabrese from the University of Hawai'i at Manoa; Cody Asuncion from Konawaena High School; Keiko Kurohara from Waiākea High School; Arissa Molina from Henry Perrine Baldwin High School; Sharnelle Kaili from Moloka'i High School; and Hau'oli Lopez from Kapa'a High School. The Youth Council members were accompanied in the gallery by Jessica Yamauchi, Trisha La Chica, and Courtney Voss from the Hawai'i Public Health Institute. Senator Baker noted that the group had helped with efforts to raise the age to purchase tobacco products from 18 to 21, and were now focusing on protecting keiki from harmful secondhand smoke in vehicles. Senator Baker then invited the members to join the youth in the Capitol Rotunda for a short program for Kick Butts Day following the Senate's floor session.

Senator Green recognized Stephen Spears, executive director for Kaua'i Habitat for Humanity since 2007, and noted that the organization had built 117 affordable homes on Kaua'i and would be tackling a large project during the next two years.

Senator Green then introduced George Massengale, who was present in the gallery on behalf of Pat Hurney, executive director of Habitat for Humanity West Hawaii. Senator Green noted that the organization had been building extraordinary affordable homes in the Kona area since 2002, and expressed his perspective that shelter provides mental health support, which has been a major problem for many people across the state. Senator Green then praised the organization's ReStore and remarked that he and his mother were grateful to support their cause and all the great work they do.

Senator Harimoto recognized Gary Passon, board president for the Hawaii Habitat for Humanity Association; Jean Lilley, executive director for the Hawaii Habitat for Humanity Association; Stephen Spears, executive director for Kaua'i Habitat for Humanity; and other supporters who were seated in the gallery. Senator Harimoto informed the members that since 1989, Hawai'i's Habitat affiliates have built more than 500 new homes in Hawai'i and have rehabilitated more than 150 existing homes, and in 2015 alone, they completed 42 new affordable homes, with Maui Habitat completing the very first low-rise condominium for 16 families with volunteers and sweat-equity labor.

Senator Kim welcomed John DeSoto, former council chair for the Honolulu City Council and champion dirt bike rider, and his wife, Patty, both of whom were seated in the gallery. Senator Kim then introduced DeMont Connor, who was present in the gallery with his wife, Rachel, and remarked that his mother, Geronimo, used to visit the Honolulu City Council regularly. Senator Kim also introduced Geronimo's sister, Ina;

Harley Rose Flint, who was celebrating her ninth birthday; and her sister, Haley.

Senator English praised Habitat for Humanity Maui for their support of Maui communities through construction of singlefamily or multi-family housing for those in need, as well as helping with critical repairs, renovations, and retrofits through their A Brush With Kindness program, which assists families in making their homes safe again by re-roofing or installing retrofits such as grab bars and ramps to accommodate a disabled or elderly resident. Senator English acknowledged Gary Passon of the Habitat for Humanity Maui Board of Directors and Sherry Dodson, executive director for Habitat for Humanity Maui, and remarked on their recent projects, including the newly-completed 16-unit low-rise condominium in Kahawai. Wailuku, and the start of ten new homes in Kahoma in Lahaina, West Maui. Senator English commended Habitat for Humanity Maui for all their fine projects, including their ReStore, which sells donated or slightly used construction materials at discounted prices to the public.

Senator Espero welcomed a group of sixth-grade students from Holomua Elementary School, who were seated in the gallery with teacher Glenda Magno and chaperone Don Santiago.

Senator Chun Oakland introduced Jim Murphy, executive director for Honolulu Habitat for Humanity, and acknowledged the organization for their superb work.

Senator Shimabukuro congratulated and honored the 2015 inductees into the Outrigger Duke Kahanamoku Foundation Waterman Hall of Fame, and presented the following remarks:

"Thank you, Mr. President and colleagues. The Outrigger Duke Kahanamoku Foundation's Hawai'i Waterman Hall of Fame was established in August 2010 to honor those remarkable legends in our islands' water sports community whose contributions to water sports unite, inspire, and remind us of the unique opportunities our oceans provide to our people.

"We are honoring today the four 2015 inductees to the Hawai'i Waterman Hall of Fame. These individuals are the finest aquatic athletes in the sports most closely associated with Duke Kahanamoku. Besides excelling in aquatic sports, these inductees are recognized as individuals who, in their generation, have also given back to their communities. Inductees, as you are introduced, please rise.

"Our first inductee, Duane DeSoto, at the age of 37, the youngest inductee to the Hawai'i Waterman Hall of Fame, is founder and CEO of Nā Kama Kai, a nonprofit organization he founded in 2008 with his wife, Dr. Malia Ka'aihue, who is the traditional knowledge advisor of the organization.

"Born and raised in Mākaha, Duane's desire was to enable Hawai'i's most disadvantaged children to learn about all aspects of the ocean, from its importance to their ancestors to safety, surfing, paddling, and how to correctly rig a canoe. His group teaches over 100 children a month, all free of charge, and all programs have been carefully designed by Duane himself to bring together ocean culture and lifestyle through innovative programs in a safe learning environment.

"Duane is winner of the 2010 ASP Pro Longboarding World Title, and his knowledge of the ocean was tapped for the Mālama Honua voyage of the *Hōkūle'a* in 2012. Further, on the 100th anniversary celebration of Duke Kahanamoku's visit and surfing at Freshwater Bay in Australia, Duane was chosen for the role of Duke in the re-creation of the event. His efforts in

the re-enactment of Duke's boardriding skills were acclaimed to be exceptional.

"We have in the gallery with us today Duane's mother, Cathy McCurnin; his dad, Manny DeSoto; his wife, Dr. Malia Ka'aihue; children Laura, Micah, and Honua; his in-laws, Abraham and Pamela Kapana, Jr.; and uncle and aunt John and Patty DeSoto. And if there are any other supporters of Duane, could you all please rise? Let's give them all a warm welcome. I now yield the floor to Senator Roz Baker."

Senator Baker rose to present the following remarks:

"Thank you, Mr. President. Colleagues, our next inductee is Soichi Sakamoto, and representing Mr. Sakamoto today is William Pratt, who's the past president of the Outrigger Duke Kahanamoku Foundation and co-creator of the Hawai'i Waterman Hall of Fame. So, let's welcome Mr. Pratt.

"Let me share a little bit about our inductee, Soichi Sakamoto. He was a swimming coach from Pu'unēnē, Maui, who took underprivileged children of plantation workers and turned them into Olympic champions. Not having any swimming pools in which to train, they trained in the irrigation ditches of the fields where their fathers worked. In 1937, Mr. Sakamoto created the Three-Year Swim Club, so named because he believed he could train the children to be Olympic champions for the 1940 games in Tokyo. His team won every swim meet they entered in Hawai'i in 1938 and the national title in 1939. Unfortunately, the onset of World War II canceled the next two Olympic Games, but his student, Bill Smith, a 2013 Hawai'i Waterman Hall of Famer, went on to win the gold in the Olympic Games in London in 1948.

"In later years, Mr. Sakamoto moved to Oʻahu to coach the University of Hawaiʻi swim team and produced several more Olympic-medal winners throughout the remainder of his career, retiring in 1966. He passed away in 1997 at the ripe old age of 91, but his tradition of swimming and rising above the norm continues to this day. And the swimming pool in Central Maui is named in his honor as well. It's now my pleasure to yield the floor to Senator Riviere."

Senator Riviere rose to present the following remarks:

"Thank you. I get to talk about Joey Cabell, who's a legend who I know from my youth growing up and as preceding me. Bill Pratt is also here representing Joey Cabell, so if I could share a few words with everyone. I started surfing in the midseventies at a time when *Surfer* magazine was this every-othermonth magazine and the subscription was \$5 a year. And so surfing even in the seventies was booming, but it wasn't anywhere near where it is today.

"But even in the seventies, I knew Joey Cabell's name as a guy who could surf fast. He was quick; he was there at the vanguard of the change of surfing from longboards, where people were more into glide, and now he was moving quicker. He created a surfboard called the White Ghost, which was designed for speed and was his hallmark of surfing. He was considered by many to be the fastest surfer alive. He was very competitive and very successful in his competition.

"He appeared in numerous surf movies and in 1963 was named to *Surf Guide* magazine's first All-American Surfing Team. In 1985, *Surfer* magazine named him one of the 25 most influential surfers who changed the sport of surfing. He was also an accomplished skier and sailor. He was a natural selection for the Duke Kahanamoku Surf Team back in 1965, and it was an exclusive team that traveled and surfed around the world and represented the great Hawaiian sport of surfing.

"So, with that, I'm really pleased to be able to speak a few words to everybody here, to talk about and celebrate the surfing life of Joey Cabell. Thanks for being here, Bill Pratt; mahalo. Mr. President, I yield the floor now to Senator Gabbard."

Senator Gabbard rose to present the following remarks:

"Thank you, Mr. President. Walter Guild is a member of the renowned kama'āina Macfarlane family, whose tradition embraces a number of sports and who were founders of some of the oldest and longest-running ocean races in the world, and is himself a renowned canoe-paddling athlete. He's a member of the Outrigger Canoe Club team, eight-time world champion of the prestigious Bankoh Moloka'i Hoe race. With a total of 17 Moloka'i Hoe crossings, Walter also secured champion status in 1999 Poai Puni/Kanaka Ikaika one-man outrigger canoe race series

"Walter was instrumental in designing and revolutionizing the six-man canoe and the Hawaiian one-man canoe that are popular today. He co-founded Canoe Sports Hawaii, which established the Altres King Kalakaua Regatta and the world-famous Kaiwi Channel Relay race from Moloka'i to O'ahu in 1990.

"Walter has spent a lifetime paddling canoes, and teaching others to do so has helped raise not just awareness but also popularity of the sport. He has become a leader and innovator in canoe and kayak manufacturing and promotion. Please give him a big hand. And I yield the floor back to Senator Shimabukuro."

Senator Shimabukuro rose and stated:

"Thank you, Mr. President. In concluding, we congratulate Soichi Sakamoto, Joey Cabell, Duane DeSoto, and Walter Guild on being named the 2015 inductees into the Hawai'i Waterman Hall of Fame and express our appreciation for their many contributions to water sports and to the State of Hawai'i. Mahalo."

At 11:55 a.m., the Senate stood in recess subject to the call of the Chair.
