

THIRTY-EIGHTH DAY

Tuesday, March 29, 2016

The Senate of the Twenty-Eighth Legislature of the State of Hawai'i, Regular Session of 2016, convened at 11:35 a.m. with the President in the Chair.

The Roll was called showing all Senators present with the exception of Senator English who was excused.

The President announced that he had read and approved the Journal of the Thirty-Seventh Day.

Senator Green commended and congratulated the recipients of the 2015 Hawaii Healthcare Heroes Award, and presented the following remarks:

"Mr. President, today we're joined by five Hawaii Healthcare Heroes. These extraordinary health professionals were nominated by patients or their families who felt they provided outstanding care to our people in Hawai'i.

"It's never easy to endure life-changing circumstances. Through their varied roles in the healthcare profession, these heroes have ensured that their patients and families did not feel alone. They have helped to strengthen the communities in which they live and work, reminding us that there are life-changing moments daily, even in what seem the most difficult circumstances. These five professionals show us that health care is not just a science-based profession and that healing requires compassion and dedication to humanity.

"I'm sure that the panel of judges had a very difficult time selecting these five honorees among many, many superb healthcare candidates and healthcare workers in our state, but today we recommend these individuals to you, Mr. President, for their outstanding contributions in health care and applaud them for the recognition that they have received. I'd now like to yield the floor to Senator Baker to begin these introductions."

Senator Baker rose to present the following remarks:

"Thank you, Mr. President. On your behalf, it's my pleasure to introduce Dr. Juliette Zelada. Dr. Zelada, a surgeon at Wilcox Memorial Hospital on Kaua'i, has been selected as a 2015 Hawaii Healthcare Hero. She specializes in laparoscopic and colorectal surgery and has worked at Wilcox for seven years. Her exemplary standard of care, excellent technical surgical abilities, and commitment to her patients embody the true spirit of a Healthcare Hero.

"Janice Bond nominated Dr. Zelada for this award, and she can attest firsthand to the monumental and life-changing impact of Dr. Zelada's work. After finding her son in a coma in his apartment, Janice accompanied him to Wilcox, where she was introduced to Dr. Zelada, who operated on him for six days in order to save him from the necrotizing fasciitis that was attacking his body. Janice shared that Dr. Zelada gave clear explanation, provided the family with peace as to what was happening with John – part of his thigh, back, and abdomen were surgically removed down to the muscles. Had it not been for Dr. Zelada's constant care, John would have died. Dr. Zelada had the skills, knowledge, and wisdom to know what to do to save his life.

"Today, John is recovered and is healing both physically and spiritually and resuming normal activities, like driving his mother to church. Thank you, Dr. Zelada; you are Janice's and the Bond family's Hawaii Healthcare Hero. Colleagues, thank you for joining me in enthusiastically recognizing this transformative healthcare provider and welcoming Dr. Zelada to the Senate today. Thank you so much, Doctor, for your

continued work and help in our community, and now it's my pleasure to yield the floor to Senator Taniguchi."

Senator Taniguchi rose to present the following remarks:

"Thank you, Mr. President; thank you, Senator Baker. It gives me great pleasure to give recognition to Kathy Krammer, another 2015 Hawaii Healthcare Hero. Originally from Chicago, Kathy came to O'ahu to pursue degrees in speech pathology and audiology, and we are grateful for her exemplary career and valuable contributions to health care here in the Aloha State. She's a registered nurse and the senior speech, language, and swallowing pathologist at The Queen's Medical Center, where she has facilitated the head and neck cancer support group since its founding in 2007.

"Kathy was nominated by multiple patients who wished to express their gratitude for her empathy, tenacity, and compassionate commitment to their care. Colleagues, even though she's not here, please join me in thanking Kathy for the strong, positive impact her work has had on the lives of her patients; could you give her a hand? Representing her on the floor today is Joanne Kawahigashi-Oshiro, her coworker, who is here to accept the certificate on her behalf. Thank you, Mr. President, and I will yield the floor to Senator Galuteria."

Senator Galuteria rose to present the following remarks:

"Thank you, Mr. President; mahalo, Senator Taniguchi. Mr. President, colleagues: Today, I'm delighted to recognize Grace Porras. Grace is a licensed practical nurse and a recipient of a 2015 Hawaii Healthcare Heroes Award. She received her medical training in the Philippines and has worked at Maunalani Nursing and Rehabilitation Center for the past 22 years. Her compassion, dedication to her work, and consistent excellent care make a lasting impression on the patients she serves as well as their friends and family.

"Grace was nominated by Liana Pang in recognition of her invaluable help and support in a profoundly difficult time. Liana's mother was one of Grace's patients. Liana shares with us, 'At the intersection of crash and burn, we turn the corner to find Grace Porras, Mom's nurse. She was our one-stop station for securing accurate information, developing a plan to address healthcare issues, and providing a compassionate shoulder to cry upon and a safe haven.' Liana also details the ways Grace's care extends beyond her patients, offering solace and emotional respite to their families as they face sorrow and loss. With her special touch of aloha, Grace acts as a source of comfort as she helps families to say goodbye to their loved ones. In Liana's words, 'Mahalo to Grace Porras, who lives up to her name that is synonymous with elegance, kindness, and blessing.' Colleagues, please join me in recognizing our 2015 Hawaii Healthcare Hero, Grace Porras. Mahalo; thank you so much! And now, Mr. President, I yield to Senator Ihara."

Senator Ihara rose to present the following remarks:

"Mr. President, I'd like to ask Jim Stremick to rise to be recognized. Jim is another Hawaii Healthcare Hero Award recipient. Jim is a physical therapist and has worked for Prime Care Services Hawai'i for the past 15 years. In the course of his work, Jim frequently encounters patients who have been seriously injured and who have faced profound challenges to regaining mobility – some are told they will never walk again. Jim's unfailing positivity and dedication to his work is instrumental in guiding these patients as they pursue physical and emotional recovery.

"Elising Tunglen, who nominated Jim for this award, can personally attest to the transformative impact of Jim's care.

While recovering from heart failure, Elising lost mobility of her legs and believed she would never walk again, but Jim's optimism and motivation eventually convinced her otherwise. He used the Rose Bowl Parade, to which he had yearly tickets, as an end goal to serve as the focus of her recovery, even sending her bouquets of roses as encouragement. Elising wrote, "One day, Jim and my grandson helped me get out of bed. Jim put a belt around my waist to support me. I took three steps and sat on a wheelchair. Eventually, three steps slowly increased, and I finally got to walk 500 feet and more. After two months of therapy at home, I did make it to California, to the parade that Jim helped me to visualize. Today, I can walk, and I have to thank Jim, my Healthcare Hero, for not giving up on me." Please join me in congratulating and thanking Jim Stremick. Mr. President, I yield the floor to Senator Harimoto."

Senator Harimoto rose to present the following remarks:

"Mr. President and colleagues, I am honored today to recognize Dr. Warren Tamamoto, another Hawaii Healthcare Hero joining us on the floor today. Originally from the island of Hawai'i, Dr. Tamamoto attended UH Mānoa for his undergraduate degree and subsequently graduated from the John A. Burns School of Medicine. He is currently chief of pulmonology for Kaiser Permanente.

"Prodigious experience, excellent care, and innovative leadership are all qualities exemplified by Healthcare Heroes, and Dr. Tamamoto combines all three. Jennifer Purcell, a patient of Dr. Tamamoto's at Kaiser, nominated him for this award based on the transformative effect his care had on her life. Struggling with asthma so debilitating that it eventually forced her to use a wheelchair and an oxygen tank, Jennifer went to Dr. Tamamoto seeking a cure. He opted to try a new procedure, bronchial thermoplasty, never before done in Hawai'i, to address her condition. The procedure worked, giving Jennifer access to opportunities and experiences previously unavailable to her due to her health.

"Jennifer said that the results have been so phenomenal, she is now able to enjoy outings with her family beyond only maintenance inhaler and her biggest achievement: completing a 4-day trip to Japan and an 11-day trip to Korea, where all she did was walk. She walked day and night for 10 to 14 hours a day, climbed miles of stairs, and she got to enjoy every single step of her trip with no wheelchairs, no extra meds, no oxygen, no rescue inhalers – just life. So, colleagues, please join me in recognizing Dr. Warren Tamamoto. And I'd also like to recognize, in the gallery, a good friend of mine, Dr. Tamamoto's wife, Claire. And I know some of his family is there, too; will you all please stand and be recognized? Also, Dr. Tamamoto's mom. Thank you."

Senator Baker rose to present the following remarks:

"Mr. President, before we leave our Hawaii Healthcare Heroes, I'd like to acknowledge some other folks in the gallery: George Greene, who is the CEO for the Healthcare Association of Hawaii, our hospital association; as well as Mary Ann Barnes and Frank Richardson from Kaiser Permanente; Phyllis Dendle, I see over there – all of the other folks from Kaiser, for HAH, who are here to support our Healthcare Heroes, if you'd please rise to be recognized? Thank you."

Senator Espero recognized State Representative Ryan I. Yamane and State Representative Della Au Belatti, who were seated in the gallery.

Senator Galuteria extended additional welcome and thanks to Dr. Tamamoto, remarking that he has been a hero to the senator's family in treating pulmonary disease.

Senator Kahele welcomed Kumu Ralph Lalepa Koga, an instructor at Kawaihuelani Center for Hawaiian Language at the

University of Hawai'i at Mānoa, who taught Senator Kahele while he attended the university. Senator Kahele noted that Kumu Koga uses primary and secondary sources exclusively, in Hawaiian and English, to develop curriculum for Hawaiian language students and is also active outside of the classroom, teaching community members who are unable to attend the university courses, and serving as a mentor to former students working towards advanced degrees.

Senator Baker recognized and honored Dr. Kenneth Moritsugu, and presented the following remarks:

"Thank you, Mr. President. Colleagues, it is indeed my honor and privilege to introduce another healthcare hero of sorts: Dr. Kenneth Moritsugu. He's an exceptionally motivated former public servant, physician, and true island son. Born and raised on the island of O'ahu, Kenneth Moritsugu graduated with honors in classical languages from the University of Hawai'i. Matriculating at George Washington University School of Medicine, Dr. Moritsugu received his medical degree and his master's in public health administration and planning from the University of California, Berkeley. He completed his residencies in both internal and preventive medicine, received his board certification in preventive medicine and as a certified corrective health professional and holds fellowships in the American College of Preventive Medicine, the Royal Society of Public Health, the Royal Society of Medicine, and the National Academy of Public Administration.

"In 1976, Dr. Kenneth Moritsugu served as the assistant bureau director and medical director of the U.S. Department of Justice Federal Bureau of Prisons for over a decade and was responsible for the overall management and healthcare program for all federal prisons in the nation. During his time serving at the Federal Bureau of Prisons, he also began his career as a commissioned corps member of the U.S. Public Health Service as an assistant surgeon general under then-Surgeon General C. Everett Koop, and in 1998, Dr. Moritsugu filled the position of deputy surgeon general, providing input and recommendations to the assistant secretary for health and to the acting surgeon general on the direction of policies and programs that our nation should undertake. In 2002, Dr. Moritsugu became the first Asian American and individual from Hawai'i appointed as the acting surgeon general, serving as our nation's top public health physician and chief educator. After his retirement from the United States Public Health Service in 2007, Dr. Moritsugu joined the executive team of Johnson & Johnson's Diabetes Solution Companies and the Johnson & Johnson Diabetes Institute.

"Through his professional and personal commitment throughout his career, Dr. Moritsugu has received numerous honors and awards. On Thursday, here in Hawai'i, Dr. Moritsugu will be awarded the Lifetime Achievement Award from the National Kidney Foundation of Hawaii for his continuing efforts and active participation for organ and tissue donations. Colleagues, I'll ask you again to join me in honoring a true island son, Kenneth Moritsugu, for his dedication and commitment to his nation and his tireless efforts to promote and educate people on a healthy lifestyle. Thank you so much, Doctor, for all you've done and for being with us today. Colleagues, another round of applause. Mr. President, it's my pleasure to yield the floor to Senator Inouye."

Senator Inouye recognized and honored Norman Mineta, and presented the following remarks:

"Thank you, Mr. President and colleagues. It is an honor and a privilege to introduce Secretary Norman Yoshio Mineta. He is roundly recognized for his accomplishments in transportation, economic development, science and technology policy, foreign and domestic trade, budgetary issues, and for being a trailblazer for civil rights. We welcome him back to Hawai'i."

“Secretary Mineta was born in 1931 to first-generation Japanese immigrants Kunisaku and Kane Mineta. In 1941, at the age of 10, Secretary Mineta and his family were relocated to an internment camp along with other Japanese Americans as a result of the Japanese attack of Pearl Harbor. Secretary Mineta graduated from the University of California, Berkeley, and served in the U.S. Army as an intelligence officer.

“In 1967, Secretary Mineta began his political career when he was appointed to the city council of San Jose, California. For the next 30 years, he served his district of San Jose as the first Asian American councilmember, first Asian American mayor, and as a member of Congress. In 2000, President William J. Clinton appointed Secretary Mineta to the position of U.S. Secretary of Commerce, making him a pioneer for the Asian American community as the first Asian American to hold a post in the presidential cabinet. The following year, he was appointed as the U.S. Secretary of Transportation by President George W. Bush.

“Secretary Mineta has been recognized throughout his career for his exemplary leadership and accomplishments. Amongst his extensive list of accolades, Secretary Mineta has received the Presidential Medal of Freedom, the highest civilian award in the United States; the Wright Brothers Memorial Trophy, awarded for significant public service of enduring value to aviation in the United States; and the Grand Cordon, Order of the Rising Sun, from the Japanese government, the highest honor bestowed upon an individual of Japanese descent living outside of Japan. Secretary Mineta is a shining example of Dr. Martin Luther King’s dream for a nation that does not judge someone by the color of their skin but by the content of their character.

“Colleagues, I was impressed with the certificate we’ll be providing, but I need to share one portion of it: ‘Secretary Mineta’s actions on and following the events of September 11, 2001, would change the course of history. As a matter of national security and in the best interest of our country, he ordered that all aircraft be grounded until such time that it could be deemed safe. This was another first in the history of our country. Moreover, his foresight and passion for civil liberty would usher in a new era within the Department of Transportation. The Secretary was instrumental in leading the charge to ensure that all travelers in the United States be treated equally, without fear of being racially profiled or unjustly harmed.’

“Please join me in honoring a living treasure, Secretary Norman Yoshio Mineta, for his remarkable and distinguished life accomplishments and his untiring dedication of service to become a leader to his community and his country. Colleagues, Mr. President, for those in the gallery, please welcome back to Hawai’i Secretary Norman Yoshio Mineta.”

At 12:00 p.m., the Senate stood in recess subject to the call of the Chair.
