Tuesday, April 5, 2016

The Senate of the Twenty-Eighth Legislature of the State of Hawai'i, Regular Session of 2016, convened at 11:35 a.m. with the President in the Chair.

The Roll was called showing all Senators present with the exception of Senator Slom who was excused.

The President announced that he had read and approved the Journal of the Forty-First Day.

At this time, Senator Espero welcomed former State Senator and Senate President Robert Bunda, who was present in the gallery with his sons, JR and Robson Bunda.

Senator Wakai recognized the United States Small Business Administration's State of Hawai'i Small Business Award recipients, and presented the following remarks:

"Thank you, Mr. President. Hawai'i is open for business: Many of those doors are being opened by the Hawai'i Small Business Administration. Under the leadership of District Director Jane Sawyer, the SBA has nurtured thousands of small businesses that benefit all of us. Over the last three decades, the Small Business Administration of Hawai'i has recognized those who have proven their excellence in small business. These awards continue to be the most competitive and comprehensive awards presented in the State of Hawai'i. Today's winners are both entrepreneurs and advocates, and have proven that they have the drive to turn adversity into great opportunity.

"Our first honoree is Jayna Uyehara. Jayna is the 2016 Small Business Advocate for Veterans. As the manager of the Business Action Center for DCCA, Ms. Uyehara keeps the Business Action Center focused on assisting Hawai'i's small business owners. Under her leadership, the agency has established several centers on the neighbor islands and extended partnerships to get important information about business licensing and startup requirements to more individuals in our community.

"Going above the basic duties of her position, Jayna plans and participates in more than 30 activities each year, including Boots to Business for veterans, following up on SBA officers on veteran-owned businesses, and the Kaneohe Marine Corps Base programs assisting spouses on base; as well as the Patsy Mink Center for Business & Leadership.

"Here to help Jayna celebrate the honor is her nominator, Naomi Masuno of Bank of Hawaii; I believe Naomi is in the gallery. Thank you, Naomi. Congratulations, Jayna. Mr. President, with your permission, I'd like to yield my time to fellow colleague Senator Michelle Kidani."

Senator Kidani rose to present the following remarks:

"Thank you, Mr. President; thank you, Senator Wakai. Colleagues, it is my privilege to introduce Elsa Talavera, president of All Island Case Management Corporation. Thank you. Elsa is a registered nurse, and in that role, she was in a position to recognize the need for healthcare services outside the traditional hospital setting. She established her healthcare case management company and quickly adopted the highest of operating standards that many others in Hawai'i now aspire to. Elsa's company works with an extensive network of nearly 300 quality care homes. She provides them with regular updates on changes in the laws that affect their operations. She also makes sure that this growing industry is kept current on best practices in care home operation.

"Along the way, Elsa has helped to provide opportunities for new nursing graduates to enter the field. She works with nursing professional organizations, social workers, healthcare administrators, and countless community organizations to assure the best health care possible for those who choose the care home alternative.

"For her good work and solid reputation in the case management field, Elsa Talavera is being recognized as the 2016 Women in Business Advocate for the State of Hawai'i. Congratulations, Elsa; mahalo for your good work and your well-deserved recognition.

"Mr. President, Elsa has several guests in the gallery this morning; first and foremost is her husband, Edgar. Also in the gallery this morning are two of Elsa's associates from her company, Vangie Abellada and Charmen Valdez; also, Angeline Shiroma, who nominated Elsa for this year's award.

"Finally, Mr. President, I would be remiss if I did not note that Elsa is a resident of Mililani. I am proud to acknowledge her as a neighbor and another outstanding member of our community. I now yield the floor to Senator Ihara."

Senator Ihara rose to present the following remarks:

"Mr. President, good morning. It is my honor to introduce SBA's 2016 Small Business Advocate for Minority-Owned Businesses, Julie Percell, owner of 21st Century Marketing. For over 24 years, Julie has supported the dreams of Hawai'i's entrepreneurs by providing leadership and training in marketing, sales, promotions, market research, financial management, venture capital, customer service, and price modeling. In the past five years, Julie worked with SBA to help establish the successful Emerging Leaders accelerator program that has graduated over 60 CEOs and created new jobs and increased annual sales. She is also active with SBA's Women in Business Committee and the Mink Center for Business and Leadership.

"Julie's award nominator, Winfred Cameron of American Savings Bank, says Julie is not known for keeping normal working hours - because student entrepreneurs don't. And her colleagues agree, calling her a 'tireless advocate for small business and promoting integrity in business, marketing, and advertising.' Julie recognized the need for business support in the Native Hawaiian community, so she partnered with the Office of Hawaiian Affairs and other organizations to provide training, coaching, and enabling entrepreneurship specifically for the Native Hawaiian community. One of her clients said, 'Not only was the class informative – covering everything from A to Z – Julie was knowledgeable, experienced, and, above all, possessed a real desire for helping all of her students succeed. And to top it all off, she was Hawaiian at heart.' It is these qualities, combined with her extensive business knowledge, that contributes to Julie's success. Hawai'i's small-business community is indeed fortunate to have the support of someone like Julie Percell.

"Please join me again in congratulating Julie for this year's award. Mr. President, in the gallery, I'd like to also recognize Julie's husband, Jimmy Percell, and Julie's nominator, Winfred Cameron. Thank you. Thank you, Mr. President. I now yield the floor to Senator Green."

Senator Green rose to present the following remarks:

"Thank you, Mr. President. It's my distinct pleasure to make the next award announcement. This is for the 2016 Family-Owned Small Business for the State of Hawai'i. This award honors family-owned and -operated businesses with more than a 15-year history and have passed their ownership across generations from one to another. In this case, it's for Kealakekua Ranch, and we're honoring Meg Greenwell and Nick Greenwell and Rhonda Kavanaugh.

"First, let me say that, established in 1881, Kealakekua Ranch has succeeded for more than 130 years under the guidance of four generations of the Greenwell family, and they're now led by siblings Meg and Nick. Transitioning over the generations from cattle ranching operations to ag and commercial operations, today Kealakekua Ranch includes a regional shopping center and independent food market, ChoiceMART, which was started in 2000, and this new venture has created over 70 new jobs. They have over 52,000 square feet of retail space at their center, and Kealakekua Ranch leases to restaurants, medical practices – which are essential to Kona – service industries, and retail outlets to provide the necessary products and services to all of our local residents and businesses.

"The ranch is a major employer, as I've said, and is a hub of the South Kona community, providing employment opportunities and really supporting hundreds of local farmers, ranchers, and fishermen by featuring local produce – which we've been emphasizing here – grass-fed beef, fresh-caught fish from the waters off of our coast, along with other natural products from the island. They create business strategies and market awareness by combining their long-term commitment to their community – they're legendary in the community – and the next generation continues to be a formula of success for the Greenwell family and West Hawai'i. We're so honored to have you; let's give them a round of applause. And Mr. President, with your permission, may I yield time to my fellow colleague, Senator Chun Oakland?"

Senator Chun Oakland rose to present the following remarks:

"Thank you, Mr. President. I have the honor of speaking about Maui Varieties, Ltd., for being the 2016 Entrepreneurial Success of the Year for Small Business Administration. With us today is Guy Kamitaki; congratulations for being here. Guy Kamitaki is one of the officers of Maui Varieties, Ltd., and he, along with Wayne, Paul, and Lynn, represent the third generation of the Kamitaki family to own and operate this thriving chain of craft and hardware retail stores in Hawai'i, with locations on the West Coast as well as here locally in Hawai'i

"Best known for their 28 HouseMart Ace Hardware and HouseMart Ben Franklin stores, Maui Varieties, Ltd., is the parent holding company for five wholly owned subsidiaries. The small business was started 65 years ago by an industrious female barber, Shikano Kamitaki, who purchased a dry-goods store in Kahului and later acquired a franchise for their first Ben Franklin store. As the business grew, it was on to Hilo then to O'ahu to develop four more stores with this brand. In 1978, they took on the Ace Hardware cooperative and soon had 14 stores across the islands. Expansion and diversification efforts started in the 1990s, a strategy to allow the company to compete with big boxes entering the local market, and continues today. SBA entered the picture in 2004, with SBA funding to purchase the Kamuela store.

"From its humble beginnings, Maui Varieties has created over 478 jobs, generated millions of dollars for the state, and provided opportunities within their organization for budding entrepreneurs and crafters. It is with great pleasure that we would like to recognize Maui Varieties, Ltd. Congratulations. I would also like to ask anyone who is here from Maui Varieties, if you could please stand and be recognized as well. Thank you very much. Thank you, Mr. President. Mr. President, with your permission, I yield my time to fellow colleague and final presenter, Senator Brian Taniguchi. Thank you."

Senator Taniguchi rose to present the following remarks:

"Thank you, Mr. President; thank you, Senator Chun Oakland. It's my pleasure this morning to introduce the 2016 Young Entrepreneur of the Year, Kurt Milne. He and his partner, David Farmer, run Aloha 2 Go. Aloha 2 Go is O'ahu's largest online restaurant marketplace, allowing customers to order food and delivery from over 85 local restaurants and food menus. Specializing in B2B, corporate, and office catering, the company has facilitated over 125,000 food deliveries and generated millions in additional sales for their restaurant partners since 2010. The owners have strategically built Aloha 2 Go into one of the largest single-market delivery companies in the nation

"Kurt and partner David have secured SBA financing for two different phases of their fast expansion, in 2010 and again in 2015. Much of the capital has gone to staffing, obtaining a liquor license, printing a quality promotional magazine, and opening an 'Aiea office. These enterprising young men have created 13 full-time positions and plan to achieve their goal of reaching the entire O'ahu market in 2017. Another hand for Kurt and Aloha 2 Go. He was nominated by Jared Kashiwabara and Michael Libertini of Bank of Hawaii. Also sitting in the gallery is Kurt's partner, David Farmer. Mr. President, I'd like to yield my time back to Senator Wakai."

Senator Wakai rose and stated:

"Thank you, Mr. President. Colleagues, there are other award winners in our gallery today. First is Mabel Hashisaka of the Kauai Kookie company – she has won the Lifetime Legacy award; Barbara Bennett of For Kaua'i Magazine, Small Business Advocate of Journalism and Media; also Art Taniguchi of Bank of Hawaii, Small Business Advocate for Financial Services; Raymond Jardine of Native Hawaiian Veterans, LLC, Small Business Person of the Year for the State of Hawai'i; Toshihisa Aoki of Hawaiian Fresh Products, Small Business Exporter for the State of Hawai'i; Pamela Tumpap of Maui Chamber of Commerce, Small Business Advocate for Industry and Business. Those are our winners for 2016; members, if we could give them a round of applause. Thank you, Mr. President."

Senator Baker recognized and honored the Bennett Foundation, and presented the following remarks:

"Thank you, Mr. President. Colleagues, it is my distinct honor and privilege to introduce Michael Bennett, Jr. and his wife, Pele. Michael and Pele are founders of the Bennett Foundation, and they're here for their third annual OCEAN Health Fest, to be held on April 23, 2016, at the Kroc Center, and the fourth annual Michael Bennett Football Camp, to be held at the University of Hawai'i on July 9, 2016.

"Seattle Seahawks defensive lineman – and, Mr. President, I tried to wear at least some Seahawks colors today – Michael Bennett and his wife grew up in Houston, Texas, not very far from my hometown, although when I mentioned that to the Bennetts, Michael said he didn't have really very good food there. I can appreciate that – probably lots of fried stuff and not very healthy. But in their many trips to Hawai'i to visit Pele's family living in Lā'ie, Hawai'i grew on them and really came to be a special place in both Michael and Pele's hearts. Their love for the islands has led them to make Hawai'i their off-season home.

"In 2014, Michael participated in a roundtable discussion at the Hawai'i State Capitol to address the growing epidemic of obesity in Hawai'i. At the time, many campaigns were pitched to be rolled out in a five-year plan. Michael and Pele realized the urgency of the matter and, without hesitation, created the Bennett Foundation with the vision of effecting positive change in the wellness of our state. Within three months, the inaugural

OCEAN Health Festival was held at Saint Louis School on Oʻahu

"Now, OCEAN is an acronym for 'Tackling Obesity through Community Education, Activity and Nutrition.' Through the Bennett Foundation, all activities in the weeklong OCEAN Health Festival are provided free to all participants. Attendees are provided with valuable information on making better choices that is hoped will help lead to positive health changes and a healthier lifestyle. Events include cooking demonstrations with local celebrity chefs, a family health day, health screenings, and a series of football-related youth camps.

"So, please once again join me in honoring Michael and Pele Bennett for their dedication and tireless efforts to promote, educate, and advocate for a healthy and active lifestyle for the people of Hawai'i – welcome home. Colleagues, we're joined in the gallery by some other folks with the Bennett Foundation: executive director Kevin Chang, board member Elix Villafuerte; Vicky Villafuerte, another board member; and Ross Oshiro. Thank you all for joining us today."
