### Wednesday, April 6, 2016

The Senate of the Twenty-Eighth Legislature of the State of Hawai'i, Regular Session of 2016, convened at 11:49 a.m. with the President in the Chair.

The Roll was called showing all Senators present with the exception of Senators Slom and Thielen who were excused.

The President announced that he had read and approved the Journal of the Forty-Second Day.

Senator Gabbard honored and congratulated Dr. Samuel M. 'Ohukani'ōhi'a Gon, III, and presented the following remarks:

"Mr. President, colleagues, guests in the gallery: We have with us today Dr. Sam 'Ohukani'ōhi'a Gon, III. You may have heard of Dr. Gon; I have, over the years, but it was actually on February 18th, when I was watching the evening news when they did a piece on Sam and it was called 'The MVP,' and as baseball season has begun, you know what that means, 'Most Valuable Person.' And if Sam looks a little surprised, we brought him down here kind of deceitfully: He had an appointment with me to talk about rapid 'ōhi'a death in my office; he had no idea that he was being honored on the Senate floor today.

"It's not often we meet someone who not only embodies the accomplished training of dual cultures but is able to meld these two worlds into a successful lifelong career respected by both scientific and Hawaiian communities. Dr. Gon has an illustrious background in Western academia with a personality that exudes our genuine aloha spirit. He's been trained professionally as a Western scientist, earning a master's degree in zoology and a PhD in animal behavior from UC Davis. Since joining The Nature Conservancy of Hawai'i in 1986, he's filled the roles of director of science, paleobiologist, and teacher. He currently serves as a senior scientist and cultural advisor. Dr. Gon is on the Board of Trustees of the Native Hawaiian Culture and Arts Program, the Advisory Council of the Bernice Pauahi Bishop Museum Association, and affiliate faculty for the Department of Urban and Regional Planning at UH Mānoa.

"But these titles only tell half the story. Under Kumu John Lake, a master of religion and cultural protocol, our brother Sam underwent the traditional Hawaiian 'ūniki rites of passage to attain the status of kahuna kākalaleo, master of Hawaiian religion and practitioner of Hawaiian chant, hula, and protocol. Sam also serves as the kahuna pule at the heiau of Pu'u Koholā at Kawaihae, Hawai'i island, with Nā Wa'a Lālani Kāhuna o Pu'u Koholā.

"With more than 40 years of experience in Hawaiian ecology and extensive knowledge of Hawaiian culture, history, and language, Sam admits, and I quote, 'It's been an amazing journey.' It has been one that has taken him to places few people ever see, from his training at UC Davis to a journey to remote rainforests, cinder cone deserts, lava tubes, streams, and pools. In seeking to blend culture and conservation, Dr. Gon has traveled the globe and provided his island conservation expertise in the Galápagos Islands, the Philippines, Pohnpei, Palau, Jamaica, Okinawa, Amazonia, and Rapa Nui, and, of course, here at our home in Hawai'i nei.

"He said on a recent TED Talk, and I quote, 'If you want to define one place on Earth to represent the full range of ecosystems that the planet can offer, it would be the Hawaiian Islands.' Dr. Gon has dedicated his life to the preservation and management of the remarkable bio-cultural diversity that exists in our island paradise, from the conservation of native biological diversity to the connections between the natural world and indigenous culture of Hawai'i. He serves on the Endangered Species Recovery Committee and believes that protecting these species and ecosystems is protecting Hawaiian culture. Sam studies what we had, what we've lost, and what remains, and is alarmed by the degree to which Hawaiians' ecological footprint has increased from less than 15 percent to 70 percent while levels of self-sufficiency have sorely declined from 100 percent to less than 15 percent.

"In 2006, Dr. Gon was appointed by the governor to the State Board of Land and Natural Resources. In 2014, he was named a Living Treasure of Hawai'i by the Honpa Hongwanji Mission. So today, we honor and commend Dr. Gon for his dedication to the environmental, historical, and cultural preservation of our precious and unique Hawai'i nei. Please give him another warm hand. And also in the gallery with us today – unfortunately, Dr. Gon's wife of 30 years, Sheri, could not make it, but we do have the executive director of The Nature Conservancy of Hawai'i, Ulalia Woodside, as well as Director Suzanne Case from DLNR, and any of the others from The Nature Conservancy; please stand so we can honor you. Thank you all for coming; aloha. Thank you, Mr. President."

Senator Dela Cruz celebrated Architecture Month during the month of April, and presented the following remarks:

"Thank you, Mr. President and colleagues. Today, to help us observe and celebrate April as Architecture Month, we have with us Ben Lee, president of the American Institute of Architects, and I think many of us would agree that he was probably one of the best managing directors the city ever had; Daniel Friedman, the dean of the University of Hawai'i at Mānoa School of Architecture; Judith Stilgenbauer, director of academic affairs and associate professor; and Jeff Chen, president of American Institute of Architects for the students. Please rise and be recognized.

"The AIA – American Institute of Architects – each year celebrates Architecture Week in April, but in Hawai'i, the Honolulu chapter celebrates Architecture Month due to many activities they schedule for this event. AIA Honolulu, founded in 1926, initiated Architecture Month to promote design excellence in Hawai'i's built environment and highlight the power of good design in making communities better places to live, work, and play.

"Hawai'i offers one of the world's richest settings for the study of built and natural environments, and the UH Manoa is well-situated to engage design inquiry and experimentation. Among the members of the faculty of the School of Architecture are experts in tropical and landscape architecture, affordable housing, digital fabrication, design communication, building performance, Asian and Pacific urbanism, and urban ecological design. UH Mānoa offers a doctorate of architecture degree, the only one in the country, and is accredited by the National Architectural Accrediting Board, NAAB. Those who earn the doctorate are eligible for licensure as registered architects in all 54 U.S. jurisdictions, including Hawai'i, and prepare students for leadership in the professional workforce. Graduates who become an AIA member signify that they adhere to a professional code of ethics and share AIA's goal to build a better place for people to live, work, and play.

"For the tenth annual Architecture Month, among the many activities AIA Honolulu has planned is the return of the popular architectural walking tour of historic Waikīkī; the first ever Architecture Month Sketch Events; a firm crawl, when architecture companies open their doors to the public; a threeclass series of a field practice of architectural shoot; and a film night for a free screening of *Urbanized*, a documentary about the design of a modern city, which serves as a catalyst for discussion on the future of cities in Hawai'i. Thousands of island residents and visitors have enjoyed and continued to enjoy architecture and design-related events each April during the past 10 years. We join in observance of Architecture Month and look forward to this event continuing for many years to come.

"So, thank you for being here. We also have with us in the gallery today Abby Spencer, AIA Honolulu executive VP; Mayumi Hara, board secretary; Chris Hong, board VP/president-elect; Jason DeMarco, director; Jason Takeuchi, associate director; Dan Chun, president, Hawaii State Council; Purnima McCutcheon, director; and Lorena Yamamoto. And for many of you, I'd like to introduce to you one of my professors and my classmates: Cathi Ho Schar and Eli, and my classmates Lynn, Jay, Adaline, and Erin. So, if you think you have to put up with me ... And for all the other supporters for Architecture Month, please stand and be recognized. And I know he doesn't want to be mentioned, but for many of us, our friend up there, Dwight Mitsunaga – he's also here to support Architecture Month. Thank you, Mr. President."

Senator Green recognized Home Depot for its contributions to the community, and presented the following remarks:

"Thank you. We're going to go from architecture to building. If I could have Amare, Tamara, and Susan please stand. Mr. President, today I'd like to recognize, on behalf of the Senate, The Home Depot, an organization who steps up. The Home Depot is being recognized by us today for its leadership in our community, particularly on impact projects that they've been doing in partnership with members across the state -SpringStar is a company that they've been working with - to disrupt and control the breeding of dengue-bearing mosquitoes. As we all know, that's been a big problem for us on the Big Island this year. Over the past weekend, The Home Depot, in partnership with this company, has held training opportunities across the Big Island, in Kona and Hilo: They're training our citizens to step up and really help mitigate the disaster that has occurred from an infectious-disease standpoint. By preventing the spread of dengue fever and Zika, they help us all, and that education has been invaluable.

"They've also been very active in other areas; Home Depot has been a community activist and an organization that delivers for our veterans' community. They completed 13,000 homes for veterans across the country in 2015, many of them here. They've also worked on several projects around the island in partnership with IHS and are currently working on the beautification of the Sand Island homeless shelter through their container-homes program. They've donated millions of dollars to community impact projects through their grant program, and they do 2,000 community projects every year nationally.

"And today, they have some of their leadership team, and they emphasize 'team' at their company. We have Amare Belay, who was born in Ethiopia. He was 25 when he came to the United States. He's been working at The Home Depot these many years – started at an entry-level position and quickly became an associate and worked his way up into management. He's a store manager – and we know how big these stores are – and a community event coordinator, doing these great works for us in Hawai'i. So I wanted to recognize him; he's been recognized numerous times, but he's just a fantastic guy.

"With him are impressive associates Tamara DeSelms, who's the district human resources manager providing human resources support to the eight stores in Hawai'i and Guam. And without her support, we couldn't get to these great programs, either. So a round of applause, please. Then we have Susan Amaral, who's also a district manager for Home Depot in Hawai'i and Guam, who also has been invaluable in these community projects.

"And if I may, Mr. President, there were two other individuals who couldn't be with us today: Ryan 'Keoni' Queypo – he's a father of four from 'Ewa Beach. He's been employed for 17 years as an assistant manager, 13 years as a store manager, and is also a district manager who contributed to these programs. Diana Kelly, who's been with the company since 1991, starting as a cashier, working her way up to vice presidency, also contributing meaningfully in these programs. And then there was one other individual who's not with the company, but his name is Jay King, and I think many of you were able to meet Jay when he was working as an associate of Congresswoman Tulsi Gabbard. He brought a lot of these projects together and really has been indispensable when getting the community activity works together. So, thank you all for helping us on dengue fever and for our veterans."
