Friday, April 8, 2016

The Senate of the Twenty-Eighth Legislature of the State of Hawai'i, Regular Session of 2016, convened at 11:48 a.m. with the President in the Chair.

The Roll was called showing all Senators present with the exception of Senators Kim, Ruderman, Slom, and Thielen who were excused.

The President announced that he had read and approved the Journal of the Forty-Fourth Day.

At this time, Senator Taniguchi introduced Dr. Colleen Sathre, vice president emeritus of the University of Hawai'i and gubernatorial nominee to the Western Interstate Commission for Higher Education, who was seated in the gallery.

Senator English recognized members of the International Fellows program at the National Defense University, representing more than 53 nations, who were present in the gallery. Senator English remarked that the fellowship gives international military and civilian leaders the opportunity to study at either the Eisenhower School or the National War College, and awards a master's degree to the fellows upon completion of the academic program. Senator English then described the program objectives as preparing future leaders of the armed forces and civilian agencies for high-level policy, command, and staff responsibilities; providing an understanding of the factors and considerations that shape U.S. security policy and strategy; developing firsthand knowledge of the social, political, and economic factors that shape U.S. institutions; and enhancing the professional qualities of the International Fellows program.

Senator Green introduced a group of massage therapists who were present in the gallery.

The Chair extended an additional welcome to the massage therapists.

"The Regulated Industries Complaints Office (RICO), a division of the Department of Commerce and Consumer Affairs (DCCA), investigates allegations of professional misconduct by licensees and any unlicensed activity suspected in Hawai'i. This bill will establish a unit within RICO to investigate complaints involving licensees in various medical professions regulated by DCCA.

"Regulating scope of practice issues and well a practice standards is difficult. Such matters are often more complex than others under RICO's purview and often require delicate handling due to the sensitive nature of the subject matter and the potential for severe harm to consumers. This bill will enable RICO to more timely and effectively investigate complaints against medical professionals by establishing five new positions – four Field Investigators and one Staff Attorney – to focus exclusively on investigating medical cases.

"Patient safety is of paramount importance in our community, and a crucial aspect of ensuring it is a timely examination of complaints regarding medical practitioners. A theoretical model provided by the Hawaii Medical Association shows that within a 15-month time frame, a single clinician delivering anesthesia can affect as many as 2,000 people. With the safety and wellbeing of so many patients at stake, investigating complaints in a timely manner is vital.

"Creating a specialized unit for these complaints will also free up the currently overburdened RICO investigators to more timely respond to other consumer complaints. Your Committee on Commerce, Consumer Protection, and Health received only supportive testimony. I ask my colleagues to please stand with me in strong support of H.B. 1627. Thank you."

"Colleagues, as we end our week here in this chamber, over in Hilo at this very moment at St. Joseph Catholic Church rests a young, beautiful 12-year-old girl, Emily Luis Quinajon, surrounded by her parents, Ricky and Evelyn; her younger twin siblings, Eric and Raelyn; and Emily's family, friends, classmates, and others who cared so deeply about her.

"Emily is a beautiful sixth grader at Waiākea Intermediate School. She's vibrant; she loves reading; she loves the arts and crafts, and her favorite place in Hilo to go to is Ben Franklin. One day in 2014, Emily started to notice a pain in her left leg. Her parents, like all of us with teenagers, brushed it off as growing pains. There was no redness; there was no trauma. It should have gone away. But when Emily started limping, they went to their pediatrician, who found a tumor.

"Emily and her parents made what would be the first of many, many trips to Kapi'olani Women's and Children's Hospital, and she was diagnosed with osteosarcoma, a type of bone cancer that affects teens and children. In July of 2014, Emily endured a 14-hour surgery to remove her femur bone and its tumor, and they replaced it with a donor bone. Since 2014, Emily has endured multiple chemotherapy treatments, and as a result of the treatments, her heart was damaged and she was diagnosed with congestive heart failure. Also, in 2015, she had a surgical tumor resection, and in January of 2016, just three months ago, was diagnosed with liver failure.

"Desperate, Emily and her father flew to Stanford University, to the Lucile Packard Children's Hospital, to evaluate her for a heart transplant. It would be her last trip from the islands. Emily took her last breath and passed away peacefully on March 30th at Stanford, surrounded by her family.

"Although I never had the honor to meet Emily, and neither will any of my colleagues, Emily wanted everyone to know she loved them all and how much she appreciated their aloha and support. Colleagues, Emily was a fighter; she was kind; she was generous; she always thought of others; she loved her home in Hilo, and she loved her family. For the 12 years Emily had the privilege to spend on this earth, she cherished every minute of it.

"Mr. President, at the appropriate time, may I request a moment of silence for Emily Luis Quinajon? Thank you, Mr. President."
