

FORTY-NINTH DAY

Monday, April 18, 2016

The Senate of the Twenty-Eighth Legislature of the State of Hawai'i, Regular Session of 2016, convened at 11:34 a.m. with the President in the Chair.

The Roll was called showing all Senators present with the exception of Senators English, Galuteria, Slom, and Thielen who were excused.

The President announced that he had read and approved the Journal of the Forty-Eighth Day.

At this time, Senator Chun Oakland, on behalf of Senator Slom, remarked on the life of Charles Ewart, noting that after almost a decade of honorable service with the U.S. Marine Corps, earning a graduate degree in engineering from Cornell University, and working as a civil engineer and consultant for four decades, Mr. Ewart dedicated his retirement to contributing to his community in many ways, including coaching youth sports, volunteering with the Sony Open, and teaching English to adults. Charles Ewart loved teaching, and spent countless hours outside the classroom creating fun and creative lessons to help others improve their English, as well as volunteering for hundreds of hours at Hawaii Literacy's Drop-In Center to teach English to adults and to help them reach their educational, career, and personal goals. Senator Chun Oakland shared that Charles Ewart's family, students, and colleagues continue to miss his caring presence and enthusiasm and joy in helping others learn, and recognized the following guests in the gallery: his wife, Terry Ewart; his son, Charles Ewart IV; his brother-in-law, Norbert M. Buelsing; his sister-in-law, Christine A. Olah; and Suzanne Skjold, executive director of Hawaii Literacy.

Senator Green introduced civic leader Bo Kahui, who was seated in the gallery.
