At this time, Senator Riviere rose to speak on a point of personal privilege as follows:

"Thank you. Members, we've had a robust debate on House Bill 2501, and that's coming up for a final vote on Tuesday. In light of the discussions that we've had, there are a couple of questions that I do not believe have been specifically answered, and so at this time, I'd like to invoke Rule 86 of our Senate Rules, and I'll be sending a letter to Suzanne Case, director of Department of Land and Natural Resources, to ask the two following questions: One, does BLNR have the authority to issue revocable permits to Alexander & Baldwin for its diversion of water from East Maui that would allow Alexander & Baldwin to use water for the remainder of their sugar operations in Central Maui? Second question: Will you include on a near-future agenda of the Board of Land and Natural Resources an item to allow the board to consider granting new revocable permits to Alexander & Baldwin for the diversion of water through the anticipated end of sugar cultivation in Central Maui?

"So, I have a letter here that we'll be emailing tonight to the director, and we'll have the original hard copy hand-delivered on Monday, and according to rules, they should respond by the next business day, so we'll circulate that appropriately, and I hope that will help inform us for our final votes on Tuesday. Thank you."

Senator Thielen rose to speak on a point of personal privilege as follows:

"Members, I know many of us send out surveys to constituents. I've been doing some surveys online to constituents, and I got a comment back today that made me think about it. When I'm giving them a list of bills to vote on that we're going to be voting on and asking them how they would vote, I'm telling them that they have three choices in their vote: They can vote 'no'; they can vote 'yes'; or they can vote 'yes with reservations.' And I got a comment back today from somebody who's been taking these surveys who said, 'You know, I didn't want to vote straight 'no' on this measure, so I ended up voting 'yes with reservations,' even though I'm really opposed to it.' And I started thinking about that and about how we have this 'yes with reservations,' but our only choice for 'no' is just a straight-up 'no.' So, I wanted to propose, maybe to test out on Tuesday when we're voting, that we could vote 'yes,' 'yes with reservations,' 'no,' or 'no with regrets.' So just a thought to think over over the weekend. Thank you."
