#### TWENTY-EIGHTH DAY

### Monday, March 13, 2017

The Senate of the Twenty-Ninth Legislature of the State of Hawai'i, Regular Session of 2017, convened at 11:36 a.m. with the President in the Chair.

The Roll was called showing all Senators present with the exception of Senator English who was excused.

The President announced that he had read and approved the Journal of the Twenty-Seventh Day.

At this time, Senator Galuteria welcomed guests from Winnipeg, Manitoba, Canada, who were present in the gallery.

Senator Chang congratulated and commended the 2017 Narcissus Queen and her court, and presented the following remarks:

"Since 1950, the Chinese Chamber of Commerce has held the annual Narcissus Festival. It was organized to preserve and showcase Chinese art and culture. This year marked the 68th crowning of the queen and her court at the annual Narcissus Festival and Pageant. The pageant selects four princesses and one queen to comprise the Narcissus Court. In addition to their natural beauty and poise, the Narcissus Pageant contestants must undergo rigorous preparation to demonstrate their understanding and appreciation of Chinese culture, history, art, and cuisine.

"This year's fourth princess of the court is Stella Chow. Stella was born in Hualien City, Taiwan. She is currently a student at Kapi'olani Community College studying pre-nursing. She is currently the president of the Tzu Chi Collegiate Association for Hawai'i. Her hobbies include singing, dancing, listening to music, playing the guitar, performing sign language, traveling, volunteering, and learning. Her goal is to eventually complete a degree in nursing and to become a forensic scientist.

"Mr. President, with your permission, and to begin introductions of the Narcissus Court we will be honoring today, I yield my time to our colleague Senator Rhoads."

At this time, Senator Baker rose to speak on a point of personal privilege as follows:

"I note with great pleasure that the Governor did, in fact, send us down governor's messages for nominees to various boards and commissions. There were about 25 that are referred to the Committee on Commerce, Consumer Protection, and Health, but I would note for the record that there's about 40 still outstanding. Those are for many of our licensing boards, and those boards cannot operate without quorum. And if you look at some of the ones that are vacant – there are four, five, six vacancies on the board – and the importance of a licensing board is not just for the licensees to get their license renewed, but it's also consumer protection. These boards review complaints against licensees. So I'm hoping that the governor will encourage his boards and commissions folks to send down more of the names so that we can hold hearings on them before we go into conference. Mahalo."
