Thursday, April 6, 2017

The Senate of the Twenty-Ninth Legislature of the State of Hawai'i, Regular Session of 2017, convened at 11:51 a.m. with the President in the Chair

The Roll was called showing all Senators present with the exception of Senator English who was excused.

The President announced that he had read and approved the Journal of the Forty-Fourth Day.

At this time, Senator Ihara recognized a group of fifth-grade students from King Liholiho Elementary School, who were seated in the gallery with teachers Lynn Sakata and Fred Magnenat, and chaperones Kat Yamashiro and Kelly Lopes.

Senator Ruderman welcomed a group of sixth-grade students from Ke Kula 'o Nāwahīokalani'ōpu'u Iki Laboratory Public Charter School in Kea'au, who were visiting Honolulu to learn about state government. The students were present in the gallery with teachers Pele Harman and Aisha Tanaka, and parent chaperones Kaiolohia Masaoka, Hi'ilei Vuta, Ranell Sioloa, Keli'i'ikeole Kalauoka'a'ea-Kahele, Keone Roback, Kekoa Harman, and Warren Elvena.

The students then sang "Kula'iwi" to an 'ukulele accompaniment for the members of the Senate.

It is important to note that Chapter 514B has superior and additional consumer protection measures not present in 514A, and that a repeal of 514A would create not only clarity in the law, but also protect Hawai'i condominium owners. Please join me in supporting H.B. 243, H.D. 2, S.D. 1. Thank you."

If identity theft is suspected, caregivers or other representatives can place a freeze on the account to stop the illegal activity.
