Thursday, April 20, 2017

The Senate of the Twenty-Ninth Legislature of the State of Hawai'i, Regular Session of 2017, convened at 11:33 a.m. with the President in the Chair.

The Roll was called showing all Senators present.

All of these individuals are outstanding members of our community and will be serving us through their participation on these boards and commissions either as licensees or public members, and I ask all of my colleagues to advise and consent to their nominations."

Senator Tokuda rose to speak in support of the nominee as follows:

"I have some comments in strong support of this Governor's Message that I would like to have inserted into the Journal, but just briefly: I think Laurel is no unfamiliar face to this body, having served us very well in this chamber, so, obviously, it is with great honor and pleasure that I stand before you to speak in strong support of her nomination as deputy director for the Department of Budget and Finance. She is going to be a trusted source for us to work with this administration on some of the toughest issues that we face - someone we can trust as we consider the fiscal struggles and challenges of our state, but also someone that we know will be able to also make sure that we can grow our economy as well. With over 20 years of public service, Ms. Johnston has experience working with large, complex budgetary and fiscal systems. She previously served as Assistant Superintendent in the Planning, Budget and Resource Development Office at the Department of Education, and was the Director of the Budget Office for the University of Hawai'i System. Ms. Johnston most recently served as Deputy Chief of Staff in the Office of the Governor, a role in which she displayed a strong work ethic and sound judgement.

"Ms. Johnston would bring to the job a wealth of knowledge and expertise that will serve the State well in creating a fiscally responsible and prudent budget. I believe she possesses the necessary administrative ability, integrity, and honesty to succeed as Deputy Director of the Department of Budget and Finance, and I remain in strong support of her nomination."

Senator Tokuda then moved that the Senate advise and consent to the nomination of DAMIEN ELEFANTE as Deputy Director of the Department of Taxation, term to expire December 3, 2018, seconded by Senator Dela Cruz.

Senator Tokuda rose to speak in support of the nominee as follows:

"I also have some additional remarks I'd like to have inserted in the Journal in strong support of this governor's nominee for the deputy director of Department of Taxation as well that I'd like to have put in, but just briefly: Damien is definitely a very strong candidate who has come to work very closely with our Ways and Means committee. It is no small task to be charged with making sure that our revenue collections are strong, and we know that it has been a very difficult task indeed, but he has definitely risen to the challenge. Every day that he comes by, he assures us that it is his job to make sure that the relationship he builds with us is one of trust. He works very hard with his team to make sure that every dollar that is owed to the state he will collect, and we know that he takes the challenges before him extremely seriously, so that Laurel has money to be able to pay for the programs and services we need – we know he is out there, hunting every day for those tax dollars that our children here in the gallery deserve.

"So, the two nominees that we have before us, while it may be deputy director positions, they are very, very strong candidates who are serving our state and this administration very well, which is why I'm extremely proud to be recommending them for advise and consent. And they, I can tell you, are working very closely with your Ways and Means committee to be sure that the budgets we put forward, the bills we put forward, have the good information and data that is required to make our decisions. So it's with great honor and it's a privilege to recommend for this body's consideration the nomination of Damien Elefante. Thank you very much."

The Chair having so ordered, Senator Tokuda's additional remarks read as follows:

"I am in strong support of the nomination of Damien Elefante as Deputy Director of the Department of Taxation. Mr. Elefante's extensive knowledge of our State's tax laws are an invaluable asset in allowing him to successfully serve the taxpayers of Hawai'i. He has previously served as the Deputy Attorney General assigned to the Department of Taxation. There he developed a deep understanding of the Department's operations having provided legal advice and litigated cases regarding issues such as the management of taxes, bankruptcy, collections, refunds, and foreclosures. Mr. Elefante most recently served as the Compliance Coordinator at the Department of Taxation. During that time, he worked successfully with the department's auditors to facilitate the auditing process and was responsible for reviewing compliance reports from all branches. I believe Mr. Elefante's professionalism, thoughtfulness, and dedication to public

service make him an excellent candidate for the Deputy Director of Taxation, and I am in strong support of his nomination."

At this time, Senator Nishihara, Chair of the Committee on Public Safety, Intergovernmental, and Military Affairs, rose to request a waiver of the notice requirement pursuant to Senate Rule 21 for the following measures:

H.C.R. No. 55; H.C.R. No. 133; H.C.R. No. 134, H.D. 1; H.C.R. No. 157, H.D. 1; and H.C.R. No. 158. Senator Nishihara noted:

"These HCRs are important for the public safety to improve our prison system. They were not able to be considered earlier."

The Chair granted the waiver.

Senator Nishihara then announced that the Committee on Public Safety, Intergovernmental, and Military Affairs would be holding a public hearing on the measures the following morning at 8:00 a.m. in Conference Room 312.

Senator Tokuda, Chair of the Committee on Ways and Means, rose to request a waiver of the notice requirement pursuant to Senate Rule 21 for H.C.R. No. 89.

Senator Tokuda noted:

"Given that we need to have a hearing on this measure – this economic development HCR – and given the tight schedule in the next week, we'd like to put this on our upcoming agenda."

The Chair granted the waiver.

Senator Tokuda announced that the Committee on Ways and Means would be holding a public hearing on H.C.R. No. 89 the following morning at 9:35 a.m. in Conference Room 211.

Senator Gabbard introduced Vincent Mina, newly confirmed member of the Board of Agriculture, who was seated in the gallery, noting that he also serves as president of Farmers Union United. Senator Gabbard commented that Vincent and one of the two other newly confirmed Board of Agriculture members, Randy Cabral, a lifelong farmer and president of the Farm Bureau, would represent farmers well as leaders of the two primary farmer membership organizations in the state. Senator Gabbard then stated that the other board member who had just been confirmed, Glenn Hong, is a current board member who brings a unique knowledge of how shipping costs impact the ag community from his role as president of Young Brothers.

Senator Kidani rose and stated:

"Mr. President, earlier this month I was invited to Military Appreciation Night at Kaleiopu'u Elementary School in Village Park. Kaleiopu'u is home campus to 896 students, and about 8 percent of them – 72 students – are dependents of military families. The school is one of 45 campuses in our public school system on O'ahu, Kaua'i and Hawai'i Island that are designated 'military impact schools'; all together, they enroll about 14,000 military dependent students.

"The DOE has an excellent and very active military liaison office that coordinates among these schools to take advantage of federal programs available to assist through the Military Interstate Children's Compact and the Joint Venture Education Forum.

"Their goal, of course, is to support military families with children in our schools and communities, to make sure they experience our islands' cultural diversity and the aloha spirit. At the same time, *our* youngsters benefit by learning from classmates from different backgrounds, even though they may be in our schools just two or three years before their families move on.

"The Department of Defense invests heavily in services for dependents. You will recall that just last week, the DoD announced that \$70 million is being allocated to make substantial improvements at Solomon Elementary School at Schofield Barracks. That follows similar upgrades at Daniel K. Inouye Elementary – also at Schofield – just a few years ago. Both schools are run by the Hawai'i DOE.

"The month of April has been set aside nationwide as the Month of the Military Child to recognize and be sensitive to the special challenges dependents and their families face with frequent relocations; acclimating to new schools and classmates; and parents absent for overseas duty, training missions, or other assignments.

"As part of the awareness month, this Friday – tomorrow, April 21 – has been designated Purple UP! Day. Purple is the color you get when you mix together Army green, Marine red and Navy-Air Force and Coast Guard blue – the official colors of the military services.

"I would like you all to consider wearing something purple tomorrow to join in this awareness program. To help you along the way, we have assembled and distributed these purple lapel ribbons – they should be on your desks – that you can pin to your blouse or jacket to join in this salute.

"Mahalo for your participation, and mahalo to our military families, who contribute so much to our communities."

Senator Ruderman rose to speak on a point of personal privilege as follows:

"I want to note with sadness the recent passing of Moanike'ala Akaka. Moani was a former OHA trustee and Hawaiian activist, a friend of Puna and Hilo, and an ally and a friend of mine. She was outspoken, bold, sometimes controversial, and always courageous. Her strong, clear voice will be missed. I do not ask for a moment of silence but rather that we celebrate her colorful and meaningful life. Thank you, Mr. President."

The Chair then stated:

"I didn't read yesterday's *Star-Advertiser* until after lunch yesterday, but if you look at Lee Cataluna's column, she talks about Ric Cox, who lived on Kaua'i for a short six years. He decided to get involved through the Rotary and – with Rotary support for education, teachers, and students on the island of Kaua'i – created Aloha Angels. In three short years, he raised over a million dollars and invested tremendously in our young people and, suddenly, unexpectedly, passed away last week Thursday. Lee Cataluna wrote a very fitting tribute to someone who has contributed so much to Kaua'i and Hawai'i in the short time that he was here."
