Senator Tokuda rose to speak in support of the nominee as follows:

"Director Hoshijo has worked at the ILWU for 26 years in various positions."

The Chair interjected to call a recess, to allow the gallery audience to transition to the House Chamber.

At 11:45 a.m., the Senate stood in recess subject to the call of the Chair.

The Senate reconvened at 11:48 a.m.

Senator Tokuda continued her remarks in support of the nominee as follows:

"As I was stating before, Director Hoshijo worked at the beginning of his career at ILWU for over 26 years in a number of different positions, including housing representative, organizer, international representative, international vice president – a very good advocate for achieving affordable home ownership and developing rental housing for individuals who were unable to purchase a home, dealing with collective bargaining agreements, supporting state assistance for agricultural and tourism employers, and gaining quite a bit of experience through this capacity. He then went on to serve as the education and political director for the Hawaii Regional Council of Carpenters from 2001 to 2015. The work that he did at the carpenters union helped to lead to the successful contract negotiation for project labor agreements for military housing developers that privatized military housing to ensure that houses for Army, Navy, Marines, and Air Force families would be built efficiently for the next 50 years at area standard wages for our construction workers - always looking out for our working men and women here in Hawai'i.

"He has served as deputy director for the last three years, assisting in managing the department. He has overseen some of the most critical and challenging areas of our department: some of the divisions that have been challenging, to say the least,

such as Work Comp, Unemployment Insurance, Workforce Development Council, and HIOSH. This will definitely help in his new capacity as director of the department: the ability to dig deep into some of those areas and the ability to now look at trying to find solutions to those areas most in need. Mr. Hoshijo has also served and will continue to serve on various low-income rental housing nonprofit corporations and labor boards.

"While currently balancing all administrative functions alone, given that there is currently no deputy director for the Department of Labor and Industrial Relations - although I've been told by the governor's chief of staff that we will soon be getting a deputy director - Director Hoshijo has been very willing to work with your Labor committee to gather data that is necessary for us to be able to make good policy decisions and to be a voice back to the administration to be sure that we get the decisions and information that we need from the administration on key issues of importance to the Legislature - issues such as paid family leave, issues such as minimum wage, pay equity, and other things. I look forward to continuing to work with Director Hoshijo, and I would humbly ask and encourage the confirmation of Director Hoshijo today in order for us to be able to make the deadlines in accordance with the attorney general's opinion. Mahalo."

Senator Taniguchi requested that remarks in support of the nominee be entered into the Journal, and the Chair so ordered.

The Chair having so ordered, Senator Taniguchi's remarks read as follows:

"I have known Leonard Hoshijo since our days as undergraduates at the University of Hawai'i at Mānoa. Since those days, I have known Leonard to be a hardworking, conscientious, and sometimes witty person — and always a straight shooter. He has many years of experience in the labor field, collective bargaining negotiations, organizational management, labor policy, and legislative affairs, and is currently serving as the Deputy Director of the Department of Labor and Industrial Relations. I strongly support his nomination to serve as Director of the Department of Labor and Industrial Relations, and ask my colleagues to vote to confirm him. Thank you."

Senator Dela Cruz requested that remarks in support of the measure be entered into the Journal, and the Chair so ordered.

The Chair having so ordered, Senator Dela Cruz's remarks read as follows:

"Thank you, Mr. President. I would like to begin by thanking the Senate President, my Senate colleagues, the staff of the Ways and Means Committee, the Governor's Administrative Director, the Department of Taxation, the Department of the Attorney General, the staff of the Legislative Reference Bureau, and the planning departments of the County of Kaua'i, County of Maui, County of Hawai'i island, and the City and County of Honolulu for the long hours of research, deliberation, and discussion on the provisions of Senate Bill 2963, Senate Draft 1.

"I would also like to recognize House Speaker Scott Saiki and House Committee Chairs on Finance and on Tourism, Representatives Sylvia Luke and Richard Onishi, for their efforts to work together with members of the Senate to create a balanced and fair measure.

## "Growth of Short-Term Vacation Rentals

"Online booking business models such as Airbnb, Expedia, or VRBO; HTA's successful marketing; and the impact of social media 'influencers' on tourists wanting an 'experiential' vacation all have created *an explosive statewide growth of short-term vacation rentals*. As has been noted in testimony before this committee, this growth has been good for those tourists seeking different vacation experiences. This growth is occurring across the nation. The 80th Council of Mayors adopted in June 2012 a resolution that, among others things, urged establishing

"... a reliable way for the municipality to identify and contact the short-term rental owner; (2) make the tax collection and remittance obligations clear to the short-term rental owner; and (3) treat short-term rental tenants the same as long-term rental tenants. Regulations that accomplish all three can achieve a high level of compliance, and are highly effective."

## "Impact of Growth on the Counties

"Zoning Violations: But the growth of this market in Hawai'i has had an impact on the availability of long-term rental housing and, in some communities, has changed the residential characteristic of these neighborhoods, despite county zoning ordinances.

"Economic incentive to rent units to tourists rather than residents is high. For example, operators of these short-term vacation rentals can make more money from the periodic vacation rentals than from long-term rentals, while others only want their units rented for short periods of time, thus removing the units from the long-term rental markets.

"On the other hand, there is an inadequate housing supply for our own residents and *the cost of rentals seems to be rising.* 

"Even though the Counties of Maui and Kaua'i and the City and County of Honolulu have regulated short-term vacation rentals, the explosive growth of these rentals are occurring outside of the allowed land use and are thus an illegal use of the properties. (The County of Hawai'i is currently writing its land use ordinances.)

"Enforcement of Zoning Ordinances: The county planning departments have indicated how difficult it is to locate, identify, and stop zoning ordinance violations when the operators are renting out short-term vacation rentals for very significant amounts of money on a daily business. The cost of defending such county litigation simply becomes a cost of doing business that is absorbed by the rental fees. Moreover, not only are the number of enforcement actions growing, but at the same time the process of enforcement is slowed in one county as the disputes go before a volunteer board.

"Other Violations: Moreover, because it is easy to rent out a room, a condominium, or an entire house through these online booking platforms, many people may be completely unaware of their obligations under state law and county ordinances, such as paying the Transient Accommodation Tax. And, those assisting homeowners with property rental management may also be unaware of their own legal responsibilities.

"A California resident, wanting to move to Hawai'i, was invited by Airbnb to be a 'co-host' for other Airbnb operators in the State of Hawai'i. She testified that her 'services' to the operators included some property management services, but also testified that she did not have a required real estate license to do those services.

"Impact of growth on collection of the Transient Accommodations Tax and Gross Excise Tax: The Department of Business, Economic Development, and Tourism, along with the Department of Taxation and the Department of Budget and Finance, estimate that given the number of hotel rooms and visitor arrivals in 2017, tourists rented short-term vacation places for over 12,000 nights. While these departments also assumed that some taxes were actually paid, they also estimated that there was approximately \$67,000,000 in uncollected Gross Excise and Transient Accommodations Taxes.

"S.B. 2963 S.D. 1 addresses these issues by improving the counties' ability to enforce land use ordinances, allowing for the transient accommodations broker to collect and pay appropriate taxes on behalf of the operators or plan managers of short-term vacation rentals; and it makes the online platform broker responsible for benefiting from or encouraging behavior by its operators and others hosts that is illegal.

"For the counties, the bill specifically:

- Allows for judicial review by the circuit court and for fees, costs, and disgorgement of profits obtained through unfair or unlawful business acts and practices and imposes a minimum fine of \$25,000; and
- With the consent of the operators and plan manager, the bill provides for disclosure of information between the transient accommodation broker and the state and county governments for purposes of enforcing the ordinances and laws

"The bill does not preempt the counties' role and responsibilities with regard to their zoning ordinances. The counties must still craft and enforce land use zoning ordinances for short-term vacation rentals. And as many testifiers noted, two of the counties are still working on those ordinances, and once each county has developed its compliance processes, the bill provides payments by the State of up to \$1,000,000 to each county for setting up and enforcement.

"For tax collection, the bill makes it easier to collect and pay appropriate taxes by allowing transient accommodation brokers to become the State's agent for collect and paying taxes; and to encourage payment of taxes, it also provides a temporary amnesty program for a short period of time.

"And finally, to ensure that the public's welfare and safety are respected by this new business model, the bill imposes liability upon the transient accommodation broker for benefiting from or encouraging the use of illegal actions of others such as:

- collecting fees for booking services from illegal transient vacation rentals:
- entering into business with an illegal short-term rental operator; and
- on behalf those operators, employing, contracting, or otherwise engaging in business with any person who is not properly licensed or in compliance with applicable laws and ordinances.

"In closing, this bill provides a fair and balanced means of maintaining the safety and welfare of our residents without undue strain upon the economic benefits of short-term vacation rentals through transient accommodation brokers.

"Again, I would like to thank my colleagues in the Senate and the House for their effort and hard work in reaching a consensus on these issues. Mahalo, Mr. President."

S.B. No. 2751 Jointly to the Committee on Higher Education and the Committee on Economic Development, Tourism, and Technology, then to the Committee on Ways and Means

S.B. No. 2791 Committee on Human Services, then to the Committee on Ways and Means

S.B. No. 3095 Jointly to the Committee on Agriculture and Environment and the Committee on Commerce, Consumer Protection, and Health, then jointly to the Committee on Education and the Committee on Ways and Means

At this time, Senator Green, Chair of the Committee on Human Services, requested a waiver of the notice requirement pursuant to Senate Rule 21 for S.B. No. 2791.

Senator Green noted:

"This is a terrific bill, Relating to Juvenile Justice Reform. We had a re-referral that you approved, and we wanted to hear this if we could at 3:45 p.m. in Conference Room 016 on Wednesday."

The Chair granted the waiver.
