Friday, February 16, 2018

The Senate of the Twenty-Ninth Legislature of the State of Hawai'i, Regular Session of 2018, convened at 11:35 a.m. with the President in the Chair.

The Roll was called showing all Senators present with the exception of Senator English who was excused.

The President announced that he had read and approved the Journal of the Nineteenth Day.

At this time, Senator Shimabukuro welcomed students from Ka Papahana o Mailikukahi and Pūnana Leo o Wai'anae, as well as other Hawaiian language immersion students who were present in the gallery.

Senator Galuteria recognized and honored various individuals for their dedicated work in the Hawaiian language, and presented the following remarks:

"Colleagues, this morning at Washington Place, Governor Ige proclaimed 2018 Year of the Hawaiian, Ke Au Hawai'i, celebrating accomplishments of Native Hawaiians for the past 30 years. The last Year of the Hawaiian, Ho'olako, was celebrated back in 1988. If accomplishments of the past 30 years are indicators of what lies ahead, the future for Hawaiians in our homeland is bright, and to all who call Hawai'i home, we are one. In addition, Ke Au Hawai'i will be interpreted as the era, or age, of the Hawaiian: a period of time considered as being of a distinctive character, an epoch, or a point in time, a distinctive period. This is Ke Au Hawai'i, and February is also 'Ōlelo Hawai'i Month, as evidenced by the many Pūnana Leo haumāna (students) joining us today.

"Our honorees today reflect a movement toward a vibrant Hawaiian language community that wasn't here 30 years ago, and our first honoree - we'll call him the grandfather of the movement - is Larry Kauanoe Kimura. Dr. Larry Lindsey Kimura has worked tirelessly to revitalize 'ōlelo Hawai'i for almost 50 years. He is a pioneer of the 'ōlelo Hawai'i movement, a respected icon of 'ōlelo Hawai'i, a kumu, and prolific songwriter of mele Hawai'i. Dr. Kimura is an associate professor of Hawaiian language and Hawaiian studies at Ka Haka 'Ula o Ke'elikōlani College of Hawaiian Language at UH Hilo. He founded the Ka Leo Hawaiian language radio talk show that aired on KCCN 1420 AM for 17 years, and, Larry, I was one of the on-air personalities at the time, and we couldn't speak a lick of Hawaiian before you came along. The Native Hawaiian speakers currently in existence are largely due in part because of Dr. Kimura, who has prepared curriculum for Papahana Kaiapuni Hawai'i, the Hawaiian language immersion programs in the public schools. He is also a well-known songwriter of original mele and songs frequently performed on the radio and at Hawaiian events. So, colleagues, please help me in welcoming and honoring a man affectionately referred to by many as the tūtū of the Hawaiian language revitalization movement and present-day Hawai'i, Dr. Larry Lindsey Kimura. Aloha, thank you, mahalo!"

Senator Kidani rose to present the following remarks:

"Aloha, Mr. President. Your constituent, Lolena Nicholas, is a native speaker from the island of Ni'ihau and a kupuna in the Hawaiian language revitalization movement. Lolena was one of the first kumu at Pūnana Leo o Honolulu in 1985 and continues to teach to this day. Lolena has served as a mānaleo, a native Hawaiian language speaker, for the Kawaihuelani Center for Hawaiian Language. Lolena is fondly and lovingly known as Aunty Lolena to thousands of 'ōlelo Hawai'i students from across Hawai'i. She was a co-host for Ka Leo Hawai'i, a

Hawaiian language radio talk show that brought mānaleo together in the Hawaiian language from across Hawai'i. In 2014, a film was produced on her life's work in revitalizing the use and prevalence of the Hawaiian language. Please help me in welcoming and honoring Lolena Nicholas, an inspiration to native Hawaiian language speakers throughout Hawai'i, a strong proponent of 'ōlelo Hawai'i, and the keeper of her mother tongue, ka 'ōlelo Hawai'i – Lolena Nicholas."

Senator Shimabukuro rose to present the following remarks:

"Dr. Ku'uipolani Kanahele Wong was born and raised on the island of Ni'ihau speaking 'ōlelo Hawai'i. In 1983, Kumu Ipo began her 'ōlelo Hawai'i career as a kumu at the Pūnana Leo o Honolulu preschool, the first Hawaiian-medium preschool on O'ahu since the late 1800s. Dr. Wong continued as a mānaleo, a Hawaiian-language speaker, resource at the Kawaihuelani Center for Hawaiian Language while continuing her studies there. She is the first native from Ni'ihau to receive her doctorate degree in education. Her dissertation provides her perspective on the stories, traditions, history, and unique and distinct features of the Ni'ihau dialect. Dr. Wong currently serves as an associate professor at UH Mānoa and as a director of the Kawaihuelani Center for Hawaiian Language. She has served as the luna 'ike 'ōlelo for the Baibala Hemolele, the Hawaiian Bible project, and as a deacon at the Kawaiaha'o Church of Honolulu. Please help me in welcoming and honoring Dr. Ku'uipolani Kanahele Wong."

Senator Kahele rose to present the following remarks:

"Mr. President, colleagues, what a beautiful day - e ola ka 'ōlelo Hawai'i! It is my honor to introduce our next honoree for today: Kananinohea Kawai'ae'a Māka'imoku. Kananinohea is a graduate of the first Hawaiian-immersion class in 1999, from Ke Kula 'o Nāwahīokalani'ōpu'u on Hawai'i island. She began as a Pūnana Leo o Honolulu student in its inaugural year and also attended Hawaiian-immersion schools at Waiau and Keaukaha. Kanani graduated with her bachelor's degree in Hawaiian studies in 2002 and received her teaching certificate from Kahuawaiola Indigenous Teacher Education Program at UH Hilo in 2004 and her master of arts degree in indigenous language and culture education in 2009. She is the first immersion graduate to return as a Hawaiian-immersion teacher and is now helping to orient and prepare new immersion teachers from across the state as they begin their teaching careers. In 2017, she joined the Kahuawaiola education faculty at Ka Haka 'Ula o Ke'elikōlani College of Hawaiian Language. Today, she lives in Puna with her husband and has two children, who both attend Ke Kula 'o Nāwahīokalani'ōpu'u. Please help me in welcoming and honoring Kananinohea Kawai'ae'a Māka'imoku, a product of Hawaiian-language immersion who is now passing on her knowledge and love of the Hawaiian language to the next generation of Hawaiian-language speakers. Mahalo, Mr. President."

Senator Galuteria rose and stated:

"Mahalo, thank you. Dr. Papaikanī'au Kai'anui was educated entirely in Hawaiian-medium schools, beginning at Pūnana Leo o Maui and later at the Hawaiian-immersion sites at Pā'ia Elementary School, Kalama Intermediate School, and Kekaulike High School. Dr. Kai'anui graduated with the first Hawaiian-immersion class on Maui in 2001. She completed her bachelor's degree in social work in 2006, her master's degree in social work and bachelor's degree in Hawaiian language from UH Mānoa in 2008, and her doctorate degree from USC in 2012. Dr. Kai'anui was the first immersion student to complete a doctoral degree. Her doctoral dissertation provides policy insights on ways to improve the education of immersion

students being educated through the medium of the Hawaiian language. Kauka is currently an instructor of Hawaiian at Maui College. Please help me in welcoming and acknowledging and honoring the achievements of Dr. Kai'anui in expanding the number of individuals who are able to speak and think in the Hawaiian language. Mahalo! Mahalo."

The Chair remarked that while he's normally introduced as "the Senator from Senate District 8: the islands of Kaua'i and Ni'ihau," he was very proud that morning to be "the Senator from District 8: the islands of Ni'ihau and Kaua'i," with Ni'ihau so proudly represented in the Chamber. The Chair further noted that the Committee on Hawaiian Affairs and the Committee on Water and Land had started a pilot project the previous year to post hearing notices in Hawaiian, with the Committee on Higher Education starting to do so as well during the current legislative session. The Chair commented that it's not just about "the great words and recognition, but the action of our deeds" in the Senate leadership team, of which the "kūpuna" category consisted of Vice President Kidani, Majority Leader English, and Majority Caucus Leader Galuteria, with Majority Whip Kahele in the "other" category.

At 11:48 a.m., the Senate stood in recess subject to the call of the Chair.

The Senate reconvened at 11:56 a.m.

She has much experience: Her career has included positions that required knowledge of budgets, finance, accounting, and investment. When working in Washington, DC, for the U.S. Sergeant at Arms, she was accountable for a budget of more than \$120 million. When Hawai'i was hit by Hurricane Iniki, as a commissioner, she engineered the creation of a \$1.5 billion pool for the Hawaii Hurricane Relief Fund to stabilize the market. I believe Linda has a proven track record of bringing large and small projects to a successful conclusion and within budget, and she's creative in finding out-of-the-box solutions to difficult problems and is not afraid to be the first one to offer creative solutions. I urge my colleagues to support advise and consent."

She has provided advice and counsel to governors, cabinet officials, and legislative leadership on current and evolving fiscal conditions. She has helped manage the governor's office administrative operations and provided executive support for cabinet officials on policy issues, budget, and legislative proposals. She has advised and supported university presidents and Board of Regents in successful budget negotiations with state legislative and executive budget agencies, resulting in additional general fund support in FY15 for campus operations. She has provided leadership and management of legislative staff working groups to successfully implement the Senate's paperless initiative, and she successfully managed budget negotiations with state legislative branch and executive budget agencies. She has a commitment to public service; she is a lifelong learner and believes in workplace innovation and succession planning. I urge my colleagues to support advise and consent."
