Senator Kim moved that S.B. No. 2055, S.D. 1, having been read throughout, pass Third Reading, seconded by Senator Ruderman.

Senator Baker requested that remarks in strong support of the measure be entered into the Journal, and the Chair so ordered.

The Chair having so ordered, Senator Baker's remarks read as follows:

"This bill will require the Governor to provide written notice to the Senate no later than the 41st day of the legislative session in which the nomination is to be considered. Members of our boards and commissions provide valuable services to the State and some hold considerable power. The Senate needs time to vet these nominees in order to faithfully fulfill its advise and consent function mandated under the state constitution. It is exceedingly difficult to take the necessary due diligence in the last few weeks of the legislative session, as we prepare for conference. This bill would require that GMs are transmitted to the Senate by the deadline without fail. This bill will protect the State by allowing the Senate to properly vet gubernatorial nominees to boards and commissions. Please join me in supporting S.B. 2055."

The motion was put by the Chair and carried, S.B. No. 2055, S.D. 1, entitled: "A BILL FOR AN ACT RELATING TO THE EXECUTIVE BRANCH," having been read throughout, passed Third Reading on the following showing of Ayes and Noes:
