TWENTY-THIRD DAY

Thursday, March 1, 2018

The Senate of the Twenty-Ninth Legislature of the State of Hawai'i, Regular Session of 2018, convened at 11:34 a.m. with the President in the Chair.

The Roll was called showing all Senators present with the exception of Senators Galuteria, Ihara, and Riviere who were excused.

The President announced that he had read and approved the Journal of the Twenty-Second Day.

At this time, Senator Baker commended and congratulated the 2017 Hawaii Healthcare Heroes, and presented the following remarks:

"It's my pleasure to introduce our Healthcare Heroes for this year. The Healthcare Association of Hawaii is a leading voice for healthcare providers in this state. The organization works to positively influence state and federal policy to provide quality and accessible health care to the people of Hawai'i. Through HAH, patients are given the opportunity to acknowledge the service of outstanding healthcare providers who have demonstrated exceptional commitment and noteworthy expertise. The five 2017 healthcare providers that we're honoring on the floor today are being honored for the exemplary care that they delivered to patients, as well as their loved ones, across the state. These folks truly are the epitome of selfless service for the betterment of our community and, therefore, are more than worthy to be designated and honored as a 2017 Healthcare Hero. I'd like to now yield the floor to Senator Ruderman for our first introduction.'

Senator Ruderman presented the following remarks:

"Jessica Ackerman is our first Healthcare Hero. Jessica is a nurse practitioner at Queen's Medical Center geriatric services. She is devoted to providing compassionate care to our kūpuna, taking the time to learn from her patients and their caregivers. Jessica earned her bachelor of science in nursing from Hawai'i Pacific University and went on to obtain a master of science in nursing from the University of Hawai'i. She says being a nurse practitioner allows her to help patients and their families learn about their medical concerns and how to take care of them. The personalized care that she demonstrates toward her patients makes her truly worthy of recognition as a 2017 Healthcare Hero. May we please recognize Jessica?"

Senator Kidani presented the following remarks:

"Dr. Anne Dempsey practices at the Kauai Medical Clinic, and I am honored to introduce her on your behalf, Senate President Kouchi. Dr. Dempsey earned her medical degree from the University of Texas Southwestern Medical School at Dallas. Dr. Dempsey practiced as a hospitalist for nine years in Austin, Texas, and has been a practicing internist at Kauai Medical Clinic since 2014. She enjoys meeting people from all walks of life as well as inspiring them to improve their health through diet and exercise. She is honored to have made a difference in someone's well-being as, to her, that is what being a doctor is all about. Her passion, empathy, and expertise make her deserving to be among the recipients of the Healthcare Hero award – Dr. Anne Dempsey. Thank you."

Senator Rhoads presented the following remarks:

"Our next honoree is Cheri Teranishi-Hashimoto. Cheri has known she wanted to become a physical therapist since high school, when she underwent physical therapy after sustaining sports injuries. Ever since then, she has dedicated herself to her career, earning her doctorate of physical therapy from Des Moines University Osteopathic Medical Center and is now the Women's Health & Cancer Rehabilitation program director at the Rehabilitation Hospital of the Pacific. Despite devoting her life to treating her patients, Cheri remains humble and thinks that the real heroes are her patients. Her dedication and humility make her worthy of recognition as a 2017 Healthcare Hero."

Senator Shimabukuro presented the following remarks:

"Gary Oshita brightens any room that he enters. As the activity coordinator in the Recreational Therapy department at Maluhia, Gary plans, implements, and leads a therapeutic recreational program on a daily basis. Gary started his career as a personal fitness trainer at 24 Hour Fitness and was then a PE teacher at Pearl Ridge and Linapuni elementary schools. Gary has been bringing smiles of joy to the residents of Maluhia for over a decade. Gary's compassion and ability to bring such joy to our kūpuna make him worthy of receiving a Healthcare Hero award. Let's give a hand to Gary Oshita. (He's got some fans in the gallery, I see.)"

Senator Nishihara presented the following remarks:

"Our final Healthcare Hero is Dr. Baron Wong. Dr. Wong is a hospitalist and internal medicine physician who specializes in geriatrics at Wahiawa General Hospital. Dr. Wong graduated from the John A. Burns School of Medicine and completed the University of Hawai'i geriatrics program in 2001. He has been at Wahiawa General Hospital as a hospitalist, geriatrician, and internist since 2002. Dr. Wong wanted a career in this field so he could care for patients with compassion, love, and dignity. He also believes that everyone can be considered a Hawaii Healthcare Hero as long as they truly care for patients with compassion."

Senator Baker rose and stated:

"I'd like to introduce in the gallery some supporters of our Healthcare Heroes, along with Hilton Raethel, the CEO and president of Healthcare Association of Hawaii. Will all of the supporters of our Healthcare Heroes, along with Hilton, please rise to be recognized? Thank you, Mr. President. I would again like to wholeheartedly thank all of our honorees for the significant positive force that they are in their chosen field of medicine and health care. Thank you."
