Friday, March 2, 2018

The Senate of the Twenty-Ninth Legislature of the State of Hawai'i, Regular Session of 2018, convened at 11:34 a.m. with the President in the Chair.

Senator Inouye rose to speak in support of the nominee as follows:

"Over the years, it has been my honor and pleasure to get to know Jade. For the Department of Transportation, Jade brings a plethora of experience, knowledge, and professionalism. From Jade's testimony on February 7, he shared his personal story from childhood to who he is today. As a Filipino immigrant coming to Hawai'i at the age of 13, speaking almost no English at the time, Jade benefited greatly from public education, and graduated from Radford High School with honors. He went on to the University of Hawai'i at Mānoa to earn a bachelor's degree in business administration, double-majoring in finance and accounting. With a desire to further his education, Jade attended Babson College in Massachusetts, one of the most prestigious schools for entrepreneurship in the United States, to earn his master's in business administration. After earning his master's degree, Jade pursued various positions, from serving as a legislative assistant and budget analyst to a congressional aide and management consultant. Then came his first major role: In 2011, Jade served as the first deputy director for the Department of Transportation until 2013. Then he served one year as a deputy director of the Department of Labor and Industrial Relations under the Abercrombie administration. In his more recent experience, Jade returned to the Department of Transportation to continue his commitment and dedicated service to the public as deputy director from 2015 to 2017.

"For those of us who have been lucky to know and work with Jade, we recognize him as a person whose character embodies the values of hard work, determination, grit, and decency. For example, in October 2017, Jade was part of the 2017 Filipino Chamber of Commerce Hawai'i's Goodwill and Trade Mission to the Philippines. During their visit, Jade noted that growing up in San Nicolas, Ilocos, the transportation system consisted of jeepneys, kalesa – which is the horse-drawn carriages; I've been in one of them – or the kariton – the carabao-drawn cart – or tricycles navigating on unpaved roads. Now, serving as the interim director of the Department of Transportation in his adopted land, he realized this is truly a remarkable feat. It proves that one can come from modest circumstances or faraway places and still be fortunate enough to be involved in extraordinary circumstances. Now, a funny story about Jade: Not only is he ready to lead all the airports, the harbors, and highways in the state, but he is always game for anything. Last month, I invited him to join me for a Sustainable Transportation Forum meeting in Hilo, which he accepted. However, apparently, word did not get to him that it was actually a roundtable discussion that would be televised for all to see. He said he would have prepared differently had he known; first of all, he would have worn a different aloha shirt. Still, he proceeded with confidence and did a wonderful job.

"Thank you, Jade, for your commitment and dedication. Although your father is no longer with us, I know he is here in spirit and very proud of you as this confirmation could not have happened to a more qualified person. Colleagues, by approving Jade's nomination today as the director of the Department of Transportation, we will ensure continuity and a seamless transition for the department. Therefore, in closing, I urge all of my colleagues to support the nomination. Thank you, Mr. President."

For the Department of Transportation, Roy brings a wealth of legal experience and working knowledge of federal, state, and county regulations. Roy's collective experience makes him well-suited to oversee budgeting, contracting, staff services, and other critical administrative functions for the DOT. During his secondary education in the state of Oregon, Roy earned a bachelor's in psychology and political science from the University of Oregon. And because he enjoyed Oregon so much, Roy continued on to earn a juris doctorate degree from the University of Oregon School of Law and is a longtime member of the Oregon State Bar and the Hawaii State Bar Association.

"Now, this is the part where you have to be very careful what you list on your résumé. In Roy's early employment, he pursued various positions as a dishwasher, highway survey aide, and pizza delivery driver as well as internships at the state penitentiary, Ethics Commission, and the federal court. I mention Roy's early employment because who would imagine that the highway service aide or intern at the state penitentiary would one day make partner at numerous Honolulu law firms such as Goodsill Anderson Quinn & Stifel, LLP; Catalani Nakanishi & Caliboso, LLP; and Rush Moore, LLP? During his time as an attorney, Roy was also active in the community. In

2004, Roy served as a chair of the State of Hawai'i Land Use Commission, several terms as chair of the National Asian Pacific American Bar Association, and currently serves as board chair of the Native Hawaiian Legal Corporation. In his most recent experience, Roy served as vice president of strategic initiatives and external affairs for Young Brothers, Limited, since 2005.

"Today, with much appreciation - and I know Jade and DOT would agree - we could not be more fortunate for your return to public service as deputy director of the Department of Transportation. For those of us who have been lucky to know and work with Roy, we recognize him as a person whose character embodies the values of hard work, fairness, integrity, and diplomacy. To his friends and family, Roy is a caring and nurturing father who is very committed to his two sons. We know that he diligently supported older son Ryan's performance as a magician, and on many afternoons and weekends, he can be seen at the athletic field cheering and coaching his son Alex. On a side note, as you can see, Roy is a very sharp dresser. A little known fact, however, which only his close friends know: He still has clothes in his closet that he wore in college and, without his wife Lorna's guidance, he would be seen in them today.

"As deputy director of the DOT, Roy will be responsible for the administrative functions, including personnel administration, central computer services, business management activities, environmental compliance, civil rights, emergency management, and contract services. Colleagues, esteemed members of our beloved Senate, by approving Roy's nomination today as the deputy director of the Department of Transportation, we will ensure legal continuity and a seamless legal transition for the department. Therefore, I urge all of my colleagues to support his nomination. Thank you, Mr. President."

Dr. Katras is the senior vascular surgery consultant, and Dr. Kovell is the psychiatry residency program director for the department of behavioral health. Both are currently serving at Tripler Army Medical Center, and their résumés speak for themselves and are available on the Senate Portal. I'm confident that their experience and expertise would make them valuable assets to the Medical Advisory Board. Therefore, I urge all my colleagues to support their nominations. Thank you, Mr. President."
