

TWENTY-SIXTH DAY

Thursday, March 8, 2018

The Senate of the Twenty-Ninth Legislature of the State of Hawai'i, Regular Session of 2018, convened at 11:31 a.m. with the President in the Chair.

The Roll was called showing all Senators present with the exception of Senator Shimabukuro who was excused.

The President announced that he had read and approved the Journal of the Twenty-Fifth Day.

At this time, Senator Galuteria introduced representatives from the cosmetics and technology industries, who were seated in the gallery: Junji Sugawara, CEO, JCosme; Isao Sueishi, CEO, Jsix and JCosme; Motohiro Noda, Jsix Japan, Seven Tech Coordinator; Philip Walstad, co-founder, Seven Tech; Jason Thelin, co-founder Seven Tech; Brian Nelson, CEO, Seven Tech; Brent Jensen, EVP, Seven Tech; Dean Rostrom, MD, Evergreen Clean; Itaru Inaho, Seven Tech Japan; and Alan Tamashiro, representative for JCosme in Hawai'i.

Senator Espero welcomed a group of sixth-grade students from Holomua Elementary School, who were accompanied in the gallery by their teacher, Hailey Scott.

Senator Kim recognized and commended Moanalua Gardens Foundation for its stewardship of Kamananui (Moanalua) Valley, and presented the following remarks:

"Mr. President, Moanalua, or Kamananui, Valley is the last undeveloped valley in urban Honolulu and it is – no surprise – part of my senatorial district, and before that, it was part of my city council district, so you can understand my special interest and my concern for this valley. For over a hundred years, Moanalua Valley was under private ownership with limited public access. Since 2008, however, the valley was sold to the State of Hawai'i and was opened to the public for education and recreational purposes. With more people visiting the area, plans had to be created to keep the valley accessible, user-friendly, safe, and secure while preserving its history, its cultural assets, and natural beauty. To this end, Moanalua Gardens Foundation has been designated as the lead organization to direct the stewardship of the valley.

"Managing a foundation is not an easy task, and it takes a lot of money. In addition to that, it takes certain kinds of individuals who will devote their time and ideas to better the lives of many. Moanalua Gardens Foundation luckily has several citizen volunteers who are committed and dedicated to making Moanalua Valley a cultural and educational environment. And these individuals do not get paid; they do it because of their love. So, leading the stewardship and following through with the valley's master plan are two very key individuals: First, Alike Jamile, the executive director and president of Moanalua Gardens Foundation, and his partner is Pauline Worsham, the foundation's managing director, and both of them have given their time and their hearts to this organization. They spend many hours; they spend a lot of their own resources, and I know they visit probably many of you here in this chamber, all in the name of helping to preserve Moanalua.

"Also, there are many people sitting in the gallery, members of the foundation who also help preserve this valley, and if I may introduce them: First, Charles Cooke, IV: He is the secretary and treasurer of the foundation. Also, Steven Onoue: He's a director and president of Moanalua Valley Community Association. He's my constituent; I've worked very closely with him on many issues of the area. We have Brendon Lee, director and second vice president of the Association of Hawaiian Civic

Clubs and president of Kamehameha Alumni. We have Aaron Stewart, director and assistant vice president and compliance officer of First Hawaiian Bank. Then we have Kimo Kahoano, who you all know and love: he's a director and radio personality, but Kimo, I have to say, back in 1982 – when his hair was black and he was much younger – he actually served as my very first emcee for my very first fundraiser. And, finally, no stranger to this place, Marlene Sai: Marlene is a director and recording artist, entertainer, and business professional. Now, Marlene and I also have a story – we go back to the 1970s, '71, where she was the lead singer with Ed Kenny in the Tapa Room, and I happened to be a line dancer there, and we spent many nights and shows in the Tapa Room entertaining tourists from all over the world.

"And so, Mr. President, I would like all of you to thank and congratulate the Moanalua Foundation. Mr. President, it takes a village to preserve, protect, and remind us of our precious heritage, and how fortunate for us that we have such devoted individuals who comprise these villages. Thank you."

Senator Galuteria acknowledged Kimo Kahoano, and noted that they did the morning radio shows on 1420 AM and FM 100 together for eight years. Senator Galuteria also acknowledged Marlene Sai, who allowed him to perform in her orchestra when she headlined at the Royal Hawaiian Hotel's Monarch Room for three years.

Senator Kim noted that the Honorable John Waihe'e III, former Governor of the State of Hawai'i, also participates on the Moanalua Gardens Foundation board.

Senator Rhoads recognized Kat Brady and Henry Curtis, constituents of the Thirteenth Senatorial District, who were seated in the gallery.

At 11:40 a.m., the Senate stood in recess subject to the call of the Chair.

The Senate reconvened at 11:50 a.m.

Because drivers of electric motor vehicles and hybrid motor vehicles **pay little to no gas tax**, these drivers do not pay for the road degradation they contribute to. With S.B. 1011, S.D. 2, we, the Senate, can work on how electric motor vehicles and hybrid motor vehicles can contribute their **fair share to the state highway fund** since they do not consume, or consume limited quantities, of gasoline. Thank you, Mr. President, and members of the **Senate for your consideration.**"

Senator Inouye rose to speak in support of the measure as follows:

"With every flight to and from the Aloha State, Hawai'i residents and visitors alike have recognized our airports are inferior to other airports serving leading travel destinations. Hawai'i is only one of three states to manage the operations of its airports, whereas a single construction project can take up to 50 detailed and time-consuming steps to process. Moreover, when you have more than one project underway, this process can be cumbersome and redundant, leading to lengthy and costly delays in part due to the multiple agencies that impact the

decision-making. With support from the Department of Transportation, creating the Hawaii Airports Corporation is the first step to improving the management, efficiency, and facilities at Hawai'i's airports. The Hawaii Airports Corporation will operate with a strong commercial and customer focus, and be able to adjust to economic opportunities and market conditions through dedicated expert airport leadership, management continuity, and year-round decision-making consistent with industry best practices.

"Since the first hearing of S.B. 2996, my committee has worked to incorporate all of the various aspects to effect the transfer of functions from the Department of Transportation to the Hawaii Airports Corporation. We incorporated input from the Office of Hawaiian Affairs, Subcontractors Association of Hawaii, State Procurement Office, and the Office of the Attorney General. In the Ways and Means committee, we continued to be vigilant and further incorporated input from the State Procurement Office, Office of the Attorney General, American Institute of Architects and American Council for Engineering, and the Office of Hawaiian Affairs. Then, this past Tuesday, we approved the amendment to change the effective date to January 1, 2019. Therefore, I'm confident, Mr. President and colleagues, that S.B. 2996, Senate Draft 3, has a solid foundation to create a robust and prosperous Hawaii Airports Corporation. Thank, you, Mr. President, and I urge my colleagues for a favorable consideration.

"And at this point, Mr. President, I do want to give thanks to the SMA staff. This is the sixth draft, and we really appreciate what our committee does, and we want to thank Wayne and Casey and his staff for their diligence and patience for what our committee has put upon them. Thank you, Mr. President."

Senator Kim rose to speak in opposition to the measure as follows:

"Mr. President, I agree with our transportation chair that our airport is very inferior to other airports around the nation, and I also appreciate the hard work that our transportation chair has put into in developing this measure and trying to make it a better measure. However, I still have a lot of concerns; it's no surprise to everyone here that I have had concerns on this measure. I believe that this corporation will mean less transparency to what is going on at the airport and will be added bureaucracy. I think we need to keep in mind that this corporation will be a board that meets once a month, possibly even more – hopefully more – and that they will hire an executive director, but everyone else will remain exactly the same – the exact same group, the same people, the same project managers that we currently have – and so I'm not sure how that will change all of the problems that we currently have.

"As far as pointing to the fact that procurement is a problem and that procurement with the board, that they will not have the kinds of problems that they currently have, let me just remind everybody that the Hawaiian Airlines hangar project went through procurement, and it wasn't that that made problems. They had 3,500 deficiencies. The problem was not just the contractor but also the consultant that we hired and paid millions of dollars to oversee this contract to make sure that it was done properly and it was done according to the specs. It was also the fact that our own airport manager did not catch any of these 3,500 deficiencies and paid the contractor and approved the payments of the contractor. So, basically, it's been poor oversight on the part of the state as well as our consultant. And so I strongly feel that, like HART and many other boards that we have currently in operation, the airport corporation will just be one more of them, and maybe we'll be back here – or future legislators will be back here – to undo what we do today, just as we're undoing the Board of Regents advisory board, so thank you, Mr. President."

Senator Espero rose to speak in support of the measure as follows:

"The senator from Moanalua Valley-Kalihi stated some good points. However, as lawmakers, we're in a position to make certain that we craft the bill that has this entity to be open, transparent, and, at the end of the day, in the best interest of our state and the residents of Hawai'i. We've been working on this since last session. We're continuing this session, and let's move this bill forward and, hopefully, between the House and Senate, we can come up with a strong, workable measure that will benefit all of us. Thank you; I ask for your support."

The motion was put by the Chair and carried, S.B. No. 2996, S.D. 3, entitled: "A BILL FOR AN ACT RELATING TO AN AIRPORTS CORPORATION," having been read throughout, passed Third Reading on the following showing of Ayes and Noes:

At this time, Senator Wakai rose to clarify that his vote on S.B. No. 2699, S.D. 2 was "Aye with Reservations."

Senator Dela Cruz rose to speak on a point of personal privilege as follows:

"I just want to thank DOTAX and the budget office and the attorney general for all their help with some of the revenue bills, and I just want to summarize some of the actions that the Senate took that will help the state's financial plan:

- Senate Bill 2699, which we just passed today, will generate \$19.4 million this year and \$49.5 million next year.
- Senate Bill 2489, the time share bill, will generate \$20.2 million this year and \$22.8 million next year.
- Senate Bill 2821, the conformity bill, will generate \$9.2 million this year and \$14.2 million next year.
- The conveyance tax, Senate Bill 2415, will generate \$8.6 million this year and \$9.4 million next year.
- HRPTA, Senate Bill 508, will see a one-time \$14.4 million; thereafter, it'll be \$4.6 million every year after that.

- Senate Bill 2484, the estate tax, will generate almost a million dollars this year and almost \$2 million next year.

"I just want to have the members keep in mind that the state is overspending by \$174 million this year, \$218 million next year, and \$191 million in 2021, so despite those numbers that I announced earlier, it will help the financial picture a little bit. However, there are things that are in the budget that we can't count on. The administration had put in \$33 million this year for the Airbnb TAT bill and \$67 million next year; that's no longer in the financial plan. There are some additional adjustments, which the administration has had to take out of the financial plan which further reduces revenues. So I'll have my office draft a summary of these so that the Senate can have a clearer understanding of where we're headed in the next couple years with the financial plan. Thank you."

Senator Ihara rose to speak on a point of personal privilege as follows:

"Mr. President, on Monday, a great surfer, entrepreneur, and environmentalist passed away: George Downing. A couple of reapportionments ago, while representing Waikiki, I spent many, many hours with George, learning about ways to keep sand on Waikiki Beach while not harming the environment and surf spots. I was in awe of this noble gentleman. He made me feel his love for our islands, and with George Downing, I felt hope for the future. I believe that George is responsible, in large part, for protecting our shorelines from beachside developments, harmful to our environment and our sense of who we are as a people. Mr. President, I would like to request that the Senate adjourn with a moment of silence to honor George Downing, one of Hawai'i's environmental and community heroes. Thank you."

ADJOURNMENT
