TWENTY-SEVENTH DAY

Friday, March 9, 2018

The Senate of the Twenty-Ninth Legislature of the State of Hawai'i, Regular Session of 2018, convened at 11:36 a.m. with the President in the Chair.

The Roll was called showing all Senators present with the exception of Senators Rhoads and Shimabukuro who were excused

The President announced that he had read and approved the Journal of the Twenty-Sixth Day.

At this time, Senator Riviere welcomed a group of fifth-grade students from Lā'ie Elementary School, who were seated in the gallery with their parent chaperones and teachers Colleen Spring and Jo-Ann Keliikuli. The visiting group also included teachers Hana McMullin, Sandi Aluli, Roxane Coleman, and Liz McOmber; and parent chaperones Kalei Judd, Bere Uluave, Stephanie Robertson, Stacey Cannon, and Shakira Feagaimaalii.

Senator Kidani welcomed site coordinators, parents, and other family members from several of the 70 HCAP Head Start centers around O'ahu, who were participating in their fifth annual visit to the State Capitol. Senator Kidani noted that the federally-funded program is the largest early childhood program in the state, serving more than 1,500 children and their families each year. She then introduced Grant Kogami, director of HCAP Head Start; Angel Lin, policy council vice-chairperson; and assistant directors Donna Manibog, Jennifer Tanele, and Suzie Uyeda.

Senator Wakai recognized visitors from Governor Wallace Rider Farrington High School, who were present in the gallery, including Vice Principal Ron Oyama, Jed Cardenas, Francis Garcia, Chris Afa, and Daniel Sanchez.

Senator Gabbard honored and commended the Windward Zero Waste School Hui, and presented the following remarks:

"Mr. President, colleagues, and our guests in the gallery, here's a question you may not have pondered before: How many tons of food waste do you think three elementary schools can generate in a year? A ton? Two tons? How about over 31 tons? We are honored to have with us today the Windward Zero Waste School Hui, which is made up of three schools: Ka'ōhao Public Charter School, Ka'elepulu Elementary, and Kainalu Elementary, who are 100 percent dedicated to food waste recovery and food security. In fact, the 2017 food waste recovery total among these three schools was 63,400 pounds that means over 31 tons of food waste not dumped in our landfill. So, you may ask, what happens to all this waste? Well, instead of lecturing and testing students on food waste recovery and food security, these schools are actually involving their keiki in a hands-on approach to every step of recycling food, paper, and cardboard waste.

"Recently, Senator Thielen and I were invited to see them in action firsthand. We began the visit at Kainalu Elementary in, appropriately, the cafeteria, during lunchtime. As students finished eating, they lined up before buckets that were already arranged and manned by their fellow students wearing hairnets and aprons, and then the magic started to happen. Students began dumping their food scraps into one bucket; milk and liquids went into another bucket, paper waste into another container, separating and stacking the paper trays. It was all organized and routine, almost reminiscent of an assembly line. The food waste was quickly moved to an outdoor area, where a student weighed the food scraps; another student recorded how many gallons of liquid waste there were – of course, they were

incorporating their math skills – and then the buckets were transported a couple hundred yards by a parent volunteer driving a golf cart to be dumped and mixed into hot compost piles that neatly surround the school's organic garden. After being layered with soil, green waste, and water, the leftover food, which would normally create a smelly mess and fill up landfill space, is left to cook for six months. Leftover compost: How about a compost club for the folks who live around the school, where they can come by and buy some compost, with that money going to support the program? And I talked to one of the janitors, who'd been there forever at the school – 25, 30 years – and the janitorial staff were a bit skeptical at first, with this new change and everything, but when I talked to this one guy, he looked at me and he says, 'Eh, brah, no stink in the dumpster, no flies; we are in heaven! We love this program!'

"The hui schools also built and maintain vermicast bins, where worms work hard to process food scraps along with paper and cardboard waste. The result: soft, sweet-smelling soil that will nourish the school garden and, yes, the students plant and maintain and harvest that as well. How successful is the Windward Zero Waste School Hui? For the students, this is a way of life now, and they in turn have the potential to grow a healthier future society. Think about this: If all of Hawai'i's 292 public schools adopted this protocol for dealing with food waste, it's estimated the annual dumpster diversion would be about 7.5 million pounds, and almost 9,000 cubic yards of rich compost would be produced, and 236 green jobs would be created to implement the program. The hui program is actively changing the mindset of the next generation to one where there is no waste, where everything can be reused, and growing your own food is fun and 'ono. In recognition of their amazing program, the EPA selected them for the top award in the nation in the 2016 Food Recovery Challenge. So, at this time, I'd like to yield the floor to my colleague from Kailua to say a few words.'

Senator Thielen rose to present the following remarks:

"I'm proud to introduce the three schools that make up the Windward Zero Waste Hui, which are in my district. Ka'ōhao Public Charter School, which was formerly Lanikai Elementary School, as Senator Gabbard mentioned, won first place in the 2016 Food Recovery Challenge. But in addition to recycling 100 percent of their food waste, they also recycle 98 percent of their cans, bottles, green waste, paper, cardboard, and Mylar, and they also use recycling as a learning opportunity. In December, they had the sad announcement that their 54-yearold monkeypod tree needed to be removed due to the roots breaking the water lines. (I'm sad to say I was a student at the school when that tree first went into place.) The third graders were studying the carbon cycle, and they designed a plan for reuse of the beloved tree: The small branches and leaves were ground into composting mulch; the woody mulch from the big branches would be spread around the property for soil restoration; and the trunk was made into benches and tables to enhance the campus. When the tree was torn down on December 21, the tree cutters said it was the first time for them to have nothing left in their trucks for disposal after a large treecutting: zero waste.

"Ka'elepulu Elementary, one of the other schools, started their program in August 2016 with their 201 students. They also recycle a hundred percent of their cafeteria breakfast and lunch food waste and a hundred percent of their cans and bottles and some of the green waste.

"Kainalu Elementary, as the senator mentioned, has a compost club. They started their program in January 2017. All 463 students are recycling a hundred percent of their cafeteria

breakfast and lunch food waste and a hundred percent of their cans and bottles. I can personally attest to the quality of the compost, which they test there, which is of a far, far higher quality and value than the compost that's made by the traditional green waste processors in Hawai'i, and also their vermicast, because I'm using both, as a member of the compost club, in our orchard. Our lemon trees are doing fantastic and the leeks that we're producing this year are much bigger than anything in prior years. So thank you very much for your efforts and your work, and I know that there are many members in the community who are signing up to become members of the compost club.

"All three of these Windward Hui schools will be entering their 2017 data that they keep from their environmental programs to the EPA national Food Recovery Challenge and, again, they do this as a learning opportunity to be graphing and charting and measuring the weights of the collection, the temperatures of the compost piles, and the value of the compost that's produced. So thank you very much, and I turn it now back to Senator Gabbard."

Senator Gabbard rose and stated:

"The folks behind this wonderful program are: First is the founder and the hui coordinator and former State Representative, Mindy Jaffe; and also the site leader and parent volunteer, Heather Marsman. I would also like to recognize Lindsey Whitcomb, a former site leader and current fundraiser for the program, who couldn't be here with us today as she is in Connecticut, and Jordan Nelson, the hui operations manager, who is busy managing lunch collections at their hui sites right now as we speak.

"The Hawai'i State Senate hereby honors and commends the Windward Zero Waste School Hui for involving our keiki in recovering food and other school waste. Your inspiring example will hopefully plant the seeds of change in the other 289 public schools statewide as well as in our private schools as well as in our homes, our businesses, and around the world. With zero waste and abundant gardens, we can all flourish. We wish you success and many more hot compost piles and wriggling worms. So mahalo nui loa. Please, another hand for our guests."

The Chair commented to Senator Gabbard and Senator Kidani that there certainly may be an application in the measuring of waste that they're doing at the three schools that would assist in the Farm to School Program as well, as they strive to get more and better data to help with that program.

At 11:51 a.m., the Senate stood in recess subject to the call of the Chair.

The Senate reconvened at 11:57 a.m.
