Monday, March 19, 2018

The Senate of the Twenty-Ninth Legislature of the State of Hawai'i, Regular Session of 2018, convened at 11:39 a.m. with the President in the Chair.

The Roll was called showing all Senators present with the exception of Senators Harimoto and Ruderman who were excused

The President announced that he had read and approved the Journal of the Thirty-Second Day.

At this time, Senator Espero recognized Kaniala Peters Clark, a senior at James Campbell High School whose interests include government and politics, who was spending his spring break as a volunteer in Senator Espero's office.

Senator Keith-Agaran introduced friends Mike Shimei and his sister, Barbara Shimei, and John Gasidlo, who were accompanied in the gallery by Senator Keith-Agaran's wife, Kallie.

Senator Gabbard recognized and honored Hui O Ho'ohonua (HOH808), and presented the following remarks:

"Colleagues and guests, it's my honor and pleasure to introduce the Hui O Ho'ohonua (HOH808), a 501(c)(3) nonprofit community development networking organization that is restoring the land surrounding Pu'uloa and the Pearl Harbor and neighboring 'Ewa moku to once again provide food. 'Pu'uloa' refers not just to the main mountain surrounding Pearl Harbor but to the waters that feed it. 'Ewa is the only moku where the rivers of all 12 of its ahupua'a converge into one place: Pearl Harbor. Historically, this area was 'āina momona, or 'abundant land,' and, as a side note, it's interesting that the Hawaiian concept of 'āina momona can be likened to the biblical expression of 'the land flowing with milk and honey.' Thus, HOH808's vision of a Pu'uloa as a land plentiful with lo'i, fishponds, and sustainable community gardens seeks to inspire all that they do. Hui O Ho'ohonua also envisions their efforts as a way to address existing hazards to human health caused by pollution over the last 100 years.

"Folks, these may seem like challenging tasks to accomplish, and they are. But would we expect anything less from an organization whose mission statement is 'Impossible is where we start'? That is actually their mission statement: Impossible is where we start. And how, you may ask, does one accomplish the impossible? By practicing HOH808's core values, which are, first, maintaining the faith of a child in accomplishing the impossible; second, honoring every citizen with dignity and selfless service; and, third, conducting business ethically and professionally with integrity. As a centralized hub, HOH808 initiates, administrates, operates, and maintains a network connecting all levels of the community to accomplish sustainable community development initiatives, such as modernizing alternate transportation corridors, completing restoration of contaminated ecosystems, and the reutilization of stormwater runoff. HOH808's core values motivate them to strive for the impossible. Their hard work, determination, and aloha resulted last October in the official renaming of the former West Loch Shoreline Park to Kapapapuhi Point Park, serving to initiate the healing process caused by years of sacredsite desecration. HOH808's work at Kapapapuhi includes restoration of the park's entire shoreline area, its wahi pana, and the three Apokeo fishponds. These sites will be used to educate the community of the cultural importance of the fishponds and the wahi pana and the impact their restoration will have on future generations. Other significant HOH808 accomplishments

include a community Pu'uloa bike path cleanup event, a collaborative effort to restore Loko Pa'aiau fishpond, and a meta-study of existing research and planning initiatives for the Pu'uloa region.

"In closing, we'd be remiss to not celebrate their recent accomplishment in the introduction of House Concurrent Resolution 214, introduced by Representative Ty Cullen, which recognizes the 30-day period from the last Saturday in September to the last Sunday in October as Malama Pu'uloa Month, celebrating one of the first settlement sites on O'ahu. If passed, Malama Pu'uloa Month would be an island-wide community celebration of the sacred waters of Pu'uloa, celebrating not only Pu'uloa herself but all that she touches, including the streams and marshes that surround the sacred waters. The month-long celebration seeks to educate the community on Pu'uloa's rich and culturally significant history; educate a generation in a collaborative approach with public and private organizations within the community to come up with the best solutions for the clean-up of Pu'uloa; encourage everyone island-wide to learn the mo'olelos of Pu'uloa so that they may attain a deeper connection with whatever part of the island that they're from; and, lastly, this would culminate in a festival at Kapapapuhi Point Park.

"And so, I'll introduce Tony Chance, executive director; Sandy Webb, chair of the board of directors; Heath Todd, vice president; Carena Phillips, visual communications; and Trey Lima, project leader. Jordan Muratsuchi, the outreach coordinator, could not be here today because of sickness. So the Hawai'i State Senate hereby honors and commends Hui O Ho'ohonua – mahalo to executive director Tony Chance and the entire HOH808 team for being guardians of Pu'uloa. Your attitude of taking on the impossible and persevering with faith, honor, and integrity should be an inspiration for all in achieving good for the community, ecosystem, and culture. Please give them another hand, and thank you."

At 11:47 a.m., the Senate stood in recess subject to the call of the Chair.

Senator Wakai informed the members that it was Manufacturing Day at the State Capitol, with exhibits on display from 20 companies that manufacture food, technology, and other products. Senator Wakai noted that manufacturing accounted for over \$2 billion in exports the previous year, and invited the members to a luncheon in Room 429 at 12:30 p.m.

Senator Kim acknowledged that it was Women in Public Office Day, celebrated across the country together with the National Foundation for Women Legislators, and congratulated and thanked her women colleagues for their service. Senator Kim noted that the Senate had passed a concurrent resolution recognizing this day, but the House of Representatives had not yet passed it.

Senator Kidani announced that floor presentations honoring the 2018 Teachers of the Year would take place the following day, with more activities relating to Education Week to follow.
