THIRTY-SIXTH DAY

Thursday, March 22, 2018

The Senate of the Twenty-Ninth Legislature of the State of Hawai'i, Regular Session of 2018, convened at 11:38 a.m. with the President in the Chair.

The Roll was called showing all Senators present with the exception of Senator Harimoto who was excused.

The President announced that he had read and approved the Journal of the Thirty-Fifth Day.

At this time, Senator Kidani introduced her "beautiful baby sisters," who were seated in the gallery: Patty Rivas, who was visiting from San Diego, California; and Cindy Asuncion and her husband, Frank, who live in Waipio Gentry.

Senator Espero recognized Illinois State Representative Mike Fortner, who was seated in the gallery with his wife.

Senator Espero then welcomed a group of sixth-grade students from Holomua Elementary School, who were present in the gallery with teachers Rachel Takabayashi and Ku'ulei Serna

Senator Ruderman acknowledged the following visitors from Hawai'i island, who were visiting the State Capitol to participate in Charter Schools Day: Principal Steve Hirakami from the Hawai'i Academy of Arts and Science (HAAS) Public Charter School, and Principals Susie Osborne and Kapoula Thompson from Kua O Ka Lā Public Charter School.

Senator Thielen recognized Principal Ed Noh from Kaʻōhao School, formerly known as Lanikai Public Charter School, Senator Thielen's alma mater.

Senator Kidani acknowledged the following charter schools that had provided informational displays in Conference Room 224 that morning: Hakipu'u Learning Center in Kāne'ohe; Hawai'i Technology Academy in Waipahu; Kamaile Academy in Wai'anae; Kamalani Academy in Wahiawā; the School for Examining Essential Questions of Sustainability (SEEQS) and Wai'alae Elementary Public Charter School in Kaimukī; DreamHouse, to be opened in 'Ewa Beach in 2019; the Hawai'i Academy of Arts and Science Public Charter School and Kua O Ka Lā Public Charter School in Pāhoa; Innovations Public Charter School, Kona Pacific Public Charter School, and West Hawai'i Explorations Academy Public Charter School in Kona; Ka'ū Learning Academy in Na'alehu; and Kualapu'u Public Conversion Charter School on Moloka'i. Senator Kidani also acknowledged State Public Charter School Commission director Sione Thompson and board chair Catherine Payne for their work on behalf of the 36 charter campuses now operating across the state.

Senator Kidani then honored and recognized the Prudential Spirit of Community Award recipients, and presented the following remarks:

"This morning, we welcome exceptional middle- and high-school students who are recognized for their outstanding school and community service. They were selected for the Prudential Spirit of Community Awards for the State of Hawai'i – the largest such youth recognition program in the U.S. The awards are sponsored by Prudential Financial in a partnership with the National Association of Secondary School Principals. Since 1995, the program has honored more than 120,000 youth volunteers at the local, state, and national level. The stories of our honorees demonstrate an uncommon commitment to service to others that is truly inspirational. To begin our introductions: Senator Espero."

Senator Espero presented the following remarks:

"Mr. President and guests, I'd like to first introduce Ms. Mahealani Sims-Tulba, this year's Prudential Spirit of Community Awards winner. This nationwide program is the largest youth recognition award system based on volunteer community service. In 1995, the Prudential Spirit of Community Awards was created in partnership with the National Association of Secondary School Principals to pay homage to students in grades 5 through 12 for their service to others nationally, statewide, and locally. The goal of the program is to applaud young people already making a positive impact in their communities and also to embolden others to consider how they may enrich their neighborhoods.

"Mahealani Sims-Tulba is a senior at Sacred Hearts Academy. She is known by many for the book she authored on bullying titled *It's Okay to Be Different*. She uses the book to connect with and encourage other young people – many who might be facing bullying. Much of her community service involves reading and talking to elementary-, intermediate-, and high-school students at schools and libraries, where she freely gives copies of her book along with her silicone bracelets.

"Mahealani also established a nonprofit foundation to disseminate the problem of bullying to students throughout Hawai'i. Her B.R.A.V.E. campaign, 'Be Respectful and Value Everyone' – words we should all live by – includes a music video that she created, a weekly television program appearance, an annual toy drive for children in need, and participation in innumerable community events. Mahealani's B.R.A.V.E. campaign has touched more than 40,000 students across Hawai'i. I look forward to the bright future that lies ahead for Mahealani and her continued dedication to bettering our state and its people. Congratulations, Mahealani. And, in the audience, if I may: residents of 'Ewa Beach, her parents, Mr. Augie T. and his wife, Kim."

Senator Tokuda presented the following remarks:

"It is my honor to acknowledge Grace Kennedy, who unfortunately could not be here today but is the recipient of the 2018 Prudential Spirit of Community Award as one of Hawai'i's top youth volunteers. Grace is an eighth-grade student at St. Anthony School in Kailua, Hawai'i, who has raised thousands of dollars to benefit sick and abused children in Hawai'i since joining Kidz For A Cause as a board member. She began her volunteerism at an early age by selling tickets to a benefit theater show and raising \$1,000 to help purchase clothes, toys, and school books for children at the Children's Justice Center on O'ahu. She then recruited her friends to help organize a celebrity chef dinner for 100 people, raising more than \$6,000 to expand a local hospital's neonatal intensive care unit. She will receive a well-deserved thousand-dollar cash reward and engraved silver medallion and a trip to Washington, DC, from April 28 through May 1, 2018, to meet top youth volunteers from around the world. It is with great pleasure that I acknowledge Grace Kennedy, a 2018 Prudential Spirit of Community Award recipient. While she cannot be here today, let's give her a well-deserved round of applause."

Senator Rhoads presented the following remarks:

"It's my privilege and honor to introduce Justin Wong, the Prudential Spirit of Community Awards distinguished finalist. Justin is 18; he lives here in Honolulu; he's a senior at Roosevelt High School. He has worked with other young members of the Center for Tomorrow's Leaders to reduce political polarization among his peer group by creating public dinner discussions and starting discussions online. An avid

volunteer with 400 service hours to his credit, Justin has served two terms as president of his school's Leo Club and has participated in beach cleanups, pet walks, and other volunteer activities. Thank you very much; thank you for your service, and can we give him another round of applause? Joining him today in the gallery are his parents, Karen Wong and Guokan Huang. Thank you, Mr. President."

Senator Kidani presented the following remarks:

"Colleagues, I am super pleased to introduce Emily Smith. Emily is a 15-year-old sophomore at Hoʻala School in Wahiawā, and I note with pride that she and her family reside in my district in Mililani (for which she gets extra points). Emily is also involved in a cause that is near and dear to my heart: She is founder of a pet-rescue organization she calls Lend-A-Paw. Through manufacture of dog treats and pet toys, and support of charity fundraising efforts, Lend-A-Paw aims to ensure that shelter animals are able to live in a safe environment and are well-fed. As might be expected, Emily uses social media to spread the word, through a website, a YouTube channel, and presentations in schools and elsewhere in her community. Well done, Emily – thank you for your commitment to this wonderful cause. And I'd also like to acknowledge her mother, who's in the gallery: Noriko Lancaster.

"I also would like to recognize the representative from Prudential who has been accompanying these students around their visit to the Capitol today – Gerri Marks, Prudential vice president for government affairs. Gerri, thank you so much for bringing the students and helping them with their scholarships. I hope that you'll continue to bring students to us each year to recognize for their very, very wonderful work in the community; thank you."

Senator Kidani then recognized Bianca Yanuaria for being selected as the 2018 Hawai'i School Counselor of the Year, and presented the following remarks:

"Mr. President, during National School Counseling week in early February, Sylvia Koch – a longtime counselor at Kipapa Elementary School in my Senate district – wrote a thoughtful essay about the importance of school counselors in our public schools. Sylvia is president of the Hawaii School Counselor Association. In discussing the importance of school counselors in the education process, she writes that they take an active and sometimes critical role in helping students cope with difficult situations, and teach them strategies to deal with the conflicts that confront them. The 600-plus Hawai'i public- and private-school counselors work behind the scenes, she says, as they support their school faculty and teach students character education, violence prevention, career planning, and much more.

"Each year, the association selects a Hawai'i School Counselor of the Year, who participates in national events. Our guest this morning had the honor of meeting with former First Lady Michelle Obama when she was in Washington, DC, in February. We are so pleased that she can be with us. Here to introduce her is Senator Thielen."

Senator Thielen presented the following remarks:

"Thank you, Mr. President, and thank you, Senator Kidani, for that introduction, which recognizes the magnitude of this award and the importance of school counselors. Colleagues, I'm very proud today to introduce Bianca Yanuaria. As Senator Kidani mentioned, the Hawai'i School Counselor of the Year award is a very competitive competition with over 600 – both public and private – school counselors to choose from. School counselors have a great impact on so many of our keiki: They help students cope with life lessons outside of classroom content and help develop the whole child. Bianca is a spectacular counselor. She has made a huge and positive impact

at Keolu Elementary, earning herself this national recognition. In just four years at Keolu Elementary, Bianca was able to accomplish significant initiatives, including creating a recess program to deal with conflict resolution on the playground. She reduced chronic absenteeism by 11 percent, and she helped start the Aloha Committee to build relationships among faculty. It's clear that Bianca fully embraces her role and has found her calling, for which we are very grateful. She was quoted as saying, 'It's humbling to be recognized for doing what I'm passionate about.' Colleagues, we all recognize that in today's world, when there's so many traumas going on at high schools because students are feeling isolated and alone, the importance of counseling. Especially in our elementary schools, so students can gain these conflict resolutions and other ways to channel their emotions into positive outlooks so that we can have a safer and more robust Hawai'i. We greatly appreciate what you do. Thank you very much, Bianca, for encouraging our kids to keep going. It's apparent that you, yourself, have gone above and beyond to give these children the support that they need to thrive. The Senate recognizes your award and appreciates your

"I'd also like to recognize Bianca's family, and I know that they play a great deal in her role by providing support to her; they've come in today from Maui and also from Las Vegas. We have Bianca's husband, John Datiles; her father, Ben Yanuaria; her aunties Letty Tuazon and Jackie Yanuaria-Domingo; her cousin Chris Yanuaria; and, most importantly, her grandma Romana Yanuaria. Mahalo, Mr. President, and I would like to turn the microphone back to Senator Kidani."

Senator Kidani rose and stated:

"It is always a pleasure to be able to recognize excellence in our public schools. Colleagues, I urge you to take some time to visit your neighborhood campuses. You will be amazed at what you learn and by the people you meet. Stop by in the early morning to have school breakfast; drop in at one of the schools in Mililani that are next up in the Farm to School fresh and fabulous lunch program. Talk with teachers and principals and counselors and students. You will know from these experiences why it is critical that we fully fund public education: to build Hawai'i's future.

"Colleagues, Mr. President, thank you so much for this week, helping to honor all the wonderful people and the wonderful things that make us proud of our public schools. Thank you for your participation in this week's presentations. Mahalo."

The Chair praised the excitement and enthusiasm of Bianca Yanuaria's grandmother and other family members, as they proudly waved and smiled to her from the gallery to celebrate her achievements.

At 11:58 a.m., the Senate stood in recess subject to the call of the Chair.
