Friday, March 23, 2018

The Senate of the Twenty-Ninth Legislature of the State of Hawai'i, Regular Session of 2018, convened at 11:43 a.m. with the President in the Chair.

The Roll was called showing all Senators present with the exception of Senator Harimoto who was excused.

The President announced that he had read and approved the Journal of the Thirty-Sixth Day.

At this time, Senator Inouye introduced Telisha Mahan and her eight-year-old daughter, Ava – visitors from Aztec, New Mexico, who were seated in the gallery with Telisha's brother Nick Martin and his wife, Sarah, who were visiting from Vermont

Senator Kidani acknowledged Justine Jumalon, a senior at Waipahu High School who had spent her spring break volunteering in Senator Kidani's office. Senator Kidani noted that Justine, an honors student ranked in the top 25 students out of more than 500 classmates, maintained a high grade point average, was enrolled in early college classes, was active in the school's engineering academy, and played alto saxophone in the school band while serving as band president, along with numerous other activities. Senator Kidani praised her for her accomplishments, and urged the members to join her in appreciation for Justine's help and hard work.

Senator Dela Cruz congratulated Zaria Dudley on being named a Gold Medal Portfolio Award winner for 2018, and presented the following remarks:

"Colleagues, today we recognize Zaria Dudley on being named a Gold Medal Portfolio award winner for 2018 by the Alliance for Young Artists & Writers. The Scholastic Art & Writing Awards is the nation's longest-running and most prestigious recognition and scholarship program for creative teens in grades 7-12 presented by the Alliance for Young Artists & Writers. In 2018, from a record-breaking 346,000 works of art and writing that were submitted, more than 2,800 teens nationwide received national recognition from the alliance within the award's 29 categories for adjudication by an impressive panel of creative-industry experts. All submissions are judged on originality, technical skill, and emergence of personal vision or voice, and adjudicated regionally through more than 100 local affiliates of the alliance. Sixteen students were selected to receive top honors in the ninety-third annual Scholastic Art & Writing Awards, Gold Medal Portfolio, which includes a \$10,000 scholarship. Zaria Dudley, a senior at Leilehua High School, was one of the 16 students selected to receive top honors for her nationally recognized portfolio, 'Life Unscripted,' portraying the lifestyle and culture of the African-American community. Zaria's work will be displayed at the Art Write Now 2018 National Exhibition and will be honored on June 7 at Carnegie Hall as part of a week of national celebration in New York City. Let's give her a round of applause. We extend our congratulations to Zaria Dudley on being named a Gold Medal Portfolio award winner and extend our best wishes for continued success in all her endeavors. Today we have joining Zaria her proud parents, Mr. and Mrs. Michael Dudley. Thank vou."

Senator Kidani commended Sheri Rolf, Hawaii Foodbank food drive coordinator, and presented the following remarks:

"As you know, colleagues, from time to time, we get involved in discussions about 'food security.' Often these discussions are in terms of assuring an adequate food supply for island residents by encouraging local agricultural enterprises

and food processing plants and so forth. Those are 'big picture' issues. For 20 percent of the state's residents – that's one out of every five people who live in Hawai'i – food security is much more narrowly focused. Think, 'Where is my next meal coming from?'. Think, 'How am I going to feed my family this week?''. More than 120,000 households now receive food assistance in some form through the Hawaii Foodbank and a network of food pantries, soup kitchens, rehabilitation centers, homeless and domestic abuse shelters, and other venues and programs. Sustaining this effort requires tremendous focus and hard work by a corps of dedicated volunteers. There is no one more focused and hard-working than our honoree this morning, Sheri Rolf – director of the Hawaii Foodbank Annual Food Drive for the past 29 years.

"Sheri and her volunteers kicked off the 2018 Food Drive in late January. Momentum builds each year through the spring, and culminates this year on April 21, when hundreds of people will be out all day, island-wide, to collect food and monetary donations. Thousands will contribute and everyone celebrates. However, the work goes on, as the need does not diminish. Success is assured because of people like Sheri Rolf, who readily declares, 'I feel lucky to have the privilege of serving in this position, as it is the best volunteer job ever. We just want to provide hope for tomorrow.' Mahalo, Sheri, for all of your hard work for nearly three decades with Hawaii Foodbank. We have asked all senators to bring something with them this morning so that you don't leave empty-handed.

"I would also like to introduce Sheri's guests in the gallery this morning, starting with her husband, Dave Rolf; also Malcolm Inamine, interim president and CEO of Hawaii Foodbank; and the rest of the Hawaii Foodbank staff. Thank you. Mahalo."

At 11:53 a.m., the Senate stood in recess subject to the call of the Chair.
