#### THIRTY-NINTH DAY

#### Wednesday, March 28, 2018

The Senate of the Twenty-Ninth Legislature of the State of Hawai'i, Regular Session of 2018, convened at 11:38 a.m. with the President in the Chair.

The Roll was called showing all Senators present with the exception of Senator Harimoto who was excused.

The President announced that he had read and approved the Journal of the Thirty-Eighth Day.

At this time, Senator Rhoads welcomed a group of constituents from Nu'uanu, Pu'unui, and Liliha who were touring the State Capitol that morning. Senator Shimabukuro introduced State Representative Cedric Asuega Gates, who was present in the gallery with Aunty Sweetie from O'ahu's Westside.

Senator Shimabukuro then congratulated Kahumana for its outstanding contributions to the community, and presented the following remarks:

"Alternative Structures International is better known as Kahumana. They are located in the beautiful Lualualei ahupua'a of Wai'anae, where it just celebrated its fortieth birthday this year. Through the state's Homeless Programs Office, Kahumana is now the largest provider of homes and jobs for homeless families on O'ahu, serving over 1,000 homeless keiki and their parents and kūpuna each year. Through their jobs program, in the last year, Kahumana placed 155 previously unemployed and homeless people in permanent jobs. Clients were placed in Aulani Resort and other hotels; Monkeypod and other restaurants; Longs Drugs and other retail establishments, such as Walmart and Home Depot. Through the state's Developmental Disabilities Division, Kahumana is a provider of services to the growing population of people with developmental disabilities and autism through its Leeward and Windward learning centers.

"For 10 years, Kahumana has been making 1,200 local healthy lunches a day in their Kahumana training kitchen, featuring produce from the Kahumana Organic Farm, and delivering them to over 35 locations. Kahumana is losing their lease on their current training kitchen and is seeking to build a new one that will train 50 homeless, unemployed, or disabled people per year. The new kitchen will make double the number of healthy lunches per day and deliver them to homeless shelters, to Head Start and other daycare, preschool programs, elementary schools, and the YMCA.

"Colleagues, 40 percent of O'ahu's homeless families live in Wai'anae. All of them live with extremely low income, and 35 percent are unemployed. These families often do not qualify for long-term permanent housing subsidies; Section 8 and public housing are not available for most of these families as well. Therefore, Kahumana is focusing on its mission to increase income through work. They have a community-based approach that's been successful for 40 years in Wai'anae, and

now they're taking their unique and holistic approach to other communities throughout the state.

"Representing Kahumana today are one of its founders, Father Phil Harmon, and CEO Tom McDonald. And also, in the gallery, we have Audrey Enseki-Tom, the project coordinator. Thank you very much."

Senator Shimabukuro then recognized and honored Puamakamae DeSoto, and presented the following remarks:

"The Buffalo Big Board Surfing Classic, regarded as the waterman Olympics of the world, was founded in 1976 by Mākaha waterman Buffalo Keaulana and boasts the largest variety of surf disciplines in any one contest. In the 2018 Buffalo Big Board Surfing Classic, Puamakamae DeSoto achieved the Waterwoman of the Year honor - the highest female honor - with the highest overall combined score of any female in the event. More impressively, Puamakamae, at age 12, is the youngest person in history to receive this honor. The Buffalo Big Board Surfing Classic hosted 13 events, from the traditional finless alaia shortboard to the newly innovated 16foot-long, 8-foot-wide SUPsquatch. These were two of the seven disciplines in which Puamakamae competed. The other five include the traditional paipo, women's open longboard, tandem surfing, team stand-up paddle surfing, and tandem bullyboard.

"Aside from being an outstanding athlete, Puamakamae is an honor roll student at 'Iolani School and a proud product of Hawaiian language immersion education through the sixth grade. Puamakamae is also a published poet and photographer. Her carefree style and rigor in the ocean attribute to a legacy Mākaha waterwoman, including Pua Mokuau and Rell Sunn. As motivated and busy as Puamakamae is, she still finds time to volunteer every month at Nā Kama Kai's ocean clinics, sharing her aloha and knowledge of the ocean with the youth of Hawai'i. Her achievements and contributions to ocean culture and the community inspire and remind us how the ocean empowers our youth.

"I want to give a special thanks to Senator Donovan Dela Cruz and his staff for coordinating this floor presentation.

"The Senate of the State of Hawai'i congratulates and honors Puamakamae on being named the 2018 Buffalo Big Board Surfing Classic Waterwoman of the Year. She is accompanied today by her very proud parents, Mālia Ka'aihue and Duane DeSoto. And in the gallery, we've got grandparents Pamela and Abraham Kapana Jr.; Cathy DeSoto; sisters Honua and Keānuenue DeSoto; and aunty Pua Ka'aihue; and anyone else for the DeSotos."
