#### FORTY-FIRST DAY

### Monday, April 2, 2018

The Senate of the Twenty-Ninth Legislature of the State of Hawai'i, Regular Session of 2018, convened at 11:36 a.m. with the President in the Chair.

The Roll was called showing all Senators present with the exception of Senator Harimoto who was excused.

The President announced that he had read and approved the Journal of the Fortieth Day.

At this time, Senator Galuteria introduced James Thomas Lee Labrie, who was present in the gallery with his foster mom, Eulalia Paz.

Senator Ihara welcomed a group of fourth-grade students from Ala Wai Elementary School, who were seated in the gallery with teacher Lori Kwee, skills trainer Marie Pagaragan, and parent chaperone Ricardo DeLacayo.

Senator Green recognized the following representatives from Hawaii Building Future Champions, a nonprofit organization that provides a football program for high-risk youth: chief executive officer and commissioner Pastor T; coach Pule Toloumu; coach Alefosio Iu; student athletes Melmolina Adtrik Piamon, Royce Wilms, Talitonu Alauni, Freddie Gregorio, Tony Matautia Jr., Mauga Tauiliili; board secretary Camille Rockett; Jay King; Clayton Tom; and board director and assistant commissioner Pastor Ava.

Senator Tokuda honored various Oroku Aza restaurant owners, and presented the following remarks:

"Good morning, colleagues. For almost a century, the honorees on the floor and in the gallery have been bringing Hawai'i's people together around food. They have been the goto places to meet and eat, the comfort food all of our families have craved, the supermarkets that fill our refrigerators. But what most may not realize is that to understand how they came to be, you also have to know where they all came from. You know that saying, 'It takes a village'? Well, the Uchinanchu who opened these establishments emigrated from Oroku, Okinawa. This project began when Columbia Inn closed in 2000 (my husband and I still crave a chopped steak, and we can hear the sizzling platter and smell it and definitely want one right now, I can tell you that much), and Gene Kaneshiro and Howard Takara, along with his daughter Holly, who was then the president of our Oroku Azajin Club, spearheaded the Hawaii Okinawan Restaurant Project. It has since documented the story of how Ushi Takara, who started American Café in 1923, took in dozens of Uchinanchu from Oroku under his wing, mentoring them and helping them to open their own restaurants. Overall, the project has identified over 325 restaurants in Hawai'i that were owned or being run by Uchinanchu, of them 75 from Oroku village. As a yonsei whose great-grandparents Kama and Moshi Kakazu also emigrated from Oroku and with relatives among the honorees here today, I am both humbled and grateful for the opportunity to recognize generations of businesses that have contributed to Hawai'i and still do today.'

Senator Tokuda then recognized the following honorees: Sidney Takara, grandson of Ushi Takara, who owned and operated American Café and was known as the "Father of Oroku Restaurants" for teaching, training, mentoring, and supporting many Oroku restaurant owners; Howard Takara, former board member of the Oroku Azajin Club and son of Yuki Takara, who owned Harriet's Saimin and Yuki's Café; Howard Takara's wife, Jane; Ethel Teruya, wife of Wallace Teruya and sister-in-law of Albert Teruya, owners of T&W Coffee Shop, Times Grill, and Times Supermarkets; and Ethel Teruya's son

Dexter Teruya, daughter-in-law Valerie Teruya, daughter Rosemarie Love, and grandson John Love.

Senator Dela Cruz recognized the following honorees: Galen Teruya, president of the Oroku Azajin Club from 2014 to 2015 and grandson of Albert Teruya, who owned T & W Coffee Shop, Times Grill, and Times Supermarkets; Gene Kaneshiro, son of Fred Kaneshiro and nephew of Gentaro Kaneshiro, owners of Columbia Inn; Doris Sheppard, Gentaro Kaneshiro's daughter; Robert and Jeanne Kaneshiro, Gentaro Kaneshiro's son and daughter-in-law; Judy Morita, daughter of Masaji Uyehara, who owned Aiea Drive Inn, Ilima Drive Inn, Keone's Lounge, and Smile Café with his brothers Sam and Johnny; Judy Morita's son Wayne Morita and grandson Gavin Morita; and Beverly Taira, president of the Oroku Azajin Club, who served for many years as a board member, vice president, and president-elect, and who has supported the documenting of the 75 Oroku Azajin restaurants.

Senator Kim recognized the following honorees: Karen Nakamura, daughter of Robert and Nancy Teruya, owners of Aloha Grill, a restaurant located in the heart of Honolulu on Bethel Street that held banquets and had a bowling alley; Karen Nakamura's husband, Wayne; Linda Teruya; Ruby Uehara, Virginia Takara, Leatrice Kakesako, and Harry Teruya, whose father, Kana Teruya, owned Lucky Grill, U.S. Café, Choice Inn, and Kaimuki Inn; and Shari Tamashiro, who was instrumental in documenting the history of the family restaurants by guiding Howard Takara, Holly Takara, and Gene Kaneshiro in recording the oral histories of 12 restauranteurs and creating an Okinawa Restaurant Exhibit at Honolulu Hale so that the story of Okinawan-owned restaurants would not be lost.

Senator Tokuda rose and stated:

"Thank you very much, colleagues, for helping us to acknowledge, again, generations and decades of Uchinanchu establishments that have helped to feed so many of our island families. And, yes, we're all very hungry, so please also, as has been told to all of your offices, join us for some food and fun and fellowship - I think I even might have seen a sanshin case with some of you - right after session as well. We will be feeding you! I assure you there will be andagi and there will be pork and possibly even some bitter melon, for those of you who would dare. But let's give another round of applause for all of our honorees and our special guests here with us on the floor and in the gallery. And as might have been also mentioned, generations continue, and we're so proud to see not just our nisei and sansei here, but the yonsei and gosei are also carrying on the torch. So the fact is, if you want to continue to eat this food, Oroku restaurants are continuing; establishments like Tatsuo's on Sand Island are carrying on what started off generations ago. The legacy continues, so we're very proud to see that."

The Chair then stated:

"Before calling for the recess, I wanted to just take care of a housekeeping item before I forget. To Senator Keith-Agaran, I extend my apologies. When I thanked Senator Rhoads for his drafting of the initial bill last year that the Senate moved over and Chairs Baker and Taniguchi for the hard work last year, I forgot that Senator Keith-Agaran was that hard-working Judiciary chair, so, Senator Keith-Agaran, I corrected it in the press release but publicly want to extend my thanks to you and Senator Taniguchi for carrying the torch this session."

At 11:58 a.m., the Senate stood in recess subject to the call of the Chair.

The Senate reconvened at 12:05 p.m.
