## Friday, April 6, 2018

The tourism special fund ceiling is lowered from \$87 million to \$83 million to allow for funding HTA at \$60.3 million, LNR at \$13.9 million, and UOH at \$3 million. All revenues generated over the ceiling are deposited into the general fund."

"Colleagues, we are saddened at the loss of our beloved Senator Daniel Kahikina Akaka this morning, the aloha statesman. Much has been said about his incredible public service in the short period since his passing this morning at about 4:30 a.m. I would like to offer a few words that speak to not only his public service as we well know – because we aspire to be Senator Daniel Kahikina Akaka in all that we do.

"We often wonder how he made it through such a hostile environment in Washington, D.C., and still remained the aloha statesman, but I think that in knowing the way he grew up would make us understand why he was such that statesman. May I offer to you that his faith in God was his source of aloha and that all that he believed in informed all of his decisions. And how do I know that? That's because we're all Kawaiaha'o Church folk. From the very beginning, I knew him as Uncle Danny - Senator Uncle Danny. I grew up with his children, Millannie, Danny Boy, Gerard, Millannie's other brother Alan, and Millannie's other brother Nicky. So we grew up each Sunday knowing and loving each other, along with the other clans at Kawaiaha'o Church: the Kamakawiwooles, the Burgesses, the Donlins, the Kaaihues, and the Galuterias, and, of course, the Akakas. And Uncle Danny would come each Sunday and he'd head right down to the choir room because he was the choir director for Kawaiaha'o Church. So, in many ways, his musical direction informed his leadership because you had to get everybody to harmonize, and that he did.

"So, colleagues, we've lost a dear icon of aloha, but be advised that he sits on your shoulder now: Wherever you go, he'll be with you, so be informed of his aloha when you make your decisions. And, Mr. President, at the proper moment, I would like to request that the Senate adjourn on a rising vote and observe a moment of silence in honor of Uncle Danny, Senator Daniel Kahikina Akaka. Mahalo."
