Thursday, April 12, 2018

The Senate of the Twenty-Ninth Legislature of the State of Hawai'i, Regular Session of 2018, convened at 12:05 p.m. with the Vice President in the Chair.

The Roll was called showing all Senators present with the exception of Senators Harimoto and Kouchi who were excused.

The Vice President announced that she had read and approved the Journal of the Forty-Sixth Day.

At this time, Senator Gabbard introduced Maggie Q, worldfamous actress and longtime animal protection advocate, who was seated in the gallery. Senator Gabbard noted that Maggie Q was born and raised in Hawai'i and attended Mililani Waena Elementary School, Major Sheldon Wheeler Middle School, and Mililani High School. In addition to her many movies and her current lead role in the television series Designated Survivor, Maggie Q co-produced Earthlings, an award-winning documentary about the plight of animals and the environment. Among other animal issues, she hoped that Hawai'i would soon follow the actions of the European Union, India, Switzerland, and many other countries in prohibiting unnecessary research and cosmetics testing on animals. Accompanying her in the gallery were her fiancé, Dylan McDermott; her mother, Katherine Quigley; other family members Nicole Stensgaard, Andrea Quigley, and Kalena Stensgaard; as well as local animal and marine protection advocates Inga Gibson, Stephanie Kendrick, Renee Umberger, and Keith Dane.

It is my belief that the nominee is more than capable of carrying out these responsibilities, having also served as deputy director, and it is his responsibility to represent new opportunities in front of him to continue to apply his skills in service to the people of Hawai'i, and he has been doing this altogether in a herculean way, ever since being appointed.

"Acting Director Wada previously served, as I mentioned, as deputy director to this state department before the retirement of former Director Nishimoto. Prior to his work at DHRD, he served as the personnel regional officer for the windward district of the Department of Education, where I have witnessed his work firsthand. He is also the former managing attorney for the Legal Aid Society of Hawai'i, so his work for the public has been ongoing for many, many years as well. In his personal statement, the nominee explained his vision for the department: It is his goal to enable DHRD to provide quality service with improved efficiencies, customer service, and staff support, building up his team and making sure he serves everyone with service.

"The Committee on Labor also heard testimony from both former and current colleagues of the nominee, all of whom expressed confidence in his ability and knowledge. His over 15 years of legal and human resources experience in both the public and private sectors will serve him well in dealing with the numerous labor protocols overseen by DHRD, a constantly changing landscape. And while there were many testimonies that we received from colleagues, past and present, and from many individuals of the public, I will say that the greatest vote of confidence that we received and the testimony that I had to somewhat force out of the individual came from his father, who usually resides at the Majority staff table but I believe is in the gallery today. I really appreciated, not just the vote of confidence, but it was very touching to hear his words as well.

"Colleagues, as we know, we have often heeded the advice and counsel of Mr. Wada, but it's very clear that the apple has not fallen too far from the tree, so it is with great humility and honor that I humbly ask for your support as we recommend Director Wada to lead the Department of Human Resources Development as he takes them under direction in the right way. Thank you."

Senator Kahele moved that H.B. No. 1585, H.D. 1, S.D. 3, having been read throughout, pass Third Reading, seconded by Senator Dela Cruz.

Senator Ruderman rose to speak in opposition to the measure as follows:

"This bill does exactly one thing for certain: It kills the Thirty Meter Telescope. It's a \$1.4 billion project which will bring more high-paying jobs in the private sector and private sector construction jobs than we've ever seen before in our state. Often, we profess to want high-tech projects to come to Hawai'i, but now we propose to sidestep the legal process to kill a project that has spent 10 years moving forward in good faith. Often, we hear of a chilling effect on future business; this is a deep-freeze, door-slamming-in-the-face, anti-welcome for the next job-creating tech proposal that so many of us say we desire. We're telling the world that, besides the tedious, timeconsuming nature of our due process, we will also pull the rug out from under you at the last minute, regardless of legal rulings. One cannot say they support this bill and are not opposed to TMT. This bill is above all else a death warrant to TMT, unfairly, without public input or due process. The moratorium is intended to punish UH for mismanagement and perhaps right some wrongs. But the only real victim is TMT, a private venture that has done its best to proceed legally, with community support, through our labyrinthine permitting process. The benefits of this project to Hawai'i in quality job creation and educational benefits is unsurpassed.

"The Hawai'i Supreme Court is currently reviewing the appeals regarding the permit process. It's their kuleana to do so. That's due process and the legal way forward. We must not, with one sentence that has never seen public input nor due legislative deliberation, negate the legal process and kill a major project. The label 'gut and replace' rightfully carries negative connotations to our observers - sometimes it's used unfairly; in this case, it's well-deserved. The moratorium part of this bill is a major new proposal with massive consequences which was inserted without due process in violation of Senate rules. So, if we're successful, we're embarking on another long series of appeals and challenges instead of relying on a long-established legal process, which is underway and which this bill sidesteps. If unsuccessful, it undermines public support for fair play and due process, and reinforces the impression that we do whatever we want regardless of laws and rules and due process.

"I am neither blindly pro-TMT nor blindly opposed; I support TMT if its permits are legal and oppose it if not. I believe in the rule of law. But I highly value fair play, the legal process, and, most importantly, the fact that democracy necessarily includes the public. The demo in democracy means 'the people.' Sometimes that's inconvenient and timeconsuming and yet it's the most important aspect of what we do and the thing that legitimizes what we do. Saying one has talked to a lot of people and feels a sense of urgency and has good ideas does not remove the requirement for public input, fair play, and due process. Although we know this bill will likely not survive as is, still I urge my colleagues to not abandon respect for our process by approving a bill which is in violation of the most basic principles of our process. Those who speak of wanting to advance high tech in Hawai'i, who advocate for economic growth so our kids can live here, who want to advance business and educational opportunities in Hawai'i: Your words will ring hollow if you vote for this bill. This bill will kill the biggest high-wage job creator and educational booster our state has ever seen. The Thirty Meter Telescope is the largest private sector proposal we have ever had; this huge, consequential project being unfairly targeted by this bill deserves fair play and due process. Thank you."

Senator Kahele rose to speak in strong support of the measure as follows:

"Senators, colleagues: This is a tough issue, but this legislature, both the House and the Senate and those who came before us, take on tough issues. It is our highest duty to the State of Hawai'i and its people to find solutions to the state's most pressing needs. And just like Kaho'olawe was 40 years ago, Mauna Kea is the Kaho'olawe of this generation. Dr. Martin Luther King once spoke of the fierce urgency of now, and I truly believe, as evidenced by other failed projects in this state, that there is such a thing as being too late. We are at a defining moment in our state's history, and it is time for us, as the leaders of this state, to raise our level of consciousness and understanding that the care and the protection of our 'āina, from the mountain to the sea, is part of our kuleana, our responsibility. The Legislature has now completed 10 public presentations and community listening sessions that have resulted in hundreds of conversations with people all over our islands. And there is one thing that resonates time and time again, and that is we have to do - we must do - a better job of protecting and managing Mauna Kea, and it cannot wait any longer. We need to stop tearing apart the very fabric of our community. We need to hold state agencies entrusted with the care of Hawai'i's most precious natural resources and wonders accountable

"My dad would often say, 'We are all in this together,' and only by working together can we restore balance and peace on Mauna Kea through the aloha that exists in each and every one of us, which makes Hawai'i the special place we all call home. Colleagues, I humbly ask you to support this bill so we can continue this conversation into conference with our partners in the House. Mahalo, Madam President."

Senator Kim rose to speak in opposition to the measure as follows:

"I rise in reluctant opposition to this measure. Madam President, I certainly agree with the remarks made by the senator from Hilo. I believe that we must continue the conversation about Mauna Kea, and there have been many bills this session on that and that conversation. However, at the same time, I think it's very important that we adhere to our rules; and so, based on our Senate Rules, Rule No. 23, Public Hearings on Bills, this bill contains significant and substantial amendments that the public has not been provided an opportunity to submit testimony. And so, to be consistent in my support of transparency in government and following our rules, I must vote in opposition. Mahalo."

Senator Green rose to speak in support of the measure as follows:

"I just would like to say that the irony of this is that some people – and I respect their opinion – may have reservations about passing this bill today, while we still have three weeks left, because of a lack of transparency, but in reality, we often don't get any input from the neighbor islands, and the good chair from Hilo has actually taken this dialogue much further than any other bill that's been debated this session. So, my initial discomfort because of internal rules that we make, in this case, is outweighed by the fact that the senator from Hilo really went the extra mile to get thousands and thousands of pieces of input from people on the Big Island and other islands. So, I know the rules are important – there's no doubt – but he has gotten incredible input, so I'll be supporting him today."

Senator Thielen rose to speak in opposition to the measure as follows:

"I agree with the senator from Hilo that we do need to act, and that's why I will be voting to support House Bill 1985, although with some reservations, because that bill sets forward the dialogue that the good senator from Hilo has been leading around the state about having a new management authority.

"This bill, however, House Bill 1585: It's not a matter of just violating our internal Senate rules; it's a matter of the constitutional requirements that any bill that we pass into law has to have a public hearing and an opportunity for the public to testify. So, the senator from Puna very eloquently raised those basic democratic principles that were violated in this bill, but it's also unnecessary because, if House Bill 1985 is to pass, that would create a new management authority that would be responsible for managing Mauna Kea, and the provisions in this bill requiring the University of Hawai'i to do certain things would be irrelevant because it would be the new authority that would be tasked with passing the administrative rules and making the management decisions that the University of Hawai'i has failed to make over the last 10 years. So, therefore, I oppose this bill and prefer that we move forward with the other that the good senator of Hilo has done so much work on."

H.B. No. 1985, H.D. 1, S.D. 2:

Senator Kahele moved that H.B. No. 1985, H.D. 1, S.D. 2, having been read throughout, pass Third Reading, seconded by Senator Dela Cruz.

Senator Ruderman rose to speak in support of the measure with reservations as follows:

"This bill is also a gut-and-replace bill, which I normally oppose on principle. However, I do support this bill with reservations to allow the discussion to continue because all the concepts in this bill had public hearings and due process at some point along the way, at least in the Senate bills which previously contained these concepts. In that sense, to me, it is not the same as the recent bill, whose major concepts were never vetted in public nor with due legislative process.

"While I have concerns for the process, I commend the senator from Hilo for his herculean effort to address a big issue with fresh new ideas, to craft a consensus, to listen to all concerned and incorporate their concerns. I also commend him for big-picture, outside-the-box thinking, which is so welcome and so needed here. He took the radical, unusual step of talking to and listening to all those concerns and the impacted citizens. I recommend this practice be widely used generally: Go talk to the affected people instead of hiding things from them as long as possible. What a concept! Talk to the people and listen to them.

"So, I do have concerns about the process, but because these concepts had public input and the support of Senate committees, I find it a tolerable use of this procedure and will support further discussions with reservations. Thank you."
