

## FIFTY-SECOND DAY

## Thursday, April 19, 2018

The Senate of the Twenty-Ninth Legislature of the State of Hawai'i, Regular Session of 2018, convened at 11:33 a.m. with the President in the Chair.

The Roll was called showing all Senators present with the exception of Senators English, Harimoto, and Thielen who were excused.

The President announced that he had read and approved the Journal of the Fifty-First Day.

At this time, Senator Baker noted that it was the twenty-third annual Massage Awareness Day, and introduced Carla Villamor of the American Massage Therapy Association.

Senator Ruderman welcomed a group of students from Ke Kula 'O Nāwahīokalani'ōpu'u Iki Lab Public Charter School, a Hawaiian language immersion school in Senate District 2. Senator Ruderman remarked on the warm welcome he had received when visiting the school, and introduced Kumu Pā'ani Kelson, Kauakea Helekahi-Kaiwi, Keawa Wong, Kahaku Tolentino-Perry, Kaleokapu Aipolani, Kū Robinson, 'Aipono Valente, and Lilinoe Ahia.

Senator Inouye recognized members of the Honoka'a High School Jazz Band, noting that the band had visited the State Capitol every April since 1989 to celebrate National Jazz Appreciation Month. The well-traveled band had earned numerous awards, including a 2011 Grammy Signature Schools Award, and had worked with local talents Frank Delima and Melveen Leed, as well as recorded an annual fundraising compilation album for the past 14 years. Senator Inouye then introduced chaperones Sue Dela Cruz, Wendy Kapu, Rose Domingo, Raina Dale, Stacey Aguilar, Dan Hooley, Doug Connors, Terri Pedro, Kelby Pedro, and Ashlynn Pedro, as well as the student members of the band and band director Gary Washburn.

The Chair extended an additional welcome to the band, and noted that his mother was a proud Honoka'a High School alumna.
